

TDG Group Modern Slavery Statement

Introduction

This Modern Slavery Statement (Statement) has been prepared according to the Modern Slavery Act 2018 (Cth) (the Act) and approved by the board of TDG Environmental as the principal governing body of the Total Drain Group of Companies (TDG). This Statement sets out the actions taken by the TDG and its related entities to address modern slavery (trafficking in persons; slavery, servitude; forced marriage; forced labour; debt bondage; the worst forms of child labour; and deceptive recruiting for labour or services) risks and ensure responsible and transparent practices within its business and supply chains.

Structure, Operations and Supply Chain

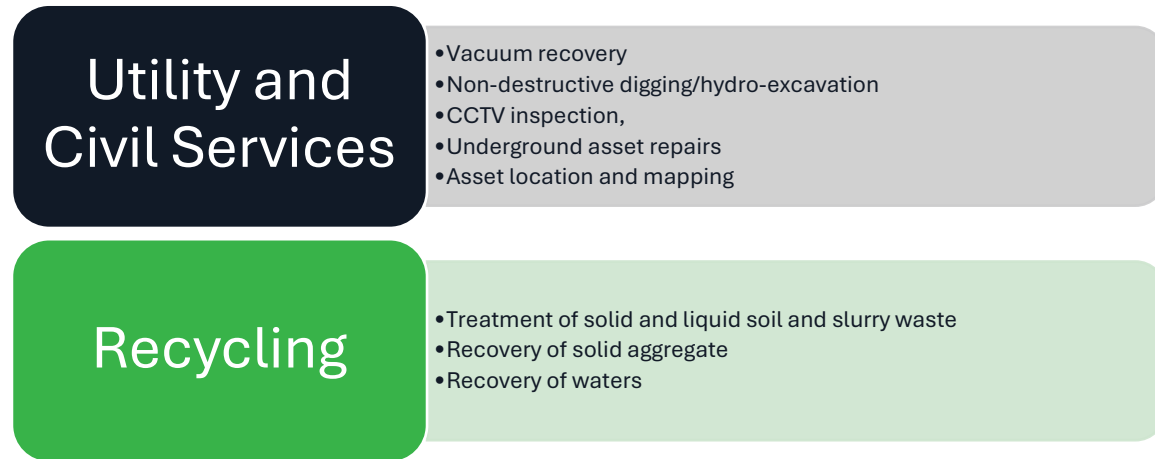
Structure

TDG is structured with the following core operating entities:

- TDG Environmental Pty Ltd is the primary services delivery business operating in Australia and New Zealand, primarily with TDG-owned assets and employees providing utility and civil services generally, specifically including vacuum recovery, non-destructive digging/hydro-excavation, CCTV inspection, underground asset repairs, asset location and mapping, plus ancillary services.
- Mainstream Recycling Pty Ltd operates licensed waste recycling facilities treating solid and liquid soil and slurry waste.

Operations

TDG operate within Australia and New Zealand, providing the following range of services:



Supply Chain

The TDG supply chain is primarily encompassed onshore in Australia and New Zealand, with limited use of offshore procurement. It engages with approximately 957 suppliers, with 98% of the supply chain being low-risk providers of services and products based in Australia and New Zealand.

Legend:

- **Direct** supply chain partners with whom the TDG Group directly engage and interacts on a business-to-business basis.
- **Secondary** supply chain partners, whom our direct partners engage, are estimated to represent.
- **Low-Risk Exposed** products, services, locations and entities with no or low potential for modern slavery. Primarily domestic providers of goods and services
- **Risk Exposed Services** with higher-than-normal potential for risk, ie cleaning, hospitality, agriculture. (Potentially includes Cleaning, Contractors & Temps, Computer Software Maintenance, Software Licenses, Software Development).
- **Risk Exposed Products** with higher-than-normal potential for risk, ie rubber products, bricks and construction materials, minerals, cocoa and tea, textiles production and some types of manufacturing. (Potentially includes Safety Equipment & Uniforms, Consumables, Computer Hardware Maintenance, Computer Peripherals, Office Supplies & Consumables)
- **Risk Exposed Locations** countries have a higher than normal potential for risk, including: North Korea, Eritrea, Mauritania, Saudi Arabia, Turkey, Tajikistan, the United Arab Emirates, Russia, Afghanistan and Kuwait. This may include exposure of vulnerable minorities, ie Uyghurs, etc
- **Risk Exposed Entities:** Entities with known or suspected modern slavery, if identified.

Modern Slavery Risks

Given the current nature and scope of operations, the risk that they are causing, contributing to, or directly linked to modern slavery practices is low, and the controls in place are effective in maintaining an acceptable level of risk. The exposure to high risk sectors is immaterial given the nature and scope of procurement within Australia and New Zealand.

Assessing the potential risk of modern slavery in supply chains, including geographic risks, products and services sourced, operating sectors, and the supply chain model involved, necessary actions have been taken to address areas of vulnerability.

Anti-Slavery Actions, Practices and Due Diligence

Recognising the level of risk within our supply chain, the following actions have been taken to ensure effective prevention of slavery and effective due diligence:

- **Policy and Process** – TDG Group has defined internal control systems through our policies and processes. Specifically, we will not engage or transact with suppliers in the very high-risk categories.
- **Training and Awareness** – Persons with procurement responsibilities in High or Very High procurement categories have completed Modern Slavery Awareness and Procurement training. Persons with general procurement responsibilities in the Low-to-Medium range have been educated about Modern Slavery through the Anti-Slavery policy.
- **Procurement Control** – All High-Risk categories are centrally controlled and restricted to procurement by designated persons who have completed the required training. Risk assessments and due diligence are conducted throughout all high-risk procurements.
- **Recruitment/Employer Control** – All employment practices and labour hire practices are conducted in accordance with Australian and New Zealand employment law and relevant Labour Hire practices as guided by our Human Resources policies.
- **Contractors & Direct Suppliers** – All preferred suppliers and subcontractors are required to commit to Modern Slavery compliance in accordance with the Act.
- **Secondary Suppliers** – Preferred suppliers are required to commit to Modern Slavery due diligence in their management and control of Secondary Suppliers.
- **Whistleblower Reporting** – Any activity causing, contributing to, or directly linked to modern slavery practices may be reported via the Whistleblower reporting procedure in accordance with the Whistleblower policy:

- **Remediation** – In the event that an incident of modern slavery is demonstrated or suspected, then TDG will take immediate action to prevent further harm, to report and cooperate with authorities and to take all reasonable action to rectify any impact to those immediately impacted.

This statement was prepared under the leadership of TDG management following direct consultation with:

- Engagement with employees and staff of operating entities
- Direct engagement and due diligence with principal suppliers

Effectiveness of Controls and Actions

TDG Group maintains an ongoing assessment of our Modern Slavery controls, informed by reported issues/concerns, benchmarking and auditing reviews with our customers, consultation and engagement with our suppliers.

The controls have thus far remained effective, sustaining our appetite for an overall low risk of modern slavery within our activities and supply chain.

No incidents or suspicions of modern slavery concerns have been reported since the last statement. Any reports are investigated and reported in accordance with the Incident and Issue Resolution Procedure.

Principal Governing Body Approval

The Board has consulted with our owners and top management of the organisation to ensure that all parties are informed, committed and engaged to ensuring an effective framework of anti-slavery controls.

This modern slavery statement was approved by the principal governing body of Total Drain Group Pty Ltd as defined by the Modern Slavery Act 2018 (Cth) ("the Act") on (date).
