This Modern Slavery Statement is provided under Sections 5(d) and 6 of the **Modern Slavery Act** (2018) Australia for the period from 1 July 2020 to 30 June 2021 for **Nolan School of Procurement** ABN 20 908 686 616.

### Our Business

We are a Queensland, Australia-based global online Procurement education provider, delivering unique Procurement-related skills training to organisations and individuals in 11 countries in Australasia, Africa, and the Middle East.

### Our Core Values

Our School has three Core Values:

1. **We transform people into Procurement Specialists through effective training.**

We have a particular focus on developing countries that have a deficit of capable skilled Procurement staff in both government and the private sector. Our training is designed to give our Students proficiency in both strategic and tactical capability. Creating Procurement job-readiness serves multiple purposes with direct Social Procurement benefits:

- Graduating capable Procurement officers to manage Government Procurement and Tender processes with confidence and probity;
- Mitigating organisational corruption through education surrounding proper separation of duties, fairness in Tender evaluation and transparent reporting;

- Our School is annually independently audited for data security and compliance with Australian Federal and Queensland State Procurement policies.

## 3. Our teaching promotes Social Justice to make the World fairer.

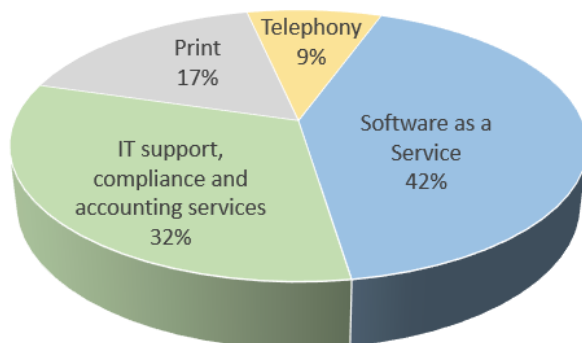

- Payment Gateways through PayPal and Western Union in US.
- Printing services through an SME in Melbourne, Australia.
- Platform as a Service from Wix.com in Tel Aviv, Israel.
