

Modern Slavery Act 2018 (Commonwealth of Australia)

This statement covers the financial year ending 31 December 2024.

This statement is made by Trend Micro Australia Pty Ltd (ABN 70 077 055 817) pursuant to the Modern Slavery Act.

We do not own or control any other entities.

Modern slavery is a violation of fundamental human rights and involves the serious exploitation of a person under the duress of slavery, servitude, human trafficking, forced labour, debt bondage and the worst forms of child labour. Trend Micro has a zero-tolerance approach to any form of modern slavery.

Structure

Trend Micro Australia is a subsidiary in a group of companies and does not control other entities. The ultimate parent of Trend Micro Australia is a listed Japanese corporation, Trend Micro Incorporated, a global leader in cybersecurity solutions. The global group of Trend Micro has over 7000 employees in 65 countries utilising the world's most advanced global threat research and intelligence.

Operations

Trend Micro Australia supplies cybersecurity products and services for hybrid cloud, endpoint and network security solutions and automated solutions for secure data sharing. Find out more at: www.trendmicro.com.au.

We primarily supply software and software related services to our customers. The software is developed by the global group of Trend Micro with contributions from the personnel of Trend Micro Australia.

Supply chains

Trend Micro Australia collaborates with channel partners to fulfil product and service distribution and delivery. We rely on multiple third party suppliers and outsourcing arrangements for the supply of goods and services.

We are committed to acting ethically and with integrity and transparency in all business dealings and to putting effective systems and controls in place to safeguard against any form of modern slavery taking place within the business or our supply chain.



We expect the same high standards from all of our contractors, suppliers and other business partners.

As part of our supplier selection and on-boarding procedure we undertake appropriate due diligence with the intention of establishing relationships of trust and integrity with our suppliers. We enter into binding contracts in order to provide enforceable commitments to be made by the suppliers involved.

As part of our contracting processes, we include specific prohibitions against modern slavery and we expect that our suppliers will hold their own suppliers to the same high standards.

Trend Micro Australia is routinely requested to confirm in tenders and binding contracts that it also complies with modern slavery obligations and that it will continue to do so.

Risk assessment

We undertook risk assessments of modern slavery risks in our operations and supply chains over the reporting period to consider if we are directly or indirectly linked to modern slavery practices.

We use a number of factors to assess the potential risk of modern slavery in our supply chains, including geographic risks from where we source materials, the products and services that we source, the sectors that we operate in and the supply chain model involved.

Due to the nature of its business, Trend Micro believes that it is at a low risk of modern slavery in its business and supply chains.

During our reporting period we have reviewed supplier engagement processes and principles. We are maintaining and expanding a process of requiring key suppliers to acknowledge compliance with the Modern Slavery Act and to support Trend Micro's compliance initiatives.

Trend Micro Australia is not aware of any conduct in its supply chains that would permit modern slavery. The full extent of slavery risks that exist in all supply chains and in all the supply chains of our suppliers is being investigated and will continue to be investigated over time.

Policies

During our reporting period we have examined and where necessary revised and updated our internal policies.



On 27 March 2025, Trend Micro Incorporated approved a global modern slavery statement titled *Trend Micro Global Human Trafficking & Modern Slavery Statement 1 April 2025* and located at https://www.trendmicro.com/en_au/about/legal.html.

This global statement followed a due diligence review of the operations and supply chains of Trend Micro Incorporated and its related bodies corporate to ensure compliance with regulatory obligations worldwide including under the Modern Slavery Act 2018 (Cth) and the UK Modern Slavery Act 2015. This review was undertaken during 2024.

Trend Micro Australia promotes open communication by its team members and has established a written procedure to encourage team members to come forward with any concerns about the operations of Trend Micro including conduct or events concerning modern slavery. These procedures are set out in the Trend Micro Australia Whistleblower Policy and enhanced by a Whistleblowing Report Procedure that applies to Trend Micro personnel internationally.

Trend Micro Australia is subject to a Code of Conduct that applies to Trend Micro personnel internationally. This Code of Conduct specifically names Modern Slavery as a crime and a violation of fundamental human rights. All employees of Trend Micro Australia must review and sign the Code when starting their employment.

We meticulously comply with all Australian laws including those relating to employment and the engagement of third party contractors. We have adopted several polices to meet these compliance obligations.

The Board of Trend Micro Australia and senior management are aware of the Modern Slavery obligations.

We routinely respond to requests and questionnaires from customers concerning modern slavery practices. These requests and questionnaires require an internal examination of the risks of such practices and thereby focus our attention and resources on compliance with the requirements of the Modern Slavery Act.

Next steps

We will continually assess the effectiveness of our actions in identifying and managing modern slavery risks by monitoring our actions and outcomes, partnering with suppliers and other external partners, and undertaking regular internal governance and external assurance processes. Based on the results of these processes we will adapt and strengthen our actions to continually improve our response to modern slavery.

We will maintain a zero-tolerance policy towards slavery.
