## 1. Background

---

This Modern Slavery Statement (**Statement**) is made pursuant to the *Modern Slavery Act 2018* (Cth) (**Act**). It sets out the actions taken by InComm Australia & New Zealand Pty Ltd (ACN 125 567 357), ("**InComm ANZ**", "**us**", "**we**" or "**our**"), to assess and address modern slavery risks in our operations and supply chain during our financial year ending 28 February 2026. InComm ANZ is a reporting entity for the purposes of the Act.

InComm ANZ is committed to conducting business in a responsible and ethical manner. As part of this commitment, we place importance on implementing practices to mitigate modern slavery risk in our operations and supply chain. We aim to partner with organisations who align with our ethical values and demonstrate the same commitment, many of which we have had successful long-standing relationships with.

## 2. InComm ANZ's structure, operations and supply chains

---

### 2.1 Structure and corporate details

InComm ANZ is a privately-owned payments technology company, incorporated in Victoria in 2007. InComm ANZ is a wholly owned subsidiary of HI Technology Corp (**HTC**), a global business with its principal place of business located in Atlanta, USA.

InComm ANZ owns and/or controls the following entities (**Subsidiaries**):

- (a) InComm TCN Holdings Pty Ltd (ACN 662 754 878);
- (b) TCN Group Pty Limited (ACN 626 501 568);
- (c) The Hotel Card Pty Ltd (ACN 626 509 171);
- (d) The Movie Card Pty Limited (ACN 621 449 769);
- (e) TCN Group Pty Ltd Company Number 8398361 (a New Zealand company); and
- (f) TCN Group Limited (09807035 ENG & Wales).

For the purposes of this statement, references to "the InComm ANZ Group" are references to InComm ANZ and each of the Subsidiaries listed above.

InComm ANZ Group currently has 60 employees and one office.

### 2.2 Operations

InComm ANZ is a large-scale provider of gift card and related payment solutions to retail, grocery, sports, entertainment and hospitality sectors. Our extensive portfolio of offerings has been established through the development of strong corporate partnerships to connect consumers around Australia to the products and services they want and need. We are proud to offer comprehensive services to retailers and corporate partners such as the supply, distribution, fulfillment and marketing of physical and digital gift card products. At InComm ANZ, we are passionate about helping Australians to gift better and in new and exciting ways every day. Our team is dedicated to creating

innovative solutions that inspire gifting and make the experience more personal for both the giver and the recipient.

We operate out of one office located at 250-254 Swan Street, Richmond, Victoria 3121. This is a corporate office out of which our business and financial operations are managed.

### **2.3 Supply chain**

Our supply chain supports us through the provision of goods and services (including materials for our gift cards and third-party gift cards, printing services, manufacturing of gift cards and packaging solutions) and end-to-end payment processing services.

The vast majority of our suppliers are located in Australia and the United States of America.

We procure card printing / packaging services from organisations in Australia, the United Kingdom and the United States of America. We also procure minimal card printing / packaging services from entities located in China. Our marketing and design partners are mostly located in Australia and the United States of America with one partner in Canada. Issuing and processing services including e-commerce partners (including payment processing) are located in Australia and Singapore. We have IT support partners in Australia, the United States of America and Israel, and an accounting support partner in Malaysia. Cleaning services are supplied by an Australian company, and our call centres are located in Australia, the Philippines, and USA. We also procure office equipment, IT equipment and other office supplies for our business, on an as needs basis.

Given the nature of our business, we have a fairly small supply chain with supply partners we have built a strong relationship with over a number of years.

## **3. Risk profile**

---

InComm ANZ makes a conscious effort to procure goods and services from local organisations, where possible. In these instances, InComm ANZ has assessed the risk of modern slavery as low.

Where this is not feasible, InComm ANZ seeks to obtain those goods or services from overseas. The vast majority of overseas suppliers engaged by InComm ANZ are suppliers that are already engaged enterprise-wide by our group through HTC subsidiary operations and with whom the InComm ANZ Group has had longstanding relationships. This provides us with greater oversight over the operations and supply chain of our supply partners who operate overseas and comfort that they operate ethically.

InComm ANZ has identified the following overseas suppliers as having a higher level of vulnerability based on the Global Slavery Index:

- Where InComm ANZ engages suppliers from a jurisdiction with a higher level of vulnerability, we seek to undertake additional due diligence on those suppliers.
- Other than the suppliers referred to above, InComm ANZ has identified that the majority of our goods are acquired from countries considered to have a lower level of vulnerability. We have used the Global Slavery Index to classify them below:

The goods and services that we procure from these countries are also deemed to be lower risk. They include design and marketing services, card printing services, merchandising services, IT support, e-commerce and payment processing.

## 4. Actions taken by InComm ANZ to assess and address these risks

### 4.1 Assessing risks

InComm ANZ continues to adopt processes and procedures to assess the risk of modern slavery including through a comprehensive process of risk mapping its operations and

supply chain regularly. We consider the risk of modern slavery when making operational decisions and during the process of onboarding of new suppliers.

#### **4.2 Addressing risks**

InComm ANZ takes modern slavery risks seriously. InComm ANZ created and dispersed an internal Modern Slavery Policy, which advanced our global commitment to eradicate modern slavery risks within our supply chain.

Our Modern Slavery Policy ensures all employees, contractors, subcontractors and consultants working for InComm ANZ demonstrate a commitment to mitigating and responding to modern slavery risk. Our policy contains details of how we investigate and manage any complaints and provides our personnel with an anonymous mechanism through which to raise concerns. Our personnel are made aware of the Modern Slavery Policy and understand that they can safely and confidentially flag any perceived or actual modern slavery risks as they may arise within the InComm ANZ Group.

Importantly, InComm ANZ also maintains a continuous focus on training and collaboration to improve on the knowledge and awareness amongst our personnel. All InComm ANZ personnel undergo annual compliance and security training, which includes training on modern slavery, human trafficking and forms of forced labour to raise awareness and mitigate risk.

We continue the process of incorporating language into our supply and distribution contracts to reflect our expectations of the supplier in respect of human rights and ethical procurement, and requiring suppliers to complete a 'supplier questionnaire' to enhance our due diligence process when we onboard suppliers as well as existing suppliers.

#### **4.3 Remediation process**

As outlined above, InComm ANZ has a confidential whistleblowing process that directors, officers, employees, contractors and subcontractors are encouraged to use to report any policy violations including modern slavery incidents or risks. If InComm ANZ or any member of the InComm ANZ Group becomes aware of a modern slavery risk in its operations or supply chain, all relevant steps are taken to adequately address this risk.

These actions will vary dependent on the type of risk, and may include investigating the alleged modern slavery conduct or risk, informing or educating the supplier, requiring the supplier to undertake remedial action, or terminating the supplier relationship.

### **5. How InComm ANZ assesses the effectiveness of our actions**

---

InComm ANZ is determined to improve its response to modern slavery and wishes to identify, in a meaningful and quantifiable way, whether the actions it is taking have been effective.

We monitor the effectiveness of the established processes to inform, and if necessary, alter the direction of, our next steps in the pursuit of eradicating the modern slavery risks in our operations and supply chain.

InComm ANZ has internal processes in place to assess and report on the occurrence of any complaints or incidents should they arise under our Modern Slavery Policy.

We also keep records of personnel attendance at all relevant training sessions which provides us with oversight of the proportion of staff that have been and are continually updated to understand and identify modern slavery risks.

Based on the results of these processes we will adapt and strengthen our actions to continually improve our response to modern slavery. We recognise that our practice in this space is ongoing and evolving and we are committed to continually build on our practices to enhance our understanding of the effectiveness of actions taken by our organisation.

## **6. Consultation**

---

This statement was developed with the input of the directors and key employees of InComm ANZ.
