


Purpose

This Modern Slavery Statement is made by Sekuro Limited (Sekuro) (ABN 14 648 798 618) for 01 January 2024 to 31 December 2024 in compliance with the *Modern Slavery Act 2018* (Cth) (the Act). This statement covers all Sekuro subsidiaries, namely:

- Sekuro Operations Pty Ltd
- CXO Security Pty Ltd
- Naviro Holdings Pty Ltd
- Naviro Pty Ltd
- Naviro Payroll Pty Ltd
- Sekuro Ltd (UK)
- Privasec Pty Ltd
- Solista Pty Ltd, and
- Solista (Victoria) Pty Ltd.

Sekuro is the main company which deals with suppliers and distributors across the group. As none of the other companies listed is a reporting entity under the Act, this is not a joint statement.



The purpose of this statement is to:

- Provide an overview of how Sekuro prevents, detects, and responds with mitigating controls to the risk of modern slavery occurring within Sekuro, its supply chain, or in any other business relationships.
- Demonstrate Sekuro's commitment to ensuring that modern slavery does not occur within our own business and supply chains.
- Ensure compliance with the Act (as may be amended from time to time).

Statement

Sekuro has a zero-tolerance approach to modern slavery.

Sekuro is committed to acting ethically and with integrity in all its business dealings and relationships, implementing and enforcing effective systems and controls to ensure modern slavery is not taking place anywhere in its own business operations or supply chains.

Sekuro is also committed to ensuring there is transparency in its approach to tackling modern slavery throughout its business and supply chains, consistent with the Sekuro's disclosure obligations under the Act.

The prevention, detection and reporting of modern slavery in any part of Sekuro's business and supply chains is the responsibility of all those working for it or under its control.

Employees, including contractors, are encouraged to raise concerns with their manager or Sekuro's Senior Leadership Team (SLT) about any likely modern slavery breaches in any parts of Sekuro's supply chains or business, at the earliest possible stage.

Sekuro expects the same high standards from all its contractors, suppliers, and other business partners. Sekuro's contracting processes include specific prohibitions against the use of forced, compulsory or trafficked labour, or anyone held in slavery or servitude, whether adults or children, and expects suppliers to hold their own suppliers to the same high standards.

This statement is an integral part of our approach to addressing modern slavery.




Operations and Supply Chain

The majority of Sekuro's suppliers are large multinational Software-as-a-Service (SaaS) providers, such as Microsoft and Atlassian. Each is subject to extensive due diligence processes to ensure compliance with appropriate regulatory guidelines, including, where appropriate, anti-slavery legislation. The non-SaaS suppliers of Sekuro are almost all based in Australia or Singapore.

All suppliers are reviewed directly through Sekuro's Third Party Management Policy.

Consultation Process

Sekuro's entities operate under the same management, governance, risk, and corporate functions as Sekuro. During the reporting period this statement covers, we actively engaged and consulted with all entities wholly owned by Sekuro (outlined on page 1). The consultation process to complete this statement involved key stakeholders from across Sekuro, including the SLT, the Board (in particular its Audit and Risk Committee (ARC)), and relevant staff involved in managing Sekuro's supply chain.



Identification of Risks of Modern Slavery

Sekuro is required to identify risks to modern slavery in its operations and/or supply chain. Modern slavery is a crime and violation of human rights that is defined under the Act as including eight types of serious exploitation:

- Trafficking in persons
- Slavery
- Servitude
- Forced marriage
- Forced labour
- Debt bondage
- Deceptive recruiting for labour or services, and
- The worst forms of child labour, which means situations where children are subjected to slavery or similar practices or engaged in hazardous work.

Sekuro takes due care and diligence in conducting high-level risk assessments of our internal systems and suppliers through our Third Party Management Policy and tracking any risks through our Risk Management Framework and associated procedures.

Operations

Sekuro has identified minimal risks concerning modern slavery in our workforce. Sekuro primarily provide services in countries with highly regulated employment law environments which protect employees, and we provide additional checks through our Third Party Management Policy and Code of Conduct Policy. Sekuro's Code of Conduct Policy details processes and communication pathways for employees to disclose misconduct.

Additionally, Sekuro's employee workforce is subject to the requirements of relevant local labour laws, including the:

- Fair Work Act 2009 (Australia)
- Modern Slavery Act 2018 (Australia)
- Employment Rights Act 1996 (UK)
- Modern Slavery Act 2015 (UK)
- Employment Act 1968 (Singapore)
- Prevention of Human Trafficking Act 2014 (Singapore)
- Employment Act 1955 (Malaysia)
- Anti-Trafficking in Persons and Anti-Smuggling of Migrants Act 2007 (Malaysia)
- Labor Code of the Philippines [Presidential Decree No. 442, May 01, 1974] (Philippines), and



Republic Act No. 10364 [Expanded Anti-Trafficking in Persons Act, February 06, 2013] (Philippines).

Supply chain

As noted above, the majority of Sekuro's suppliers are large multinational Software-as-a-Service (SaaS) providers, such as Microsoft and Atlassian. Many suppliers that work with Sekuro are based in Australia or Singapore. These suppliers with data centres and headquarters in Australia or Singapore have a low exposure to modern slavery-related risks as they are required to comply with this Act and operating in a highly skilled sector. Although we operate in an industry that is generally considered a low risk for modern slavery, we are aware we can be indirectly exposed to modern slavery risks through our supply chains. A risk assessment is conducted and reviewed for every supplier to ensure modern slavery is considered in accordance with our Third Party Management Policy.

Risk assessments of our supply chain have showed that, to enable the delivery of our services, our risks relating to modern slavery can be grouped at a high level into the following categories:

- Technology and hardware
- Premises and facilities
- Professional services
- ▼ Staff costs, including staff merchandise and apparel
- Travel and related expenses (limited in line with our carbon emissions targets), and
- Hospitality and entertainment.

Area		Exposure to Modern Slavery Risk
((w))	Technology and Hardware	Globally, the electronics sector is one with many potential supply chain risks. We source from suppliers with a global reputation as well as distributors with Australian headquarters that have developed procedures to lower risks relating to modern slavery in their supply chains.
		We are reassured by these suppliers' abilities to detect and manage risks related to modern slavery as a result of our regular examination of them.
	Apparel and Merchandise	We purchase staff clothing and merchandise through established regional suppliers and distributors.
0		While the textiles sector is generally acknowledged as having elevated modern slavery risks in global supply chains, we continue to communicate with our distributors and suppliers to ensure that our suppliers have ethical production practices in place and consider their impact on the environment.
	Professional Services	Most of our professional services are obtained from companies in Australia or Singapore. This can be considered a low-risk sector with a minimal amount of risk associated with modern slavery. Despite this, we still



review and consider our exposure to risk in this area and minimise it accordingly. **Premises and Facilities** Cleaning services are acknowledged as high-risk services. We make use of the building management's cleaning services at each of our office locations. **Travel** Travel occurs domestically and abroad, primarily in Australia, Southeast Asia, the United Kingdom, and the Unites States of America. Travel is limited due to the increased use of hybrid work arrangements. **Hospitality and** We work alongside entertainment and catering services for **Entertainment** staff and customer facing events. We believe there is a low risk of modern slavery occurring in this sector, although we communicate with the providers of these services and review their practices to determine if any risk should be addressed.



Actions to Address Modern Slavery Risks

Governance controls and training

Sekuro has developed internal governance controls for engaging with suppliers (and in particular high risk sector suppliers).

Sekuro:

- Publishes a Modern Slavery Policy.
- Reviews our Third Party Management Policy and procedures to ensure inclusion of modern slavery clauses.
- Updates our standard procurement agreements to include contractual obligations to address modern slavery compliance so that all new suppliers commit to adherence to the new modern slavery requirements.
- Updates our tender documents to include modern slavery-related questions to ensure we identify modern slavery risks early with new suppliers during the procurement process.
- Continues to improve our engagement with our suppliers to ensure we have a clear understanding of their businesses and modern slavery risks.
- Continues to refine our internal online training programs and ensure staff undertake annual mandatory refresher training to all employees (this program covers a broad range of governance, risk and training subjects).
- Actively monitors its internal compliance with applicable laws and workplace awards and standards.
- Revises aspects of our Work, Health and Safety-related (WHS) policies and procedures, and continues to improve these to maintain employee safety.



Policies

In addition to our Modern Slavery Policy, Sekuro has multiple policies in place through which it both assesses and seeks to prevent modern slavery practices within its own operations and the operations of its suppliers. These processes include (but are not limited to) the policies referenced below.

Acceptable Use Policy

Through these policies we commit to ensuring the health, safety and wellbeing of our employees and remain compliant with Australian workplace and safety laws. Sekuro's offshore operations also adhere to the relevant legal, customs and regulatory obligations. These policies include requirements seeking to ensure our workplace is free of any type of discrimination, intimidation, harassment or bullying; not use child labour or forced labour; provide and promote a safe work environment; and treat everyone fairly.

Code of Conduct Policy

Sekuro's Code of Conduct Policy details processes and communication pathways for employees to disclose misconduct, including any conduct related to modern slavery.

One of Sekuro's key values is that we would rather act in a way that maintains our ethical standards than make a quick profit. Senior management encourages all new employees to support these values and report any instances in which people affiliated with Sekuro may not be following this standard.

Third Party Management Policy

Suppliers are assessed under this policy initially before being contracted with, and again on an annual basis if they are deemed high risk or critical for their suitability as partners from Sekuro's perspective. This policy includes a requirement to check whether our suppliers are complying with relevant anti-slavery legislation.

Supplier Assessments and Contractual Reviews

Sekuro has continuously improved their supplier assessments to reduce risks, including risks relating to information security and modern slavery. Sekuro has recently updated our supplier onboarding process to incorporate further detailed questions concerning privacy, information security, WHS, environmental security, and modern slavery policies. Once a new or ongoing supplier has identified a risk that relates to the aforementioned criteria, Sekuro is committed to remediating these risks. This process aligns with Sekuro's ISO 9001, 14001, 27001 and 45001 certifications.

Recognising that the biggest risk of modern slavery originates from our supply chains, Sekuro's initiative aims to implement specific modern slavery clauses in supplier contracts when achievable, recognising that many of our largest suppliers by expenditure are global providers.
