These policies provide guidance to employees and suppliers on expected standards of conduct, ethical behaviour, and reporting mechanisms.

## 6. Risk Management and Training

We acknowledge that risks may arise within extended global supply chains. To address these risks, IMG is progressively:

- Reviewing supplier arrangements to identify and assess potential risks.
- Educating staff involved in procurement and supplier management on modern slavery awareness and due diligence.
- Strengthening reporting mechanisms to allow concerns to be raised confidentially and investigated independently.

IMG is committed to continuous improvement and will:

Monitor the effectiveness of our practices.



- Update our procedures in line with industry standards and legislative requirements.
- Report transparently on progress in future statements.
