## ETHICAL - SUSTAINABLE - TRACEABLE

The ethical focus of UWC's producers ranges throughout all aspects of animal husbandry and responsible on farm management practices. UWC prides themselves in meeting the challenge of supplying non-mulesed wool to clients where their clients require this added component. In these cases, UWC provides fully traceable documentation.**



## AUSTRALIAN TRUSTED TRADER

After many years and months of refining UWC's operations in all respects, UWC is an approved member of the Australian Government, Australian Trusted Trader program (ATT). This is a very rare privilege for an Australian Wool Exporter.

ATT recognises UWC as a top-tier exporter with transparent and completely reliable systems relating to all aspects of UWC's operation from procurement through to shipment, documentation and customs clearance.

ATT has Mutual Recognition Arrangements (MRA) with several countries including China and therefore offers benefits to UWC's customers when clearing goods into China. MRA recognise ATT within participating countries. These arrangements give UWC's goods priority treatment at the borders of partner countries. This enables faster processing, which means greater predictability, certainty, and distribution speed.





## RISK AND RESPONSIBILITIES

UWC is committed to assessing and addressing the risk of modern slavery and human rights within its organisation and throughout the extended supply chain in accordance with UWC's business values of shareholders, the law and community expectations and regulations for business and human rights.

It is the responsibility of the Directors of UWC to ensure that all business conducted complies with the legal and ethical obligations to eliminating ill practices toward Modern Slavery.

## REMEDIATION

If an event occurs at which a case constitutes modern slavery within the supply chain, at which UWC has business workings, UWC will immediately cease those workings or dealings with that entity. This reflects UWC's zero tolerance among shareholders and employees within UWC towards ill practice relating to modern slavery.

As a registered and certified global Trusted Trader, due-diligent measures are of the highest importance among UWC's supply partners and strategic brand partners. This is to identify any high-risk areas and to ensure they are not entering into any contractual agreements with organisations where modern slavery practices may be taking place, or with individuals who condone those practices.



## ACTION

UWC is committed to the continual evaluation of the supply chain to ensure the highest ethical and legal standards are adhered to. Listed but not limited to below;

- o Fair treatment and respecting the rights of UWC employees
- o Legislative working hours to be maintained
- o No forced labour
- o No child labour
- o Providing and promoting a comfortable, safe and compliant workplace eliminating discrimination and harassment
- o Respecting the rights of individual cultures by adopting the United Nations Universal Declaration for Human Rights
- o Raising awareness of the forms of Modern Slavery among UWC employees in line with the *'Modern Slavery Act 2018 {Cth}'*.
- o Continually review, evolve and maintain UWC's due diligence to assist and identify any potential risk associated with any forms of modern Slavery.

As a company, UWC conducts business ethically and with integrity both in Australia and overseas through UWC's relevant customers, brand partners and those agents representing UWC for the best interest of animal welfare and humanity.
