

Clover does not knowingly engage suppliers that are involved in modern slavery or human trafficking. Clover Pipelines does not procure products from underdeveloped countries where this may occur.

Agreements are entered into where standard terms and conditions and other requirements such as meeting local and international legalisation and standards are agreed to prior to entering into an agreement.

Assessing and actioning the Risk of Modern Slavery

To address and mitigate potential risk of modern slavery, Clover Pipelines has implanted management systems and procedures to prevent exploitation of human rights in our operations and our supply chain.

With regards to our key suppliers, agreements will be developed and agreed including requirements to meet various international and local standards and applicable local and international laws including modern slavery.

All suppliers are required to complete Corporate Social Responsibility covering the following including Modern Slavery, Human Rights and Labour Conditions. Any breaches of Modern Slavery laws identified through audits or completion of Modern Slavery questionnaire by our suppliers will result in Clover immediately stopping purchasing from them until they can demonstrate that they addressed the issue (s) and are complying with the law.

Our key suppliers are identified, reviewed and approved annually in line with our ISO 9001:2015 certification.

Clover Pipelines provides training for all management, staff and contractors in relevant policies and procedures to give a better understanding of the risks to the business, including Modern Slavery. All suppliers are required annually to complete a Modern Slavery Questionnaire to identify any potential risks in their business which may require addressing. If required, Clover will monitor any actions until satisfactory correction has been implemented and meets Modern Slavery Laws.

Clover Pipelines also maintains and implements various Policies into its operations as follows. All suppliers, management, staff and contractors must comply with these policies.

- Health Safety Quality and Environments;
- Code of Conduct;
- EEO;
- Ethical and Sustainable Procurement;
- Diversity and Inclusion.



Supplier Evaluation

Clover Pipelines is committed to continuously strengthening its procedures and processes to all aspects of the business operations including to combat modern slavery practices and protecting human rights.

Risk Assessments of our supply chain have been completed to identify at risk suppliers and controls implemented to ensure any ongoing risks are mitigated.

Supplier Network

Clover Pipelines sources product globally and all suppliers are required to complete Modern Slavery Questionnaire as identified risk must be addressed.

Risk Management Process

Risk Management is defined as the identification, assessment and prioritisation of risk followed by the coordination of resources to minimise, monitor and control the probability and/or impact to the business. Clover Pipelines SSP-04 Management of Risk and Hazards will include assessment of risk to business using the Risk Rating Matrix below.

The risk will be assessed before and after controls are implemented. Clover Pipelines aim is to have identified risk rating of moderate or lower after control measures have been implemented.



Assessing the effectiveness of the Risk of Modern Slavery

Clover Pipelines is committed to continuously strengthening its procedures and processes to all aspects of its business operations including to combat modern slavery practices and protecting human rights.


Various audits of the business operations are conducted each year to ensure compliance not only to relevant International, Australian Standards but also to local and international legalisation applicable. It includes Health & Safety, Quality and workplace conditions. Any gaps or areas of concern are recorded, and corrective action is implemented to rectify the issue.

The findings of these audits are reviewed in annual management review meeting together with the actions taken to rectify them. All policies are reviewed in this meeting to ensure they are current and updated where required.

With multiple distribution centers and locations across Australia states all supported by a sophisticated logistics operation, we cover all corners of the country and into the APAC region. From large shipments of entire pipeline packages to small but critical replacement parts, to our clients we are more than just suppliers, we are trusted project partners with shared deadlines and common goals.

Consultation Process

Clover Pipelines consults with employees, contractors and suppliers to identify and address risk of modern slavery. Within the business, various levels of the staff and management are involved in the process cumulating in Senior Management Review Meeting. Clover Pipelines is committed to meeting its legal obligations both locally and internationally and continually improve its processes and compliance.
