THE REPORTING ENTITY & STRUCTURE

This Modern Slavery Statement ('Statement') identifies the steps taken by Kennards Hire Pty Limited (ABN 69 001 740 727) ('Kennards') and its controlled entities to identify, manage and mitigate the risk of modern slavery in our supply chains and operations.

Kennards Hire New Zealand Limited (NZBN 94290305354473) operates under the control of Kennards. Kennards New Zealand is not, individually, a mandatory reporting entity under the *Modern Slavery Act 2018* (Cth) ('the Act').

During the reporting period, the Kennards executive team continued to have management oversight of Kennards New Zealand. Management and governance are applied consistently across both entities, including in relation to modern slavery.

This Statement has been published in accordance with the Act and has been prepared in consultation with the Kennards Board of Directors. This Statement has been signed by a duly authorised corporate officer.

In this Statement, where details have remained unchanged across reporting periods, information from Kennards' previous modern slavery statements has been reiterated.

OUR VALUES



INTRODUCTION

Now in our fifth year of reporting under the Modern Slavery Act, our Statement allows us to reflect on the 2024 financial year and the progress of our efforts and actions. Our corporate values underpin the way we do business and continue to serve as an effective framework for ensuring that we provide a fair working environment and zero tolerance for human rights in our supply chains.

Our modern slavery action plan is an important component of our broader environment, social and governance (ESG) strategy which is now in its second year of delivery. As is referenced in this Statement, we will again look ahead in the FY25 reporting period to formulate an updated modern slavery action plan to guide our efforts for the next planning period. The Kennards ESG strategy continues to ensure we are well positioned to meet our goals and positively contribute to our customers, our team members and the communities in which we live and work.

The introduction of a reduced working hour week in the previous reporting period has positively impacted work life balance, diversity in our workforce and overall productivity. Since our previous Statement, our key achievements include the reinforcement of our whistleblower process including the addition of an independent reporting channel, development and expansion of training, membership with the Cleaning Accountability Framework and the completion of targeted on the ground overseas supplier audits. We are proud of our progress over the past five reporting periods and are committed to continually improving and learning.

OUR OPERATIONS

Kennards is a leading equipment hire supplier with operations in Australia and New Zealand. We provide rental products and solutions across various market and industries, from do-it-yourself home renovators, through to complex services and equipment required for commercial construction and infrastructure projects. We also supply equipment and other support to specialist markets, including pumping and power generation, road traffic management, rail, testing and measuring, major events, concrete care, and lifting and shifting.

The Kennards network operates from over 210 branch locations and distribution centres across the two countries to deliver quality hire equipment products, industry solutions and exceptional services to a vast range of customers.

OUR PEOPLE & SUPPLY CHAINS

As of 30 June 2024, Kennards employed over 1,900 people across our branch and support network, comprised of 1,698 team members in Australia and 212 team members in New Zealand.

Since the conclusion of the previous reporting period, the proportion of full-time employees in our workforce has increased slightly and the proportion of casual employees has decreased slightly. Our workforce composition by type of employment is:

- 2% Part-time
- 6% Casual
- 92% Full-time

Kennards' supply chains relate primarily to products and services procured directly from suppliers to carry out our business operations. Procurement of the plant and equipment that we purchase to hire to our customers is the predominant area of supplier purchasing by both overall spend and time invested. Before the plant and equipment can be delivered to Kennards and made available to our customers, various activities must occur. These activities including raw material extraction, refinement, manufacturing and transport, each of which have their own complex supply chains.

The categories of plant and equipment offered by Kennards are varied and range across generators, air compressors and pumps through to site equipment, testing and measuring gear and traffic management products. Our supply chains also include the products and services utilised by our operational support functions.

MODERN SLAVERY RISKS

As has been the case in previous reporting periods, we are not aware of any actual or suspected instances or modern slavery in our supply chains or operations.

There have not been any material changes to our supplier composition during the reporting period or across reporting periods. Kennards continues to partner with over 5,000 suppliers. Our total number of suppliers decreased by approximately 2%. Our overseas supplier count did not change, continuing to account for less than 1% of Kennards total suppliers.

The risk assessment described in the ensuing methodology section was performed against the updated Kennards supplier list for the reporting period. Both the total number of suppliers and the proportion of Kennards suppliers assessed increased compared to the previous reporting period. The entire Kennards supplier list was included in our FY24 risk assessment.

Our approach to identify and assess the potential risks of modern slavery, including those that may lie well beyond the suppliers that we are in a direct contractual relationship with has remained consistent year-on-year. The risk assessment methodology, which remains unchanged since the last reporting period, is described in detail in the ensuing section. The principle of expanding modern slavery due diligence beyond direct suppliers to maximise transparency back to raw material and initial manufacturing stages continues to underpin the ongoing development of our response.

According to the risk assessment, the overall inherent risk profile of our supplier base decreased slightly. Taking the assessment back to tier 10 in the supply chain, the theoretical gross calculated number of people in forced labour across fell 6% year on year and by 4% per million dollars spent. The risk assessment also showed relatively higher modern slavery risk in more distant tiers of the supply chain. By geography, inherent risk is highest in Australia as a consequence of the concentration of procurement spend in this region, the next highest risk regions are China and India.

Risk Assessment Methodology

Incorporating company spend data throughout global markets, we have utilised external consultants with proprietary technology to trace the economic inputs required to produce products and services sourced from tier 1 suppliers to tier 2 suppliers, tier 2 suppliers to tier 3 suppliers, and so on, all the way to tier 10 suppliers in our supply chain.

This supply chain mapping was performed using a balanced, global Multi-Regional Input-Output (MRIO) table which links supply chain data from 190 countries, and in relation to 15,909 industry sectors. This MRIO table is assembled using the following sources:

- a. The United Nations' (UN) System of National Accounts;
- b. UN COMTRADE databases;
- c. Eurostat databases;
- d. The Institute of Developing Economies, Japan External Trade Organisation (IDE/JETRO); and
- e. Numerous National Agencies including the Australian Bureau of Statistics.

The MRIO is then examined against the following international standards:

- a. The UN Guiding Principles on Business and Human Rights;
- b. The Global Slavery Index;
- c. International Labour Organisation (ILO) Global Estimates of Modern Slavery; and
- d. The United States' Reports on International Child Labour and Forced Labour.

A proprietary algorithm has then been applied to synthesise publicly available risk data against the exclusively licensed MRIO table. The result of this process is the creation of a modern slavery risk profile to tier 10 for each supplier.

This analysis was performed for the purposes of risk identification under the Act. It does not purport to confirm the actual existence (or nonexistence) of slavery in our supply chains and operations. Analysis was undertaken at the industry and country level. It does not account for variances at the entity, region or product level.

The multi-faceted approach to modern slavery risk assessment that we have undertaken has included examination and analysis of the following:

- a. The individual suppliers and industries with the most elevated risk of modern slavery;
- b. Supply chain plots to provide a visual representation of the supply chains for our top three (3) first tier industries;
- c. Plotting the relative slavery risk in the supply chain by tier, up to tier 10;
- d. Geographical depiction of the cumulative risk of modern slavery across the supply chain around the world;
- e. An overview of the classification of the first tier of our supply chain by country and industry, including relative modern slavery risk; and
- f. Suppliers in our supply chains and operations that posed any calculated risks in relation to modern slavery were identified.

Key Risk Areas

Overseas Workers

In the FY24 reporting period, new team members joined Kennards under the subclass 482 temporary skill shortage visa. Overseas recruitment continues to enable Kennards to address skills shortages across our network of operations, particularly in Australia's remote locations.

We continue to monitor overseas recruitment closely and understand the elevated risk of modern slavery associated with the practice. We recognise that the risks range from those that we can directly control such as substandard working conditions through to risks to which we can contribute or be linked to such as exploitation by other parties early in the recruitment phase. Overseas recruitment risk controls include:

- Restricting overseas recruitment to a single jurisdiction using carefully selected suppliers with whom Kennards has developed strong working relationships;
- Only using recruiting agencies that are accredited by the recognised overseas government agency dealing with the protection of worker's rights and the promotion of full employment, quality of employment opportunities and securing the best terms and conditions;
- Requiring that suppliers instate establish ethical recruitment policies and practices and do not, under any circumstances, charge applicant's placement fees or costs;
- On the ground presence in the country of origin by a Kennards employed team member during each recruitment initiative. This enables the completion of in-person interviews and review of supplier operations on-the-ground for the purposes of ensuring workers' rights are being protected during the recruitment process;
- Ensuring workers recruited internationally are provided with appropriate remuneration and employee benefits, including assistance with accommodation and on-the-ground support. Kennards also supports applications for permanent residency; and
- Conducting annual salary audits to ensure all enterprise agreement and remuneration obligations are being met.

Our desk-based supplier engagement controls continue to apply for any new suppliers involved in overseas recruitment activities.

Commercial Cleaning and Related Services

In our previous Statement we referenced the characteristics limiting transparency in the cleaning industry causing elevated modern slavery risk. Cleaning has also been identified as a high-risk industry by Government. That risk can present itself in various way such as excessive overtime, debt bondage and withholding of wages. Although Kennards engages in relatively limited procurement of cleaning services, efforts to conduct in depth assessment of suppliers in this category were commenced during the reporting period and remain ongoing. The details of this initiative are described in this Statement in the 'Our Approach' section.

Solar and Critical Minerals

We are continuing to invest in solar capability at Kennards branches and are prioritising investment in lower emissions products for our customers. The solar rollout has involved the ongoing purchasing of solar panels and inverters while, in relation to hire equipment, battery, solar and electrical componentry is increasingly a feature of product innovation.

In our previous Statement we outlined the elevated risk of supply chain linkages in connection with solar and critical minerals. We are continuing to monitor media reports and importation bans both locally and in foreign jurisdictions regarding the presence of forced labour indicators in this area of elevated risk. An on-the-ground audit of our inverter supplier has been completed in China which is covered in more detail in the 'Our Approach' section. We are also investigating the feasibility and benefits of procuring fully 'traceable' solar panels.

Original Equipment Manufacturers

High spend in the machinery and equipment supplier category translates to an 11% share of Kennards overall inherent supplier risk profile. A high proportion of this risk is represented by a relatively small number of large suppliers. Resellers and distributers are often direct suppliers in this category. We are moving engagement efforts from direct suppliers to original equipment manufacturers to continue to improve effective assessment risk and mitigation.

OUR APPROACH

Cleaning Accountability Framework & Supplier Review

During the reporting period Kennards joined the Cleaning Accountability Framework ('CAF') as a member organisation demonstrating our commitment to responsible business practices and decent work for cleaners. CAF is a multi-stakeholder organisation that exists to end exploitation in property services and improve labour standards through education and advocacy. CAF stakeholders work together in a spirit of cooperation to drive responsible standards for the procurement, management and delivery of cleaning services. This occurs through CAF Certification, a worker-centric due diligence mechanism that assesses, addresses and mitigates the risk of labour exploitation by engaging workers and other supply chain stakeholders. Through CAF, Kennards is provided with updates on the risk profile in the cleaning industry, guidance on responsibility as a cleaning procurer and access to tools designed to improve identification, investigation and remediation procedures. As a CAF member, Kennards is working alongside other stakeholders to address modern slavery risk in this industry.

Kennards is in the process of completing a commercial cleaning supplier review. We have identified suppliers operating in this category, and, drawing on CAF expertise including utilisation of engagement and compliance tools, formulated an approach to engaging with suppliers. The purpose of the review and engagement is to assign residual risk ratings to suppliers and where modern slavery risk are identified, engage with the supply chain to implement corrective action and proactive measures to address the risks or if necessary, shift suppliers.

On-site Audits

During the reporting period we engaged a recognised third-party testing, inspection, certification and compliance solutions provider conduct on-the-ground supplier audits. The audits were targeted at high-risk suppliers and were focused focusing on working conditions, working hours, transparency and a range of other key indicators. Kennards is currently engaging with a key supplier regarding corrective actions in connection with the audit findings.

Internal Education and Training

After the conclusion of the reporting period prior to the lodgement of this statement, we developed an interactive training module designed to build knowledge and awareness of modern slavery and Kennards specific risks and expanded the delivery of modern slavery training internally. The module includes information about Kennards policies and procedures, how to engage suppliers about modern slavery, risk identification through to resolution and the requirements under the Act. During the FY24 reporting period, a separate training program was completed by the Kennards leadership team as referenced in our previous Statement.

Policy Framework and Governance

Supplier Pre-Screening

We are in the process of instating online supplier on-boarding due diligence as a trial to replace the risk checklists that have been used for the previous two reporting periods. The online supplier pre-screening is mandatory where the supplier is based offshore or operating in a high-risk industry. In circumstances where supplier risk is above threshold, or if actual or suspected wrongdoing is identified, the supplier must be referred to the Modern Slavery Working Group for assessment before on-boarding procedures continue. The transition to online pre-screening will likely enable supplier coverage to be expanded over time.

Supplier Code of Conduct

Our Supplier Code of Conduct reflects our company values and standards. The Supplier Code of Conduct includes an expectation that suppliers comply with international and domestic modern slavery regulations in all circumstances. The code supports the communication of our minimum expectations when we engage and work with our suppliers.

Whistleblower Policy

After the conclusion of the reporting period prior to the lodgement of this Statement, we reviewed and updated the Kennards' Whistleblower Policy. An independent third-party reporting channel has been added as a reporting option to promote the disclosure of reportable information in circumstances where the reporter may not feel comfortable making a report to an internal channel.

The Kennards' Whistleblower Policy supports risk remediation by providing affected parties and observers with a clear directive that wrongdoing in any form within or external to Kennards, by contractors or suppliers, should be reported. The Whistleblower Policy encourages legitimate reporting of wrongdoing by establishing a convenient and safe mechanism for doing so and by providing protection for people who make wrongdoing disclosures. Kennards did not receive any whistleblower reports during the reporting period. For more information and to obtain a copy of our Whistleblower Policy please visit the Kennards Hire Website.

Modern Slavery Policy

Our Modern Slavery Policy describes how Kennards' modern slavery risk mitigation is reflected through the internal governance framework including in operational policies and procedures. The Modern Slavery Policy establishes consequences of non-conformance and outlines Kennards' commitment to addressing modern slavery across training, engagement, due diligence and risk remediation.

Human Rights and Ethical Conduct Policy

Our Human Rights and Ethical Conduct Policy sets out our commitment and guiding principles to always respect and uphold human rights and demonstrate a high standard of ethical conduct across our operations.

Bullying, Harassment and Discrimination Policy

Our Bullying, Harassment and Discrimination Policy assists in minimising risk to our team members' wellbeing by education about and addressing inappropriate and unlawful behaviour.

Contracts

We have developed longstanding partnerships with many of our suppliers, particularly those from whom we procure the high-quality equipment we hire to our customers. Our standard equipment supplier contract contains contract provisions dealing with modern slavery including that the contracting party implement reasonable measures to address modern slavery in their own supply chains and operations.

Procurement Policy

Our Procurement Policy establishes our approach to procuring suppliers and services through a process of balanced judgement.

Grievance Handling Policy and Procedure

The Grievance Handling Policy and Procedure outlines the procedures for complaint handlings to ensure that grievances are resolved effectively, confidentially where relevant and with sensitivity to all involved. The grievance process is readily available and is used frequently. The grievance policy received minor updates during the reporting period to clarify the available reporting avenues and resolution pathways.

Supplier Self-Assessment Questionnaire (SAQ)

We did not undertake a broad SAQ oriented risk management exercise this reporting period. However, SAQs continue to play an important role in supplier engagement and modern slavery risk mitigation. SAQs were issued and response evaluated on an ad hoc basis throughout the reporting period.

Modern Slavery Working Group

The Modern Slavery Working Group met every other month during the reporting period with representation across Legal, Procurement, Finance and People & Culture including participation from the Kennards leadership team. The Working Group is well positioned to respond to modern slavery risk identified through risk mitigation initiatives, formal grievance mechanisms, informal communication and due diligence activities. The Working Group continues to be responsible for monitoring progress of modern slavery actions, assignment of tasks, risk tracking using the risk assessment platform and review and approval of proposed actions. The Working Group reports directly to the Kennards CEO, reporting to the Kennards Board of Directors.

REVIEWING OUR PROGRESS

Monitoring and Response Framework

Effectiveness has partly been measured using the monitoring and response framework referenced in our previous Statements and included in the table below. The key performance indicators (KPIs) have provided a reference point for tracking actions and illustrate the completion of key designated initiatives over the past reporting periods. We recognise the importance of transparency in relation to modern slavery reporting and we have again disclosed our progress tracking against each KPI with a brief explanation for missed KPIs where relevant.

A possible update to the framework was referenced in our previous Statement. We have elected to retain the framework for this Statement with commentary on performance. The framework will be replaced or updated in the next reporting period to align with the completion of our three-year action plan.

Three-Year Action Plan

The FY25 reporting period is the final year in the three-year modern slavery action plan we introduced in our FY23 Statement and have continued to reference. The multi-year framework underpins our strategic approach to continuous improvement actions. The structure and longer-term vision supported by the action plan has improved the integration of our approach across different business functions.

We aim to conduct a three-year holistic review at the conclusion of the current reporting period to evaluate our actions across this period and the efficacy of the three-year planning cycle. This review will support planning and decision making with respect to ensuring that a longer-term approach is applied to modern slavery risk management into subsequent reporting periods.

The key action plan activities to be implemented in FY25 reporting period are:

- Maintain full supplier list coverage in annual risk assessment;
- Increase number of suppliers subject to in depth assessment and engagement process following initial risk assessment findings;
- Identify relevant indirect (tier 2) supplier modern slavery risk and develop approach for engaging with and performing risk assessment and mitigation in connection with these companies;
- Consider feasibility of on-site audits for indirect suppliers should initial risk assessment activities indicate the need;
- Continue to monitor effectiveness of high-risk industry and/or geography supplier on-boarding pre-screening (pre-screening approach has been adjusted as per description in Our Approach section);
- Continue to monitor connection of any Kennards suppliers with new and existing company lists in relation to alleged linkages with modern slavery;
- Comprehensively review suppliers operating in designated high-risk industry;
- Continue to utilise on site audits as a critical tool for obtaining primary data and driving improved practices; and
- Review and update risk assessment framework for subsequent reporting periods.

HOW WE CONSULT OUR ENTITIES

This Statement is submitted on behalf of all controlled entities trading under Kennards Hire Pty Ltd and is inclusive of the operations, supply chains and relevant actions across both Kennards Hire and Kennards Hire New Zealand. As with previous reporting periods, the executive leadership team and the Board of Directors are responsible for managing all controlled entities and key business functions are centralised. Shared people, processes and initiatives ensures that consultation with the controlled entities on the matters set out in this Statement constantly occurs as part of 'business as usual' practices. The policies and codes referenced in this Statement apply to all entities.
