Established in Australia as EnerMech Pty Ltd as a proprietary company, with the ultimate parent company being EnerMech Group Limited, United Kingdom.

EnerMech Pty Ltd has a few subsidiaries in Australia all of which, apart from MInteg Pty Ltd, are defunct and non-operating with no revenue, no costs, no personnel.

MInteg Pty Ltd is very small with revenues well under A\$10M per annum and hence no disclosure is being separately made for MInteg Pty Ltd however all representations below with regard to Modern Slavery Statement are a representation being made for EnerMech Pty Ltd and its subsidiaries which includes MInteg Pty Ltd.

EnerMech Pty Ltd Group of Companies in Australia financial year and tax year is calendar year based. Audited financial statements and tax return last filed was thus for year ended 31 December 2019. There were 635 employees in EnerMech Pty Ltd Group at 31 Dec 2019.

The risk of modern slavery does exist due to us procuring materials and services from a range of suppliers/ providers across multiple commodity types. However, the risk is low to medium as majority of our supplier/ service providers are Australian or use Australia based personnel / materials. Below comprises majority of our procurement:

- Personnel hire via labour hire agencies, almost entirely Australian
- Consultancy largely from Australian providers using Australian work force

- Engineering, Fabrication and Machining almost entirely performed by and in Australia.
- Equipment Rental at least a part of the equipment we rent will be manufactured in Australia, though in part these could be manufactured overseas.
- Travel largely within Australia and using leading and Australia based airlines like Virgin and Qantas and, infrequently used, smaller regional airlines. Though Airlines may be using plant and equipment, products/materials procured from overseas but significant part of their cost is likely to be personnel.
- Accommodation which is largely within Australia and whilst Hotels will be using some products and materials manufactured overseas, a significant part of their supply chain is local personnel related
- Freight and logistics again mostly within Australia
- Gasses all manufactured locally.

But above suppliers / providers to us will surely have a part of their supply chains that may be exposed to international providers/suppliers and thus may have a higher risk of being exposed to modern slavery. Also, given the range of materials and services we procure including some from overseas, it is highly likely that some of our suppliers/ providers use products, materials and services within their supply chains that are coming from higher (modern slavery) risk countries.

Measures Taken to Assess, Address & Manage the Risk of Modern Slavery

Commitment & Policy & Modern Slavery and Human Trafficking Statement

EnerMech is committed to a zero tolerance of slavery and human trafficking, in all its different forms, in any part of its business and supply chain. Board and senior management are fully committed to managing modern slavery risk within our organisation. Please see our Modern Slavery and Human Trafficking Policy Statement attached.

Due Diligence

See attached EnerMech Supplier Assessment Form. Every supplier that is set up is required to fill in the attached and supplier responses are evaluated prior to accepting & setting them up for use. This includes a section on Code of Business Conduct including compliance with Australian anti-corruption laws, US FCPA and other applicable anti-corruption laws in jurisdictions that the suppliers do their business in. It also provides that if the supplier is a smaller business and does not have their own documented policies then they need to abide by EnerMech's supplier code of business conduct. Please also see SAF item 6.2 (Corporate Social Responsibility), SAF item 7 (Modern Slavery), SAF item 8 (compliance with Export control laws & regulations). Also see SAF item 5 (Environmental Management).

Risk Assessment

• Quantified spend – We listed all suppliers according to spend for assessment. Generally, the greater the amount of spend, the greater the risk hence larger value suppliers were especially focused upon.

- Categorised spend Sorted suppliers (covering entire supply chain) into categories and determined if they are supplying goods or services. Not only the direct suppliers captured in procurement but making sure we included indirect suppliers that occur throughout our operations, such as transport & logistics, labour hire, IT or manufacturing/ fabrication activities.
- Risk Assessment An assessment was done and letters sent to selected suppliers. Selection was risk based i.e. suppliers who are likely to use input materials and services in their supply chain that may be originating/ sourced from other countries which countries we are not aware of and thus we are unable to judge whether those countries are such that have a known history of human right violations. Hence we have circulated a questionnaire to a selected number of suppliers. Responses from suppliers will be evaluated over the course of the next few months and suitable action will be taken where suppliers do not respond or it is apparent that they are not managing the risk appropriately.

Engagement, Training & Specific Actions Taken

- Throughout 2017 and 2018, EnerMech worked towards putting in place the necessary requirements to enable the prevention of Modern Slavery within our Supply Chain. Although specific departments within our organisation are responsible for ensuring compliance to the Act, we appreciate that all EnerMech employees are to be held accountable for ensuring that any acts of Modern Slavery or Human Trafficking are prevented. 2019 saw EnerMech develop a Supplier Code of Business Conduct which contains provisions on the fundamental rights of workers. Please find a copy of our Supplier Code of Business Conduct attached.
- We have engaged with internal and external stakeholders including EnerMech senior management, operational leads, commercial, legal and procurement staff. A communication was issued to internal stakeholders in Australia in July 2020 advising them about Australian Government's Modern Slavery Act and Reporting Requirements. Also, attached letter was sent to identified suppliers which has a questionnaire to enable EnerMech to assess and ensure it meets its Australian Slavery Reporting Requirements.
- We perform online HSE Inductions and the Code of Business Conduct is mandatory for all staff which covers this topic. Please see attached EnerMech Code of Business Conduct:

Further Actions to be Taken

- Supplier responses to the questionnaires issued by EnerMech are pending to be evaluated.
- Revisiting the list of suppliers to increase coverage by sending questionnaire to other identified suppliers.
- Taking appropriate action where suppliers/providers have not provided us sufficient comfort that they in turn are managing the risk of modern slavery appropriately.

• Recirculating to higher (modern slavery) risk suppliers/providers EnerMech Supplier Assessment Form requiring them to fill in again to enable a full re-evaluation process.

Worst Forms of Child Labour, Forced Labour, Bonded Labour and Human Trafficking

EnerMech does not hire children under the age of 18. We obtain proof of age/identity documents from all new hires. We have a Modern Slavery and Human Trafficking Policy (attached above) that prohibits modern slavery including all forms of forced labour, bonded labour and human trafficking in its operations.

Grievance Mechanism

See attached EnerMech Employee Grievance Procedure outlining the process through which Employees and any subcontractors can raise a grievance they have witnessed or experienced by EnerMech or any of its suppliers. We also have an Australia Speaking Up Policy, please see attached.
