- **Mining and infrastructure**: outsourced contractors and international procurement.

5. Actions Taken to Assess & Address Risks

- **Supplier Due Diligence**: Screening of new suppliers for compliance with labour and human rights standards.
- **Contractual Safeguards**: Inclusion of modern slavery compliance clauses in supplier agreements.
- **Training & Awareness**: Staff training on identifying and reporting modern slavery risks.
- Whistleblower Mechanism: Confidential reporting channels for employees and suppliers.
- **Audits & Monitoring**: Periodic reviews of high-risk suppliers, particularly in pharmaceuticals and agriculture.

6. Assessing Effectiveness

We measure effectiveness through:

- % of suppliers screened against modern slavery criteria.
- Number of staff trained annually.
- Audit outcomes and remediation actions taken.
- Ongoing monitoring of high-risk supply chains (Thailand–Australia pharma logistics).
