



# MODERN SLAVERY STATEMENT - AUSTRALIA

This Modern Slavery Statement (Statement) has been prepared as part of our commitment to meeting the requirements of Australia's *Modern Slavery Act 2018 Cth*.

This Statement applies to the Australian Egis entities outlined in Schedule 1.

This Statement describes the steps taken by Egis to ensure modern slavery or human trafficking do not take place in any part of Egis' business or in its supply chains.

Egis' formal commitment is also incorporated within its Modern Slavery and Human Trafficking Policy – Australia and New Zealand (B3617-ANZ-M2-POL-010).

## DESCRIPTION OF BUSINESS

Business lines activities include Transport (Technical Advisory, Engineering & assurance in Rail, Roads, Transport Planning, Structures), Energy and Sustainable Cities (Technical Advisory, Project Management, Planning and Urban Development, Architecture Engineering Services and Facade Specialist, Buildings, Water and Energy) and Advisory and Operations (Advisory Services, Project Manager and Operations and Maintenance Services) in the public and private sectors.

## RISKS OF MODERN SLAVERY PRACTICES IN OPERATIONS & SUPPLY CHAINS

Having regard to the regulated nature of Egis' business in Australia and New Zealand (ANZ) coupled with Egis' internal policies, due diligence and systems, we consider that the overall risk of modern slavery existing within our immediate ANZ business and the operations of our first-tier suppliers is low.

Egis identifies the main opportunity for possible modern slavery risks within our ANZ business in the following key areas:

- **Local contractor and service arrangements.** Modern slavery risks arise where the services procured for the premises of business services involve exploited forms of work types such as cleaning services, indoor plant maintenance, document production and printing services.
- **Suppliers of suppliers (Second-tier suppliers).** Egis' supply chain, as with all supply chains, has several tiers and there are certain sectors and industries, products and services, geographic regions and supplier entities which carry a higher risk of modern slavery than others. While Egis monitors its first-tier suppliers and higher risk suppliers (based on geography or services being procured), it has less visibility or control of the business practices and operations of the suppliers of its suppliers (second-tier suppliers and beyond).

Egis considers its overall risk exposure in either key area to be low owing to:

- The nature of the goods and services which we procure (mostly services, mostly skilled professions); and
- The locations from which we procure them (mostly in developed markets); and
- Our procurement policies (for example, we agree to reasonable terms and ensure timely payment).

## OUR OPERATIONS & SUPPLY CHAIN COMMITMENT

Egis pledges to respect the human rights and the fundamental freedoms of all employees in line with the Fundamental Conventions of the International Labour Organisation (ILO). We strictly comply with the minimum

legal working age in all countries in which we operate as well as with the principles of freedom of association and non-discrimination in the workplace.

All forms of slavery, servitude, forced or compulsory labour and child labour are formally prohibited.

Acting ethically and with integrity in all business relationships are minimum standards of conduct expected from every Egis employee. We expect our employees to abide by the law in their respective jurisdiction, to observe statutory regulations and to comply with all of Egis' guidelines, policies and procedures.

We partner with our key suppliers in a manner consistent with our values on quality, safety, integrity and sustainability. In addition to undertaking due diligence of potential business partners we require our partners and suppliers undertake their obligations as follows:

- Adhering to our commitment to protect the health, safety and security of their own employees, clients and other third parties who could be affected by their activities; and
- Respecting the human rights of their own employees; and
- Paying their own employees a fair wage in line with statutory rates in the jurisdiction they operate in together with adequate working conditions.

## **MONITORING & COMPLIANCE**

Our policies and practices reflect our commitment to acting ethically and with integrity in all our business relationships and to implementing effective systems to ensure modern slavery or human trafficking do not take place throughout our supply chains in ANZ.

These commitments are reinforced through:

- Egis endeavours to partners only with high quality, reputationally strong suppliers who hold values that align with our own;
- In the event of any breach and/or concern regarding compliance with laws, we reserve the right to terminate agreements by written notice with immediate effect; and
- Strengthening our internal practices to counter slavery and human trafficking, whether this is through specific Modern Slavery training for Egis employees or by creating greater awareness of prevention.

Egis monitors the effectiveness of our processes and procedures to address the modern slavery risks that our business causes, contributes to, or is directly linked to, in line with the UN Guiding Principles. Egis is also a proud member of the United Nations Global Compact since 2011, ensuring its strategy and development align with the ten principles surrounding human rights, labour rights, environmental rights and the fight against corruption. Egis will continually assess the effectiveness of our actions in identifying and managing modern slavery risks by: tracking our actions and outcomes, partnering with suppliers and other external partners, and undertaking regular internal governance and external assurance processes. Based on the results of these processes we will adapt and strengthen our actions to continually improve our response to modern slavery.

Egis Group's Board of Directors hold overall responsibility for ensuring Egis' policies comply with our global legal and ethical obligations. Egis Group's Modern Slavery Statement can be accessed [here](#).
