

Modern Slavery Statement

Grindley is Committed to taking all reasonable steps for ensuring that the goods and services procured by Grindley are not the product of modern slavery. Grindley has a legal and ethical obligation for considering, identifying, managing, and reporting on modern slavery risks within Grindley's supply chains in accordance with the Modern Slavery Act (NSW) 2018 and Modern Slavery Amendment Act 2021.

Modern Slavery is a serious violation of an individual's dignity and human rights. It is a term used to describe situations where coercive, threatening, and deceptive practices are used to exploit victims and undermine them of their freedom. The term Modern Slavery refers to several offences including:

- Slavery, servitude, forced labour, deceptive recruiting for labour or services, forced marriage
- trafficking in persons, trafficking in children
- debt bondage
- sexual servitude
- forced child marriage
- the use of a child in the production of child abuse material and related offences
- the slavery, servitude or forced labour of a child.

With this Modern Slavery Statement, we identify the risk it poses on our organisation, the actions we implement to mitigate and prevent modern slavery.

2. Grindley's structure, operations, and supply chains

Structure

Founded in 1988 by Alan Carstens, Grindley Construction Pty Ltd is an Australian owned Construction group renowned for its expertise in the aged care, retirement, education, commercial, and industrial sectors. We take pride in being selected by our clients in our proven track record in delivering projects that exemplify exceptional quality and outstanding value.

In 2011 - Grindley interiors Pty Ltd was launched, specialising in high end fit outs, refurbishments and building upgrades. Grindley Construction and Grindley Interiors are collectively known as Grindley.

Operations

With exceptional delivery of meeting our clients' needs in the various sectors we serve, our clients are based in the Sydney Metropolitan, Greater Sydney, and Regional New South Wales. With our head Office located in Pymble, New South Wales, it employs just over 110 employees.

Supply Chains

As a head contractor we coordinate the services of subcontractors & suppliers to complete the projects works. Most of our subcontractors are small to medium sized entities (less than \$100m turnover) who are not required to complete a Modern Slavery Statement; however, they are to adhere to contractual agreement to follow Grindley's requirements, policies and procedures when carrying works within our projects.

Our suppliers are predominately located within New South Wales.

Below is a breakdown of our supply chain in the simplest of terms.





3. Identified Risks

While it may not be possible to completely eradicate modern slavery, we have identified risks within our operations. These risks can affect various aspect of our organization, including safety, quality, environmental impact, and financial stability. Most importantly, they have a direct impact on the well-being of those who work alongside us.

The identified risks are categorized based on our involvement, whether we contribute to, cause, or are directly linked to them.

4. Actions undertaken in FY23-24

To address and prevent modern slavery, we have established a framework that underpins our commitment to ethical practices and human rights. We are actively working to identify and mitigate risks within our organization. Our ongoing efforts are designed to ensure that our operations and partnerships adhere to the highest standards to safeguard the well-being of everyone involved.

Subcontractor Screenings	During submissions and offers, contractors and suppliers are requested to complete a questionnaire outlining any acknowledgement of Modern Slavery within its organisation. Although they are not required to submit a statement, they are to adhere to Grindley's requirements, policies, and procedures as well as all relevant local laws when working on our projects.



Policies	We address modern slavery by actively reviewing and updating our Human Rights Policy. By scheduling regular review dates to ensure alignment with the Australian Human Rights Commission guidelines, we can identify, prevent, mitigate human rights risks, including modern slavery, within our business.
Management	Incorporating Modern Slavery into Management meetings to address how as an organisation we are achieving our goals to mitigate and prevent Modern Slavery in our workforce.

We also aim to enhance our practices, as detailed in Section 7 of this statement.

5. Assess the effectiveness

During this reporting period, we focused on evaluating how our current indicators measure the impact of the actions we have implemented within Grindley. Guided by Commonwealth Modern Slavery Act 2018 resources, we aim to enhance these measures to ensure a more accurate assessment.

Subcontractor Screenings	The Internal assessments conducted on tier one supply chains creates transparency when works are outsourced to smaller entities. With the data received from this assessment it can help identify, measure, and compare the trades with their competitors on their understanding and actions towards modern slavery.
Research & Review	Comparing our performance and practices against industry benchmarks, best practices, and revolving standards.
Training and awareness	Assessing the level of awareness and the understanding of modern slavery through site inductions. Creating reports based on the knowledge collected from project inductions and tender questionnaires.

Our measures are calculated utilising the following actions:

We have engaged extensively with the senior management teams, directors, and key stakeholders of both entities to review our reporting obligations. We have provided them with comprehensive materials and updates regarding the actions we are taking to address these requirements effectively.

7. Other Relevant Information – Improvements

Based on our analysis and consultations with both entities regarding the identification, assessment, and management of modern slavery risks, we are poised to implement these enhancements in the near future.

- Formalising a grievance and remediation framework to install within our ethical policies.
