# Assessing and actioning the Risk of Modern Slavery

To address and mitigate potential risk of modern slavery Clover Pipeline within our operations and supply chain has implemented management systems and procedures to prevent exploitation of humans rights in our business and our supply chain.

With regards to our key suppliers, agreements will be developed and agreed including requirements to meet various international and local standards and applicable local and international laws including modern slavery.

Our key suppliers are identified, reviewed and approved annually in line with our ISO 9001:2015 certification.

Clover Pipeline provides training to all management, staff and contractors in relevant polcies and procedures to give a better understand of the risks to the business including Modern Slavery.

Clover Pipeline also maintains and implements various Policies into its operations as follows. All suppliers, management, staff and contractors must comply to these polices.

# Assessing the effectiveness of the Risk of Modern Slavery

Clover Pipelines is committed to continuously review and update its procedures and processes in all aspects of its business operations including modern slavery practices and protecting human rights.

Various audits of the business operations are conducting each year to ensure compliance not only to relevant International, Australian Standards and but also to local and international legalisation applicable. It includes Health & Safety, Quality and workplace conditions. Any gaps or areas of concern are recorded and corrective action is implemented to rectify the issue.

The findings of these audits are reviewed in annual management review meeting together with the actions taken to rectify them. All policies are reviewed in this meeting to ensure they are current and updated where required.

With multiple distribution centers and locations across Australia states all supported by a sophisticated logistics operation, we cover all corners of the country and into the APAC region. From large shipments of entire pipeline packages to small but critical replacement items, to our clients we are more than just suppliers, we are trusted project partners with shared deadlines and common goals.

# **Consultation Process**

Clover Pipeline consults with employees, contractors and suppliers to identify and address risk of modern slavery. Within the business various levels of the staff and management are involved in the process cumulating in Senior Management Review Meeting. Clover Pipeline is committed to meeting is its legal obligations both locally and internationally and continually improve its processes and compliance.

During the reporting period, Clover Pipelines actively engaged and consulted with all companies/business units owned or controlled in the development of this statement (Clover Pipelines Pty Ltd entity addresses are outlined in the contacts us section of this document). Clover Pipelines discussed details of the Modern Slavery Act 2018's reporting requirements; information regarding the actions we intend to take to address these requirements and provided them with relevant materials and updates including:

- a) monitoring Clover Pipelines' existing suppliers and undertaking risk assessments in relation to new suppliers to ascertain whether they pose a modern slavery risk and, if they do, to reduce that risk to the maximum extent possible;
- b) reviewing and updating training material to ensure that it is up to date, relevant and effective;
- c) reviewing Clover Pipelines' policies and Supplier Code of Conduct to ensure they remain relevant and in compliance with all applicable laws; and
- d) engaging with suppliers and key customers to verify they are following through with any modern slavery actions they have committed to undertaking.
