

# Zip Water Group MODERN SLAVERY STATEMENT

## MODERN SLAVERY STATEMENT

Made pursuant to the Australian Modern Slavery Act 2018

#### **REPORTING ENTITY**

This modern slavery statement is made in compliance with the Modern Slavery Act 2018 (Cth) (the Act) on behalf of the Zip Water Group.

The Zip Water Group reporting entities are referred to collectively in this statement as "Zip Water" (we/us/our).

The registered office and principal place of the Zip Water Group businesses is 77 Allingham St, Condell Park, NSW 2200.

#### **OUR STRUCTURE AND OPERATIONS**

Zip Water specialises in the design, development, manufacture, supply and service of drinking water systems to wide range of residential and commercial customers primarily under the Zip brand.

We have a manufacturing and warehouse facility at our head office in Condell Park NSW and have sales offices and warehouses located throughout Australia. Our team of approximately 470 people which are located in Australia also support sales and distribution businesses in New Zealand and the United Kingdom. We also export our products to a wide range of countries through our distribution network and through our parent business Culligan Corporation. The Culligan Corporation is a global business operating across a wide range of sectors in the drinking water market.

We operate as part of the Culligan Group and have a senior leadership team based in Australia who lead and operate the Zip Water business.

#### **GOVERNANCE AND POLICY FRAMEWORK**

Zip Water is committed to compliance with all applicable laws and standards where we directly operate. We also expect our suppliers to do the same in the regions they operate in. We fully acknowledge that risks of modern slavery exist in any complex supply chain, particularly where raw materials are procured by our suppliers from one or more other companies that we have no direct interaction with, or knowledge of. In order to control this risk, we have implemented new policies into our procurement framework. These policies apply across the Zip Water Group.

# **OUR SUPPLY CHAIN**

Zip Water produce the majority of the Zip products in Australia using a wide range of raw materials and componentry such as copper tubes, aluminium coils, steel, plastic components, fans, compressors, insulation and electrical components which are supplied by both Australian and overseas based suppliers and manufacturers. These overseas countries include China, Germany, USA, Taiwan, Brazil and the UK.

We have identified approximately 515 suppliers to our business. Over time we have been seeking to consolidate our key suppliers and have 13 major suppliers to our business where our annual spend exceeds \$1 million dollars with each supplier. Of these suppliers we have applied a risk based approach to identify higher risk suppliers for the purposes of modern slavery compliance who will be required to undertake our modern slavery questionnaire.

As a component of a strategic procurement program all of our suppliers will be required to meet the requirements set out in our Zip Supplier Manual which includes a requirement to manage the risks of modern slavery. As part of that process suppliers to Zip will progressively be required to undertake a supplier questionnaire in order to continue to be an approved supplier to Zip Water.

# DESCRIPTION OF MODERN SLAVERY RISK IN OUR SUPPLY CHAIN

The majority of our suppliers are based overseas. We also have a significant number of Australian based suppliers, however, due to the nature of the products we source from those Australian suppliers many procure these products from overseas and then supply to Zip Water.

The assessment of modern slavery risks is undertaken by the Zip Operations team which is overseen by the Zip Compliance, Quality and Risk Management committee. In order to undertake an assessment of the modern slavery risks to the business we have undertaken a risk-based analysis of our expenditure. This analysis includes an assessment of the type of product or services supplied to us; the geography of supply; and any specific known supplier issues.

#### **ZIP SUPPLIER MANUAL**

This document contains all the expectations we have of current and prospective suppliers. It details Zip Water's position with respect to quality, compliance, delivery and ethics, including modern slavery.

The Supplier Manual is updated periodically and is referenced in all new Supply Agreements. It is also freely available on our website for any prospective supplier to review.

#### SUPPLIER AUDITS

We periodically audit our suppliers to determine capability and identify any risks to supply, quality, compliance or cost. We also evaluate their business practices with respect to ethical practices and the effectiveness of their management structure and business systems to maintain and improve these going forward.

First preference is always to conduct a supplier audit face-to-face, at the supplier's facility. Where this is not practical to complete, especially in the current climate of travel restrictions, supplier audits can also be completed virtually via teleconference.

#### STAFF TRAINING

Staff responsible for procurement will receive training on what the Modern Slavery Act 2018 entails, along with their responsibilities to report any risks they become aware of as a result of their interactions with our suppliers.

## ACTIONS TAKEN AND ASSESSMENT OF EFFECTIVENESS

We have assessed the risks of modern slavery impacting our business and have integrated this into our supplier approval and risk management process. This integration is an on-going activity across our business and will extend to inclusion in our policy and procedural documentation and practices.

We are not currently aware of any modern slavery practices occurring within our supply chain.

Oversight by the Zip Water Compliance, Quality and Risk Management committee will ensure that the process are embedded within the Zip Water businesses.

# CONTINUOUS IMPROVEMENT

We are committed to continuous improvement of our systems and processes in order to reduce the risks of modern slavery in our supply chain into the future. This will include;

- Continued training of our staff;
- Progressively rolling out new supply agreements that reference our Supplier Manual; and
- · Reviewing closely any suppliers deemed to have elevated risk.

#### CONSULTATION

All of the entities listed in this statement have common directors and officers and are aligned across the Zip Water Group.

The Zip Water Compliance, Quality and Risk Management committee is constituted by senior members of the Zip business and is responsible for the activities of all members of the Zip Water Group.

#### **APPROVAL**

This statement was approved by the Board of Zip Heaters (Aust) Pty Ltd on 5 October 2021 and is signed by John Doumani who is a Director and President of Zip International. This modern slavery statement has been adopted across the Zip Water Group.
