#### 1 GROUP OVERVIEW

#### **Primary Function**

The Pharmacy Guild of Australia is registered under the *Fair Work (Registered Organisations) Act* 2009 (RO Act) to provide industrial relations advice and support to pharmacy businesses in Australia. Functions provided by The Pharmacy Guild of Australia are listed below.

All entities covered by this report are incorporated in Australia, with the exception of Guild Solutions Inc, a fully owned subsidiary which is incorporated in the Philippines.

The Pharmacy Guild of Australia (including its Branches) is registered under the RO Act and is an incorporated entity per section 27 of that legislation.

Some support services are provided by Guild Solutions Inc, a fully-owned subsidiary which is incorporated in the Philippines.

# 3 RISKS OF MODERN SLAVERY PRACTICES IN OPERATIONS AND SUPPLY CHAINS

For the entities covered by this report, The Pharmacy Guild of Australia considers that the risk of modern slavery in its Australian operations is low due to its higher skilled workforce. The Pharmacy Guild of Australia takes the view that Australian employment laws create a compliance environment where there is no appreciable risk of Modern Slavery within its Australian domiciled workforce.

The Pharmacy Guild of Australia has identified a higher inherent risk of modern slavery in its wholly owned subsidiary, Guild Solutions Inc. (GSI), which operates in the Philippines and as such is not subject to Australian labour law.

From risk assessments undertaken of key suppliers, the risk of modern slavery in The Pharmacy Guild of Australia supply chains has been identified in the areas of outsourced cleaning contractors, professional service firms that outsource services to overseas countries and information technology companies that manufacture electronic products globally, which are not subject to Australian labour law.

## 4 DUE DILIGENCE, RISK MITIGATION AND REMEDIATION

In order to determine whether and to what extent modern slavery risks are present in the Pharmacy Guild of Australia and its supply chain, the Pharmacy Guild of Australia:

- 1. Maintains employment practices that comply with Australian labour law
- 2. Requires new key suppliers to complete a Modern Slavery Questionnaire as part of the selection process
- 3. Requires the completion of an annual Modern Slavery Questionnaire by its key suppliers and/or for any key suppliers whose responses to the annual Modern Slavery Questionnaire indicate the Modern Slavery Risk is likely to be present in their business or supply chain:
  - a. Vendor managers work with key suppliers to check how they are progressing and any actions they have put in place to address Modern Slavery risks,
  - b. They are required to complete the Modern Slavery Questionnaire on a half-yearly basis, and
  - c. Half-yearly attestations are obtained from the relevant business unit leader where that business unit wishes to continue to use the supplier.
- 4. Analyses the responses to the Modern Slavery Questionnaires completed by each of its key suppliers and arrives at a Modern Slavery risk rating for its key suppliers.
- Tracks its risk of Modern Slavery via its risk management frameworks. The Pharmacy Guild of Australia's risk profile, which includes Modern Slavery risk, is reviewed on an ongoing basis and is reported to National Council, the relevant Branch Committee or company board, as applicable.

Guild Solutions Inc. (GSI) is a wholly owned subsidiary of Guild Group Holding Ltd (GGHL), which is incorporated in the Philippines. GSI takes the following steps to lower the risk of modern slavery in its Philippines operations:

- GSI staff receive salary and benefits which exceed government-mandated minimum standards.
- GSI Staff use a clock-in / clock-out system in line with local HR requirements to ensure worked hours can be monitored and overtime paid.

# 5 CONSULTATION PROCESS WITH ENTITIES THAT THE REPORTING ENTITY OWNS OR CONTROLS

On an annual basis, entities within the controlled group are provided with an update on modern slavery reporting requirements and provided with materials to conduct key supplier questionnaires, risk assessments and remediation processes.

Entities within the group provide the results of their risk assessments to The Pharmacy Guild of Australia on an annual basis to enable a Modern Slavery risk assessment and analysis to be conducted at a consolidated level for the reporting period.

# 6 EFFECTIVENESS OF ACTIONS TAKEN TO ASSESS AND ADDRESS MODERN SLAVERY RISKS

The Pharmacy Guild of Australia understands that a key process in the management of Modern Slavery risks is to continually review the effectiveness of its actions to assess and address Modern Slavery risks in its operations and supply chains. The following activities assist the entity in achieving this outcome:

- Board oversight of Modern Slavery risks through regular reviews of The Pharmacy Guild of Australia's Risk Register and Modern Slavery Policy, which includes the incorporation of ongoing learnings into the policy and associated processes
- 2. Training of relevant employees on Modern Slavery risks
- 3. Operation of an independent Whistleblower service in which employees can report suspected misconduct
- 4. Ongoing review of Modern Slavery reporting processes, including the Modern Slavery Questionnaire and risk assessment procedure

#### 7 IMPROVEMENT OF ANNUAL MODERN SLAVERY REPORT

For the period ending 30 June 2023, The Pharmacy Guild of Australia has improved its Modern Slavery Reporting by:

- 1. Including a more granular description of its Modern Slavery Reporting Processes, such as, how it consults with key vendors
- 2. Including more granular descriptions of its due diligence, risk mitigation and remediation activities
- 3. Augmenting its key supplier Modern Slavery Questionnaire with additional questions.

#### 8 MODERN SLAVERY RISK ASSESSMENT

For the period ended 30 June 2023, The Pharmacy Guild of Australia has found no likelihood of any modern slavery risk in its or any of its subsidiary's businesses or supply chains.

This statement was approved by the National Council of The Pharmacy Guild of Australia (principal governing body) on 13 December 2023.


