As a Tasmanian business with a long and proud history, we recognise our responsibility to the communities in which we operate, to our employees, and to all people connected to our value chain. Our team has taken significant steps to enhance awareness, transparency, and accountability, particularly through risk assessments, supplier engagement and third-party audits.

Respect for human rights is non-negotiable. We oppose all forms of modern slavery, from forced labour and servitude to human trafficking, all of which are categorically unacceptable. Our policies and practices reflect a zero-tolerance stance on modern slavery in all its forms.

We remain focused on continual improvement, building capability, deepening our engagement with suppliers, and fostering a workplace culture where human rights are understood and championed, at every level. This is a journey, and we are committed to the path forward.

We strive to “do right by our whānau”, ensuring all people connected to our business are treated with dignity and respect.

This means taking modern slavery seriously, not only as a regulatory obligation but as a moral imperative. Across our group, we are building robust governance systems, encouraging transparent partnerships, and acting on risks where they emerge. Guided by the principles of kaitiakitanga and manaakitanga, we are determined to build a future where exploitation has no place in seafood supply chains.

Our History

Founded in 1949 by Peter and Una Rockliff, Petuna has grown from a small family fishing business into one of Australia's most respected vertically integrated aquaculture companies. Headquartered in East Devonport, Tasmania, Petuna has a proud history grounded in innovation, regional employment, and a deep respect for the marine environment.

Petuna is wholly owned by Sealord Group Limited, a New Zealand-based seafood company with significant international operations. Sealord is co-owned by Moana New Zealand, which represents the collective interests of Māori iwi across Aotearoa (New Zealand), and global seafood leader Nissui (Nippon Suisan Kaisha, Ltd). This unique ownership structure underpins Petuna's long-term commitment to sustainability, kaitiakitanga (guardianship), and the protection of people, culture, and the environment.

Our Operations

Today, Petuna produces premium Atlantic Salmon and Ocean Trout, supplying retail, wholesale, and export markets. The company's operations span the entire supply chain — from broodstock development and hatchery management to marine farming, harvesting, processing and distribution. Petuna's facilities include a hatchery in Cressy, marine farming zones in Macquarie Harbour and Rowella, a modern processing facility in East Devonport, and corporate offices in both East Devonport and Launceston. A third marine site is proposed at Storm Bay, reflecting the company's forward-looking approach to sustainable growth.

With a workforce of approximately 170 employees and a seasonal labour hire contingent of up to 70, Petuna is a major regional employer. The company takes pride in its role within the Tasmanian aquaculture sector and is focused on responsible growth, best-practice animal husbandry, and the ethical sourcing of all inputs.

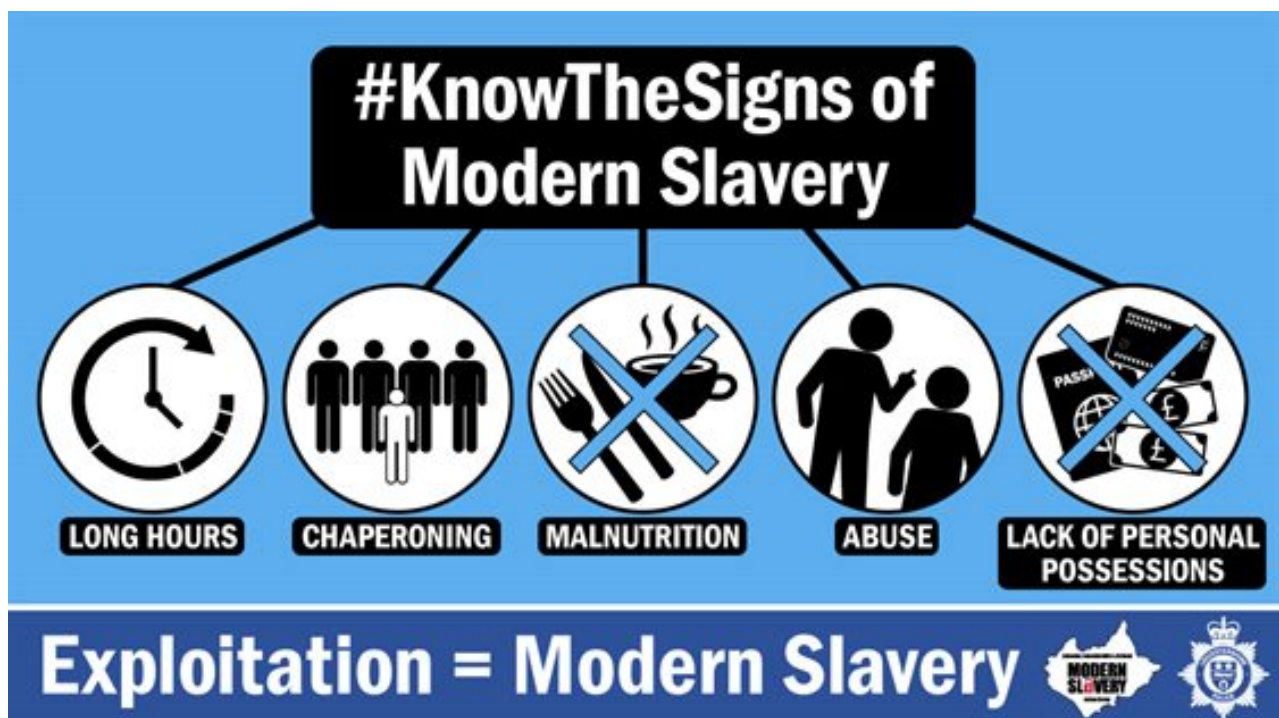

Definition of Modern Slavery

Modern slavery encompasses a range of severe human rights violations where individuals are exploited through coercion, threats, violence, deception, or abuse of power. It involves situations where people are unable to leave or refuse such conditions due to fear or control. Forms of modern slavery include, but are not limited to:

- Forced labour
- Human trafficking
- Debt bondage
- Forced or servile marriage
- Sexual exploitation
- Slavery-like practices
- The sale and exploitation of children



These crimes are fundamentally incompatible with universal human rights and dignity. According to the Walk Free Global Slavery Index (2023), more than 50 million people globally were living in modern slavery as of 2021, an increase of 10 million since 2018. The Asia-Pacific region accounts for the highest number of people subjected to modern slavery, underscoring the importance of continued vigilance in Australian and regional supply chains.

Australia is a party to a number of international conventions that prohibit modern slavery, including:

- The Universal Declaration of Human Rights (1948), Article 4
- ILO Conventions No. 29 (Forced Labour), No. 105 (Abolition of Forced Labour), No. 138 (Minimum Age), and No. 182 (Worst Forms of Child Labour)
- The United Nations Protocol to Prevent, Suppress and Punish Trafficking in Persons, Especially Women and Children (Palermo Protocol)
- The United Nations Guiding Principles on Business and Human Rights (UNGPs)

Australia's commitment is further embedded through the Modern Slavery Act 2018 (Cth), which mandates corporate reporting and transparency around the risks of modern slavery in operations and supply chains.

Alignment with UN SDGs

Petuna is committed to aligning our operations, governance, and ethical sourcing practices with the United Nations Sustainable Development Goals (SDGs).

These goals offer a modern, strategic framework to guide improvements across our business, with a particular focus on supply chain sustainability, traceability, and transparency. They serve as a globally recognised structure for delivering measurable impact, especially in enhancing the ethical performance of our supply chain, and will be used to help to guide the development future-fit systems that strengthen our due diligence and risk management across procurement and supply networks.

Adopted by the United Nations in 2015, the SDGs define global sustainable development priorities and seek to mobilise coordinated international action to end poverty, protect the planet, and ensure peace and prosperity for all. There are 17 interlinked goals, each with specific targets designed to address the world's most pressing challenges.

Petuna recognises modern slavery as a direct threat to SDG 8.7, which calls for immediate and effective measures to eradicate forced labour, end modern slavery and human trafficking, and eliminate the worst forms of child labour. Our commitment to human rights and ethical business practices aligns with the broader UN SDG framework, and we are working to embed the principles of sustainable development into our day-to-day operations.



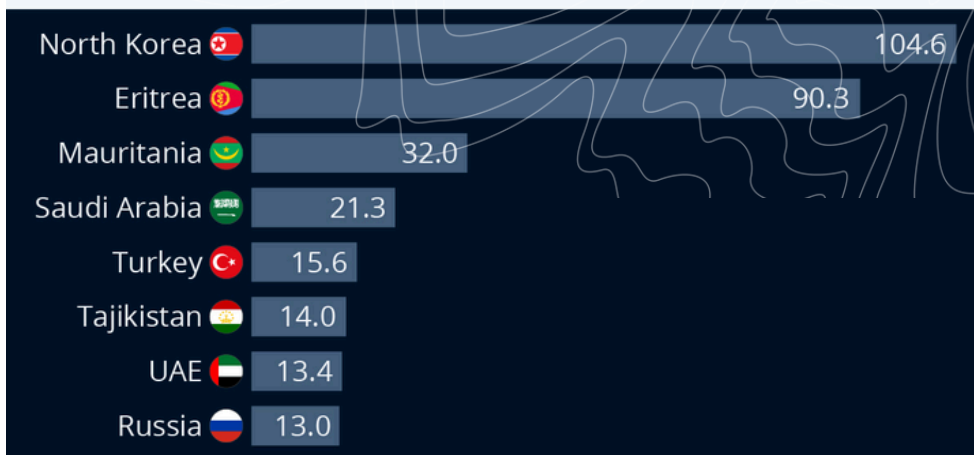
In particular, our actions contribute to:

- **SDG 8 – Decent Work and Economic Growth**
 - Through fair employment practices, ethical procurement, and labour rights compliance, Petuna supports inclusive and sustainable economic growth and decent work for all.
- **SDG 12 – Responsible Consumption and Production**
 - We are focused on sustainable sourcing, efficient use of resources, and greater supply chain visibility. This includes strengthening procurement policies, supplier due diligence, and third-party auditing to ensure responsible business conduct.
- **SDG 14 – Life Below Water**
 - Petuna supports the long-term sustainability of seafood supply chains by reducing the environmental and economic drivers that contribute to modern slavery. Through ethical resource management and transparent sourcing, we help limit reliance on informal or unregulated labour, where exploitation risks are highest.
- **SDG 16 – Peace, Justice and Strong Institutions**
 - Our corporate governance framework promotes transparency, accountability, and ethical conduct. This includes mechanisms such as our Whistleblower Policy, grievance procedures, and modern slavery compliance program.

We acknowledge that addressing modern slavery is not a one-off action but a continuous improvement journey. Petuna is committed to playing our part in the global effort to eliminate modern slavery by embedding due diligence, risk assessment, and stakeholder engagement into every level of our operations and value chain.

Petuna Aquaculture Pty Ltd is wholly owned by Sealord Group Limited, a New Zealand incorporated company.

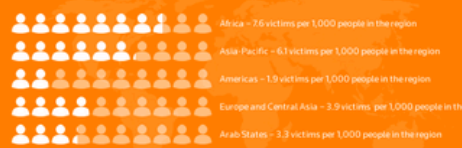

Our Supply Chain

Petuna sources various products for our operations predominately from local and interstate suppliers; however, also some products are sourced internationally. Products can vary from packaging for the processing facility to fish feed, farm nets, to plant equipment and operating machinery for our marine farms.

Categories of services used by Petuna include, but are not limited to: information technology service providers, distribution logistics, facilities services, and consumables.

Our risk of Modern Slavery

Petuna is committed to producing the highest quality, sustainable and ethically sourced salmonids whilst responsibly maintaining the health and welfare of our people, our fish and the environment in which we operate. Petuna's values, policies and practices and the expectations of our people regarding ethical conduct eliminate/mitigate the risk of modern slavery practices in our own workforce, however we acknowledge that the risk of potential modern slavery practices in the supply chain are always present.

Sourcing specialist capital equipment and product associated with our operations from overseas countries with less developed economies, regulations, and practices, together with indirect entities, that Petuna does not have a direct contractual arrangement (our suppliers supply chains), are assessed as having an increased risk of the potential for modern slavery practices. The number of local suppliers represents 96% of our total supply chain activity, with 4% of our input supply chain based internationally.

Actions taken to assess and address risk

Petuna has made significant progress in assessing and addressing the risks of modern slavery throughout our supply chain and operations.

In November 2025, management representatives from our Macquarie Harbour marine farm completed a trip to India to inspect, verify and audit the operations of our new marine farm net supplier. During the visit, aspects of modern slavery were thoroughly reviewed to ensure compliance with our stringent ethical standards. The addition of an on-site evaluation during the procurement process underscores our commitment to maintaining a supply chain free of modern slavery and reinforcing our dedication to ethical business practices.

Petuna continues to annually review and update our existing formal policies and documents that promote ethical conduct and form due diligence against and prohibit modern slavery and broader human rights (HuR) practice violations, as well as provide avenues for individuals to report. Robust recruitment processes ensure compliance with requirements for employing overseas workers, young workers, and other workers who may be at risk of exploitation.

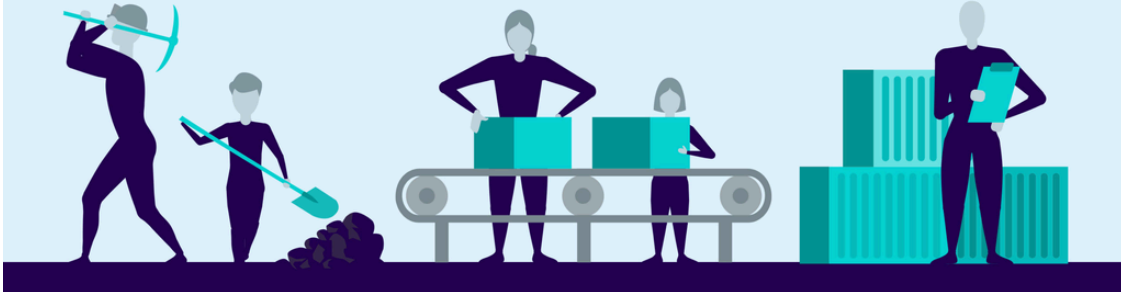

Petuna has an appointed Modern Slavery Compliance Officer, whose role includes oversight of the implementation of these policies and procedures.

Petuna is registered as a supplier with the Supplier Ethical Data Exchange (SEDEX) and undertakes Supplier Member Ethical Trade Audit (SMETA) four pillar third-party compliance audits encompassing labour standards, business ethics, health and safety, and the environment.

Additional third-party compliance audits occur across all our sites in the form of our Best Aquaculture Practices (BAP) accreditation. BAP is the only third-party certification program that encompasses the entire production chain, including our hatchery, processing plant, farm and feed mill. BAP certification is a due diligence compliance process that amongst other crucial business areas, covers worker safety and workplace relations.

To increase and maintain awareness across Petuna, modern slavery education has been included in our induction program which also serves as refresher training every twelve months. Additionally, new and existing key personnel involved in procurement processes have also undergone specific modern slavery awareness training.

Supply chain management

During 2022, Petuna engaged a third-party to review and assess all our suppliers for modern slavery activity risk, determined against relevant criteria originating from the *World Benchmarking Alliance* and the *United Nations Human Rights, Office of the High Commissioner*.

Suppliers that represent a spend of \$200,000 per annum or more were reviewed/assessed for potential risk, utilising accepted HuR modern slavery criteria. A scoring system was adopted which consisted of assessment based on 3 major risk criteria.

The assessment resulted in nine suppliers being determined as having potential for high-risk of modern slavery activities. Petuna’s evaluated potential modern slavery risk areas include:



As part of our supply chain process all new suppliers and renewing suppliers are subjected to our due diligence process before Petuna will enter a contract with them. Supplementary assessment is conducted at Petuna's discretion and any reservations around business conduct, compliance, and human rights is reviewed and mitigated in partnership with the relevant supplier representative.

Suppliers that are considered by Petuna to present a modern slavery risk following due diligence will be either rejected or subjected to continuous monitoring. Where appropriate, Petuna is committed to take the necessary actions to terminate supplier arrangements or contracts with any suppliers that do not comply with the supplier code of contract.

Petuna has implemented a three-tier initial supplier assessment process:

Tier 1. Supplier Ethical Code of Conduct

- As part of our commitment into integrate ethical and socially responsible business practices into all aspects of our business. As part of that code, Suppliers commit that they currently do and will continue to comply with Petuna's ethical sourcing principles and practices. Suppliers acknowledge that Petuna may verify compliance through internal or external assessment mechanisms including but not limited to questionnaires, declarations, site-visits, request for policies and other documentation validating practice as well as third-party ethical audits. The code includes the following areas of ethical conduct: wages, working hours, harsh and inhumane treatment, discrimination, bullying and harassment, freely chosen employment, child labour, safe working conditions, freedom of association, entitlement to work, and recognised immigration.

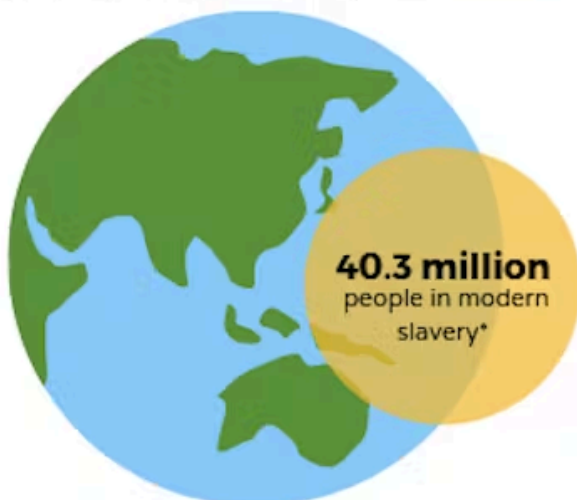
Tier 2: High Risk Supplier Assessment

- Using the criteria of \$200,000+ spend and assessment against geographic location, products/services supplied, and industry/sector, will complete the self-assessment questionnaire (Australian Government Supplier Questionnaire) and provide supporting documentation, policy and process. Additional evidence of compliance will be pursued by either provision of documented third-party social licensed audit (SMETA or similar recognised standard) or via Petuna audit where third-party audit activity is not occurring.

Tier 3: Site Visit for High-Risk Suppliers (if necessary)

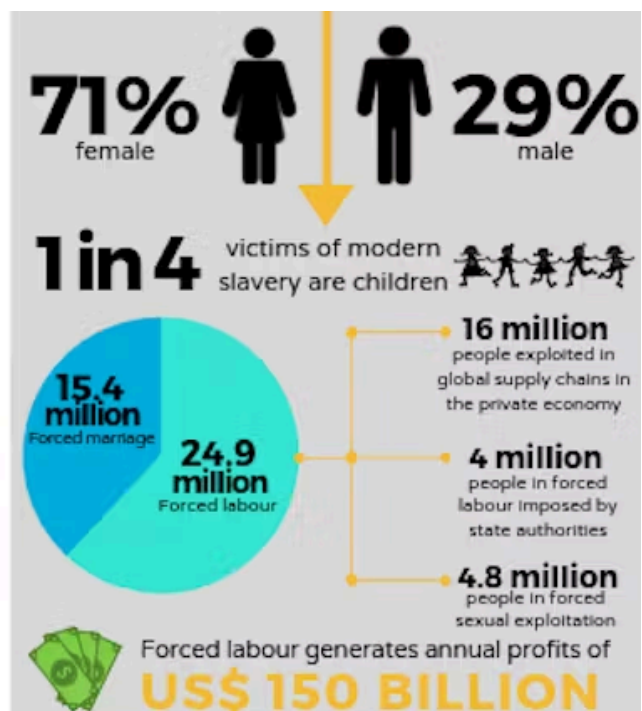
- Where risk remains high or additional assurance is required, Petuna may undertake an in-person site visit to assess supplier practices on the ground. This will be considered on a case-by-case basis. An example includes the recent supplier visit in India, which provided important insights beyond documented assurances.

Measuring Effectiveness

Petuna continues to measure the effectiveness of its actions against modern slavery risks by conducting annual internal reviews, site-visits where necessary, and participating in third-party compliance audits. We have completed the development of a Human Rights (HuR) policy incorporating modern slavery mitigation. We continue to seek evidence and validation of our key suppliers' commitments to modern slavery prevention, including the requirement of third-party ethical audits for suppliers deemed high-risk.

We will continue to explore further mechanisms to assess the effectiveness of actions we undertake to address modern slavery in our operations and supply chain.

Consultation with Associated Entities

As all Petuna entities share the same board and executive/senior management team, consultation occurs automatically, however there is also ongoing consultation with key managers and other personnel that have procurement involvement. Petuna is wholly owned by and engages with Sealord Group Ltd of New Zealand on broader human rights issues and international standards that impact our business.

Future Commitments

Over the next few years our key focus areas to improve our approach to modern slavery will include the following:

- **Supplier Commitment Validation:** Continue to pursue evidence and validation of our key suppliers' commitment to modern slavery prevention, including insisting on third-party ethical auditing for suppliers deemed high-risk.
- **Ongoing Supply Chain Review:** Maintain and enhance our supply chain review processes to ensure continuous monitoring and assessment of modern slavery risks.
- **Training and Awareness:** Develop and implement new training and awareness programs to educate employees and key stakeholders about modern slavery risks and our policies to mitigate these risks.

- **Legal Compliance:** Implementation of a biannual formal legal compliance programme that will include assurance by management of compliance with ethical sourcing legislation and Petuna’s own ethical sourcing policies.
- **Improved Metrics and Indicators:** Develop new metrics and indicators to better measure the effectiveness of our actions in addressing modern slavery, including the introduction of measurable KPIs for suppliers
- **Stakeholder Engagement:** Enhance consultation processes with entities within Petuna and Sealord Group Ltd to ensure a comprehensive, cohesive and proactive approach to human rights and modern slavery issues.
- **Ethical Sourcing Practices:** Strengthen our ethical sourcing practices by incorporating feedback from internal and third-party audits and assessments, and ensuring compliance with our supplier code of conduct.
- **Community and Industry Collaboration:** Collaborate with industry bodies, NGOs, and the community to share best practice, enhance transparency and stay informed about emerging risks and strategies to combat modern slavery.

By committing to these actions, Petuna seeks to proactively uphold and strengthen ethical and responsible practices across our operations and supply chains, while contributing to the ongoing prevention of modern slavery.
