Introduction

Stripe is a global technology company that builds economic infrastructure for the internet. Businesses of every size - from new startups to public companies - use our services to accept payments and manage their businesses online. Our goal is to promote equal economic opportunity and equip entrepreneurs from all over the globe to realize their business ideas.

At Stripe, we strive to always do the right thing in our business operations, complying with all applicable laws and maintaining high ethical standards.

Why do we need to make a statement?

We publish this statement in compliance with the *Modern Slavery Act 2018* (Cth) to show our users how we implement policies, procedures and controls to help prevent modern slavery, human trafficking, forced labour, and labour rights violations from taking place in our business and supply chains.



This statement applies to Stripe Payments Australia Pty Ltd, ABN 66 160 180 343 ("Stripe Australia") for the period of 1 January - 31 December 2025.

This Statement was approved on 29 June 2026 by the Board of Stripe Australia.

What is modern slavery?

Modern slavery encompasses all types of slavery, human trafficking, servitude and forced or compulsory labour across a vast number of industries. Modern slavery may affect individuals that are resident within or outside Australia, and includes:

- Human trafficking
- Slavery
- Servitude
- Forced labour
- Debt bondage
- Forced marriage
- Deceptive recruiting practices, and
- Child labour and exploitation (where children are subject to slavery or similar practices, or engaged in hazardous work).

Organisational Structure

Stripe provides business infrastructure and payment technology that is tailored to the needs of merchants and e-commerce platforms. Stripe simplifies payment processing for businesses of all sizes by reducing many of the complexities that can be a barrier to accepting payments online.

Stripe Global Holdings Inc. (the ultimate parent company of Stripe Australia) was founded in 2025, and is headquartered in the United States. Stripe offers services in over 40 countries.

Stripe Australia was founded in 2012 as a proprietary company and has a registered office at Level 18, 383 Kent St, Sydney NSW 2000. Stripe Australia's principal business is to provide products and services which simplify the processing of online payments for users



across Australia. Stripe Australia acts as reseller of the Stripe services in Australia; contracting with Australian merchants and platforms for the delivery of the Stripe services.

Stripe's risks of modern slavery practices in its operations and supply chains

Stripe is committed to acting ethically and with integrity in all of our business relationships. We do not tolerate any form of modern slavery, and have systems and controls to help prevent such activity from taking place in our business or supply chains.

Stripe's supply chains include:

- Hardware and software, including computer equipment, software licenses, verification vendors, and cloud-based software;
- Data storage services; and
- Professional services from our advisors including law firms, consulting and accounting firms.

The majority of our suppliers are based in Australia and North America.

As an internet-based payment technology business, with the majority of our suppliers being software and professional service providers, Stripe operates in a sector that is considered relatively low risk for modern slavery and human trafficking.

Actions taken by Stripe Australia to assess and address those risks

Stripe Australia will not deal with any business whom we know to be involved in modern slavery. We take below actions to assess and address its modern slavery risk.

Supplier Due Diligence

Stripe conducts risk-based due diligence of new suppliers before we work with them and on an ongoing basis throughout Stripe's relationship with the supplier. This due diligence involves reviews by Stripe's security, compliance, finance and procurement teams. It includes an assessment of the supplier's modern slavery risk, based on the supplier's jurisdiction and business line. Stripe notifies suppliers of Stripe's Supplier Code of Conduct

expectations, which includes compliance with laws and a commitment to opposing modern slavery and human trafficking in all aspects of their business and supply chain. Once relevant risk assessments are completed, our suppliers contractually commit to us to comply with all applicable laws in the performance of their obligations.

If Stripe, through its reviews of suppliers, establishes that modern slavery is taking place in our business or supply chains, we will terminate the relevant relationship, report such activity to law enforcement (where applicable) and cooperate with any resulting investigation.

Employee Involvement

In addition, Stripe's employees are expected to behave in accordance with our Employee Handbook. Ethics, transparency, and integrity are core values that we expect all Stripe employees to exemplify when communicating inside and outside of Stripe. Stripe employees are encouraged to raise concerns of suppliers through Stripe's Speak Up program. Stripe also protects whistleblowers through its Speak Up Policy, which provides a confidential avenue for disclosures to be made anonymously.

Training

At Stripe, all employees are required to complete annual Financial Crimes training. This training informs all employees about the high-level red flags of financial crimes, including human trafficking, and provides clear escalation paths to ensure any suspected financial crimes issues are properly reviewed and investigated.

How Stripe Australia assesses effectiveness of actions

To assess the effectiveness of Stripe's Modern Slavery controls, an annual review will be undertaken to examine:

- the appropriateness and effectiveness of the questions within our procurement and due diligence processes to ensure any potential Modern Slavery risks are identified before onboarding a supplier;
- the completion rate of required training modules;

- the concerns raised by Stripe employees in relation to its suppliers.

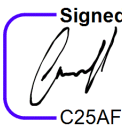
Consultation with relevant entities
