


# MODERN SLAVERY STATEMENT



Redox is a publicly listed Australian chemical distribution company established in 1965, with its headquarters in Sydney, Australia. We manage our own domestic distribution network of warehousing facilities. It currently operates from 19 locations across eight (8) countries being Australia, New Zealand, Malaysia, Singapore, Mexico, Canada, and the United States. Redox's principal operations are predominately situated across Australia and New Zealand, with offices located in almost all major cities.

Globally, Redox employs over 400 employees, representing a diverse range of backgrounds and experience. Our team includes over 180 salespeople supporting customers across the Asia Pacific and the United States. During the Reporting Period, all Redox employees were engaged under formal employment contracts that comply with local legal requirements.





Our business has grown to become one of the leading chemical and ingredients distributors in the world. Redox is proud to distribute more than 1,200 product groups to a diversified rage of over 7000 customers from over 169 industries consisting of: commodity and specialty chemicals; food ingredients; agricultural chemicals; household and personal care chemicals; mining chemicals; surface coatings; plastics additives; grease and lubricants; water treatment chemicals; building and construction chemicals and pharmaceutical ingredients.

# INTERNAL GOVERNANCE & POLICIES

Redox recognise that effectively managing modern slavery risks in our operations and supply chains requires strong governance, clear expectations and high-performance standards. We have established a companywide policy framework that reinforces our commitment to protecting labour rights and upholding ethical business conduct. Our policies are periodically reviewed and updated to ensure continued alignment with evolving legislation, best practice, and stakeholder expectations.

### Company-wide policies and procedures with relevance to management of modern slavery

**Modern Slavery Policy** 

Defines Redox's minimum standards for ethical labour practices, setting clear expectations for employees, suppliers, and business partners regarding labour standards, including child labour, forced and compulsory labour, human trafficking, freedom of association and collective bargaining.

**Whistleblower Policy** 

Outlines Redox's process for making and investigating a disclosure in line with the Whistleblower Protection Scheme set out under the Corporations Act 2001 and the Taxation Administration Act 1953. This policy promotes transparency, integrity, and protection from retaliation.

**Diversity Policy** 

Formalises our commitment to fostering diversity, equity, and inclusion within the workplace. It supports a culture that values different perspectives and ensures equal opportunity for all employees.

Harassment, Bullying and Discrimination Policy

Affirms Redox's commitment to maintaining a safe, healthy, and respectful work environment that is free from bullying, harassment, and discrimination. This policy ensures all employees are treated with dignity and fairness.

### **Operational policies and procedures**

**Code of Conduct and Ethics** 

Our Code of Conduct and Ethics defines the standards of integrity, professionalism, and accountability expected of all employees, officers, and directors. It serves as a practical guide to ethical decision making and responsible business conduct at Redox, supporting our commitment to lawful, fair, and transparent operations.

#### **Supply chain policies and procedures**

**Supplier Code of Conduct** 

The Supplier Code of Conduct outlines Redox's minimum expectations for suppliers and their associated entities. It establishes clear standards relating to human rights, the prevention of forced labour and human trafficking, non-discrimination, safe and fair working conditions, and environmental protection. Compliance with this Code is a condition of ongoing partnership with Redox.

## MODERN SLAVERY RISKS

We recognise that the risk of modern slavery within our operations and supply chain may be increased by the scale and complexity of our global sourcing activities, as we procure a wide range of products and services from numerous countries around the world.

### **RISKS IN OUR OPERATIONS**

Following a detailed assessment, Redox considers the risk of modern slavery within its direct operations to be low. This is primarily due to the majority of our workforce being directly employed by Redox under robust legal and regulatory frameworks that govern employment conditions in each jurisdiction in which we operate. Our operations are located in countries with strong labor laws, transparent employment practices and effectively regulatory oversight, reducing the likelihood of exploitative labor conditions.

Additionally, contractors within our distribution network, are predominantly based in low risk regions including Australia and New Zealand. Redox maintains a high level of oversight across all jurisdictions of operation, ensuring compliance with workplace standards and ethical expectations. We place a strong emphasis on employee training, awareness and accountability, ensuring that our values are embedded throughout our operations. By maintaining rigorous internal polices and procedures, we aim to mitigate the risk of unethical practices and uphold our commitment to ethical business conduct.



#### **RISKS IN OUR SUPPLY CHAIN**

Redox operates a complex multi-tiered supply chain that spans numerous countries. This global reach inherently increases the risk of modern slavery due to limited visibility and oversight on the working conditions of our suppliers' workforce. The primary source of modern slavery risk in our supply chains are associated with:

## Third-Party Labour

The use third-party labour hire companies or recruitment agencies can increase the risk of worker exploitation and unfair labour practices. To mitigate this risk, Redox requires that all third —party labour hire companies complete and sign a Supplier Declaration Form. This process ensures that suppliers engaging labour through third parties uphold our standards for ethical employment, fair treatment, and safe working conditions.

# Supplier Geographic Location Procurement from suppliers located in High-Risk jurisdiction

Procurement from suppliers located in High-Risk jurisdictions (Afghanistan, Cambodia, DR Congo; India; Indonesia; Iraq, North Korea; Pakistan; Philippines; Sudan; Uzbekistan; Xinjiang, (China) [In Alphabetical Order] increases the likelihood of modern slavery practices entering our supply chains. To mitigate this risk, Redox applies enhanced due diligence measures and stronger regulatory oversight.

## **Product or Services Market**

Redox has identified that certain products and services, such as palm oil, carry a higher risk of modern slavery due to the nature of their global supply chains. To reduce these risks, Redox has partnered with Roundtable on Sustainable Palm Oil (RSPO) to ensure that all of Redox suppliers of palm oil are producing Certified Sustainable Palm Oil. This partnership helps us uphold responsible sourcing practices and supports the ongoing elimination of exploitative labour in high-risk product markets.

Redox remains committed to continuously improving the transparency and traceability of our supply chain and the identification of high-risk suppliers. Redox continues to strive to maintain ethical business practices aligned with human rights standards, by monitoring our supply change and supplier engagement.

# MANAGING MODERN SLAVERY RISKS

**Supplier Assesments:** To mitigate the risk of modern slavery and unethical practices within our supply chain, Redox has implemented an Ethical Sourcing Declaration Program. Under this program, all suppliers must obtain an internally issued permit before being classified as a Redox approved supplier. To be eligible for a permit, suppliers are required to complete the Ethical Sourcing Declaration, confirming compliance with Redox's internal governance policies, ethical sourcing standards, and relevant legislation. Where a supplier in unable to sign Redox's Ethical Sourcing Declaration, we request that they provide us with wither their own modern slavery internal governance policies for assessment or provide us with a copy of a valid Sedex/Smeta audit report. Each supplier is subject to a risk assessment to ensure that their operations and employment practices align with Redox's values, applicable laws, and our Supplier Code of Conduct.

**Supply Chain Monitoring:** Redox regularly monitors its supply chain through ongoing reviews of the US Customs and Border Protection (CBP) Active Withhold Release Orders and Findings List. Suppliers issued with a Withhold Release Order (WRO) by the Commissioner or appearing in the published Federal Register are flagged for investigation and follow up. This process enables Redox to maintain visibility across all supply chain tiers and promptly identify potential modern slavery risks, ensuring that our sourcing activities remain compliant and transparent.

**Training and Capability Building:** The Quality Assurance, Marketing, Food Safety and Legal departments are required to complete this mandatory training every two years from their employment commencement date. These programs strengthen the capability of our workforce to identify, assess and manage modern slavery risks within our supply chain. During this Reporting Period, Redox reviewed and enhanced its modern slavery training to communicate our values and practices and ensure greater alignment with industry, customer, and shareholder expectations more effectively.



# COLLABORATION WITH OTHER ORGANISATIONS



#### SEDEX

Sedex provides Redox with comprehensive data, tools and insights that enhance visibility and transparency across our global supply chain. Through Sedex's platform, Redox can monitor supplier sustainability performance, assess ethical risks, and strengthen compliance.



#### **Roundtable on Sustainable Palm Oil (RSPO)**

Redox collaborates with RSPO to identify and mitigate risks associated with the sourcing and distribution of palm oil. By partnering with RSPO, Redox ensures that all palm oil supplied through our network is responsibly sourced and certified under the Certified Sustainable Palm Oil (CSPO) standard.



#### **Australian Trusted Trader (ATT)**

Redox partners with ATT to enhance the security and integrity of our international supply chains. Accredited by the Australian Government Department of Home Affairs and the Australian Border Force, this partnership supports Redox in maintaining compliant trade practices, protecting Australia's trade borders, and upholding ethical and secure supply chain operations.



### Rainforest Alliance (RA)

Redox participates in the RA certification program which plays a key role in promoting sustainable sourcing and ethical trade practices. Through this collaboration, Redox supports initiatives that protect biodiversity, foster responsible business conduct, and improve working conditions in supplier factories and farms.

# ASSESSING OUR ACTIONS


Redox conducts regular reviews of our Ethical Sourcing Declaration Program. This program includes ongoing internal reporting on the number of active suppliers that have submitted a signed Ethical Sourcing Declaration and hold an internally issued permit. Redox also places a large effort on reducing the number of suppliers it partners with that have not submitted a signed Ethical Sourcing Declaration, or otherwise fail to meet our ethical sourcing requirements.

During the Reporting Period, Redox assessed and issues modern slavery permits to a total of 1,821 new and existing active suppliers, which accounts for approximately 85% of our active supply chain.

The total number of active suppliers this Reporting Period has nearly doubled since the last reporting period. Despite this significant growth, the percentage of active suppliers holding a modern slavery permit has remained stable. This indicates that Redox is effectively maintaining visibility into its supply chain. During this Reporting Period, there were no breaches found through the monitoring of the CBP Active WRO and Findings List.

## **2026 INITIATIVES**

Redox recognise that preventing and addressing modern slavery risks in our operations and supply chains requires long-term ongoing vigilance, collaboration and long-term commitment. During the next Reporting Period, Redox will focus on the following key initiatives:

#### **EDUCATION OF OUR SUPPLY CHAIN**

Redox will continue to strengthen supplier awareness through educational communication on modern slavery prevention.

### **IMPROVING MODERN SLAVERY POLICIES AND PROCEDURES**

We will review and update our Modern Slavery Policy and Procedure, including our supplier risk assessment and due diligence processes.

#### **SUPPLIER DUE DILIGENCE**

Redox will continue quarterly reviews of the U.S. Customs and Border Protection (CBP) Active withhold Release Orders and Findings List to identify suppliers of concern. We will continue to seek voluntary collections of valid SMETA/SEDEX audits from new suppliers.

#### SUPPLIER DECLARATION PROGRAM

We will further strengthen our Supplier Declaration Program by increasing the number of suppliers holding a valid ethical sourcing permit.

Redox is confident that these initiatives will reinforce our comprehensive approach to combating and addressing modern slavery risks within our operations and across our supply chains.
