MODERN SLAVERY STATEMENT



Reporting Entity

This statement covers the activities of Wisdom Properties Group Pty Ltd (ABN 82 089 425 829) (Wisdom)

Wisdom submits this Modern Slavery Statement in accordance with the *Modern Slavery Act* 2018 (Cth) (Act).

The statement outlines Wisdom's approach and actions taken to identify and address the risk of modern slavery and human trafficking within its operations and supply chain for the calendar year, 1 January 2024 to 31 December 2024.

Wisdom is committed to operating with integrity, strong corporate governance and to the highest ethical standards. Any behaviour or actions of modern slavery will not be tolerated.

ABOUT US

Established in 1999, Wisdom Properties Group Pty Ltd (Wisdom) has been constructing homes across New South Wales. Wisdom is a market, award winning professional builder of beautiful and modern homes, pools and landscaping that exceed customer expectations in design and quality. By providing a home, pool and landscaping services, Wisdom offers a full turn-key solution to homebuyers.

Wisdom is a privately owned incorporated, NSW residential building company. The company began in 1999 as a family owned home building business based in South West Sydney. Wisdom has grown over the years and is now owned by Japan's Sumitomo Forestry Group and operates throughout greater Sydney and in other parts of NSW.

With the backing of a global building leader in Sumitomo Forestry Australia, Wisdom is a professional builder, with long standing relationships with contractors and trades and a focus on guiding the customer through the building process.

Wisdom believe the homebuilding journey is just as important as the home. It is one of the biggest life decisions its customers will make, which is why Customer Experience, is at the forefront of everything it does.

Wisdom is made up of a team of dedicated and focused professionals, who strive to exceed our customers' expectations by supporting, nurturing and providing specialised advice giving them the home they have always dreamed of.



ORGANISATION STRUCTURE, OPERATIONS AND SUPPLY CHAIN

Wisdom operates in the residential construction industry in New South Wales, predominantly in the Sydney, Illawarra, Hunter Valley and South Coast.

Wisdom's head office is located in Gregory Hills, New South Wales and it operates display centres across Sydney and the Illawarra at HomeWorld Box Hill, HomeWorld Marsden Park, Cobbitty, Leppington and Calderwood. Its operations are resourced by a team of approximately 100 employees and over 2832 workers within contractors, subcontractors and tradesperson.

Wisdom's subsidiary companies and brands, all of which operate within Australia only, include:

- Wisdom Homes;
- Wisdom Landscapes Pty Ltd;
- Wisdom Pools and Landscapes;
- Wisdom Constructions Pty Ltd;
- Wisdom Real Estate Sales Pty Ltd
- Inspire Group Pty Ltd; and
- Canvas Quarter Design Studio.

While only Wisdom meets the criteria of a reporting entity under section 5 of the Act, all steps take to mitigate and assess any risk of modern slavery were taken across all of Wisdoms subsidiaries companies.

Wisdom's principal operations are to design, sell and oversee the construction of new homes. Wisdom builds new homes on land owned by customers and on greenfield land for the sale of completed homes, or home and land packages. The display homes provide the homebuyer the opportunity to browse the company's range of homes, pool and landscaping services, designs, speak to expert consultants and to experience the quality of finishes and inclusions.

Wisdom's supply chain involves products and services that contribute to the design, marketing, sale and construction of residential dwelling, including:

- Office supplies;
- Utilities;
- Promotional and marketing materials;
- Technology (hardware, software, cloud services);
- Home construction goods and materials;
- Specialised trades and labour;
- Labour hire firms in Australia;
- Professional services consultants, organisations and contractors; and
- Operational support services including finance, technology, human resources, sales, marketing, procurement, development and design.

Wisdom's organizational structure and process involves:

- Sales made by an internal sales team, with completed 'spec' homes also sold by external agents;
- Pre-construction includes drafting, tender/contracts, estimating and pre-construction lodgments, all completed internally, but with scope to use external drafting/estimating resources if demand exceeds our internal capacity;
- Construction each home is managed by a site supervisor who engages with the contractors and tradespersons who complete the building works.
- Maintenance / Warranty post handover of the home, any warranty or maintenance work is managed by a dedicated internal team, using external tradespersons and contractors.





RISKS OF MODERN SLAVERY IN OUR OPERATIONS AND SUPPLY CHAINS

While Wisdom recognises that modern slavery and human trafficking risk may occur in the organisation and extended supply chain, aside from drafting and estimating services performed in China and the Philippines (being services that are not engaged on a regular basis), Wisdom's supply chain involves products and services sourced from local and Australian suppliers. For this reason, Wisdom considers the risk of modern slavery to be very low.

Wisdom has sought feedback and clarification on the risk of modern slavery through regular communications and interactions with employees, contractors and suppliers. Despite this, Wisdom has not been made aware of the existence of any forms of modern slavery in its operations during the reporting period.

Wisdom sources building materials from local and national Australian suppliers, which may source materials/components from overseas suppliers. Wisdom is not aware how they may procure labour during the manufacturing processes, but has made reasonable enquiries with its suppliers to confirm that there are no instances of slavery throughout the network.

To ensure that Wisdom minimises the risk of modern slavery and the potential exposure of human rights more broadly, Wisdom has introduced a range of initiatives to assess contractor and supplier risk, ensuring the organisation has robust and effective processes that are embedded in how it conducts its business.

RISKS IDENTIFIED

Having completed a comprehensive analysis, Wisdom does not consider there is any risk of modern slavery within its internal operations. However, where external resources are used, there is risk of modern slavery practices:

- 1. Overseas based drafting and estimating resources;
- 2. The manufacture of material particularly where the material is manufactured overseas;
- 3. Mining of materials;
- 4. Labor within the supply chain particularly the use of migrant labor by some contractor companies; and
- 5. On site labor particularly the use of migrant labor by some contractor contractors.

RISK MANAGEMENT

Wisdom has formal policies and procedures in place that are intended to promote ethical and legally compliant business conduct. The policies contribute to their commitment to prevent violations of human rights such as modern forms of slavery in the business, including Code of Conduct, Grievance and Complaint Policy, Whistleblower Policy and Modern Slavery Policy.

Wisdom's Procurement team have a number of risk mitigation and procurement processes in place, including Contractor/Supplier Engagement Agreements and contractor/supplier on-boarding requirements. On each of the Purchase Order, contractors/suppliers are reminded of their obligations to look out for and report any risk of modern slavery.

All purchase orders issued to trades, contractors and suppliers reference Wisdoms commitment to identifying and reporting any potential modern slavery example. This includes a dedicated mailbox, that is monitored regularly, where concerns must be reported.

The external drafting and estimating resources are based in the Philippines and are owned by a related entity of Wisdom. The overseas office are held to the same standards as Australians and provided the equivalent working conditions. This is audited regularly by the Australian based management.

As the construction and maintenance supervisors have the most interaction with the suppliers and tradesmen, a specialized training session was held with them to help them understand the risk and reporting requirements around Modern Slavery and Wisdoms policies on the issue.

All of the above procedural controls will be reviewed to ensure that Wisdom's processes minimise the risk of modern slavery in its operations and supply chains.



RISK MITIGATION ACTIONS

In order to identify and potential instances of modern slavery, Wisdom undertakes the following actions:

Policy

All staff are required to read the Modern Slavery Policy and acknowledge their requirements in ensuring Wisdom comply with its obligations under the Act. Staff must complete a refresher of the Policy every two (2) years.

Training

Delivered mandatory modern slavery training to staff to increase capability and awareness. The training includes a requirement that all staff have read and understood the Modern Slavery Policy, then correctly answer 10 questions on the Policy. All new starters must complete the training and existing staff must complete the training every two (2) years.

Reporting

A modern slavery email address (modernslavery@wisdomgroup.com.au) allows easy, available and open reporting of anything that may constitute modern slavery. It is provided within the Policy and on Purchase Orders issued to contractors and suppliers. No reports were made.

Assessment

Wisdom's procurement team analyzed all supplier and contractor types to assess the potential of modern slavery to exist. Considerations included: whether any products were manufactured overseas, or more specifically, whether the opportunity for modern slavery exists within Wisdom's supply chain. Where a supplier/contractor had multiple risk factors, they were contacted directly to ask what they were doing to avoid modern slavery in their company and supply chain.

A Modern Slavery Committee was formed comprising of a range of Wisdom staff, including the CQ Manager, Head of Supply Chain and Procurement, Head of Construction, General Counsel and HR Manager. The Committee met regularly (usually every 2nd month) to discuss any potential risks associated with modern slavery and any other actions that may be taken mitigate the risk.

When considering the products that are installed within the home, Wisdom management inspect the factories and warehouses where the products are manufactured and/or held. These inspections are carried out, (amongst other things) as a tool to assess the suitability of the facilities of Wisdoms supply chains and identify any potential risk of modern slavery.

RISK MITIGATION ACTIONS (cont.)



Consultation

Engaged with all suppliers by:

- Issuing a notification to all suppliers and contractors via SkyTrust that (amongst other things) notifies them of :
- our Modern Slavery Policy and provides them a copy;
- their obligation to be aware and on the lookout for any potential instances of modern slavery;
- the email address to report any concerns or potential instances of modern slavery; and
- the Modern Slavery Policy and a requirement to read and acknowledge the policy in the onboarding of all new suppliers and contractors.

The above steps also assist Wisdom in mitigating the risk of modern slavery occurring within its business and/or its suppliers/contractors.

For contractors who source their material from overseas (by way of example: Tiles), Wisdom consults with the Management of these businesses to understand the steps taken by the contractor to assess and reduce any risk of modern slavery in the supply chain.

Co-Operation

As part of the Sumitomo Forestry Group, which includes other major builders such as Henley, Metricon and Scott Park Group, Wisdom's Procurement Team meets twice yearly with the comparable roles at the related builders to discuss supply chain. These discussions focus on creating a synergy within our collective supply chain. Another focus of these meetings has been investigating the use of the manufacturing and raw material business' owned by Sumitomo internationally (i.e. timber supply and plasterboard). These international companies are run at the high standard set by Sumitomo Forestry and provides Wisdom with great visibility to ensure compliance with Modern Slavery legislation.

Compliance

All persons who carry out works on Wisdoms building sites must be inducted for work health and safety purposes. The induction includes a record of their qualifications and white cards and a photo.

When on site, supervisors and Wisdoms dedicated WHS team must check that all persons working on site have been inducted. If they have not, the person is either inducted or removed from site. For any contractor whom may be forced to be on site against their will, they are provided a safe opportunity to raise an alarm to our team during this process.

This process ensures that Wisdom has visibility over the persons carrying out works on site and ensures that those persons who are carrying out works as part of Wisdoms operations are in the country legally and working without duress.

Planned Actions & Next Steps

- Continue to raise awareness of modern slavery across our supply chain, through regular dialogue and clear guidelines and policies;
- Continue the use of Modern Slavery clauses in all new and renewed supplier and sub-contractor agreements and Purchase Orders, stating they must assess their manufacturing supply chain/s to ensure compliance with all Anti-Slavery Laws and provide training and education to their officers and workers.
- Increase frequency of meetings between Supply Chain and Procurement teams from Sumitomo Forestry Group builders.
- Investigate vertical integration opportunities whereby Wisdom has more control and visibility of its supply chain.

Effectiveness of Actions

- Continue to evaluate the effectiveness of actions taken to prevent Modern Slavery. This includes a comprehensive assessment of our policy reviews and annually when preparing our Modern Slavery Statement. This has occurred during the preparation of this Statement, with the Modern Slavery Committee meeting specially to discuss and evaluate the Statement, along with proposed actions that can be undertaken to improve our process' throughout the next year.
- These evaluations contribute to our developing approach to combat modern slavery are effective and aligned with our commitment to ethical practices.
