# **OUR APPROACH**

#### **Human Resources**

NEPEAN has policies in place which promote legal and ethical business conduct. These are regularly reviewed and receive Board approval. All new employees upon induction into procurement roles receive initial and ongoing Modern Slavery awareness training and learn of NEPEAN's policies, guidelines and actions taken by NEPEAN in order to minimise and prevent Modern Slavery from occurring. NEPEAN's existing employees continue to receive Modern Slavery awareness training, which is implemented via shared learning platforms and reinforced by our various General Managers across our different business units.

Our guiding principles are underpinned by the United Nations Guiding Principles on Business & Human Rights, Universal Declaration of Human Rights and the International Labour Organisation's Declaration of Fundamental Principles and Rights at Work.

### Speak Up

NEPEAN promotes a confidential Speak Up reporting regime and has a dedicated Modern Slavery Complaints Officer, specifically tasked with the investigation of Modern Slavery suspected incidents or occurrences. This is augmented by NEPEAN's Whistleblowing policy.

## **Supplier Due Diligence**

Our Commercial, Project & Finance teams continue to carry out various supplier due diligence checks and enquiries including issuing on-boarding questionnaires, desktop assessments, visiting suppliers (and customers) on site as well as holding discussions with suppliers as to what measures and policies they are taking and implement within their own organisation and supply chains in order to prevent & minimise Modern Slavery.



#### Contracting

Our standard purchase order terms and conditions, conditions of sale and all of our other supply and purchase agreements require our suppliers and customers to acknowledge that they have no knowledge of any Modern Slavery offences occurring within their organisation(s) or supply chain(s) and that they will take steps to address any grievances, instances or concerns which may arise throughout the contract and their supply chains generally.

#### **Risk Assessment**

Across the portfolio, each General Manager across our various business units (which includes our subsidiaries and related entities) reassessed its supplier geographical & contract value based risk identification process - which graded suppliers according to regions based upon the Global Slavery Index Walk Free Foundation Regional Prevalence & Vulnerability Data Index Matrix. Other factors were also taken into account including the sector and type of industry those suppliers operate within.

Adopting this process again enabled us to identify and consider risks that may possibly cause or contribute to modern slavery practices along with the type of industry and type of products and services being supplied. This assessment criteria enabled us to classify our suppliers as being at Minor through to Low, Moderate, High and Extreme Risk. The outcome of the assessment assisted with our prioritisation and implementation of our supplier engagement.

We continue to monitor the overall effectiveness of this assessment based approach against our current adopted processes and procedures in order to identify the modern slavery risks that our business may be exposed to. This is consistent with the UN Guiding Principles on Business & Human Rights. We continue to assess the effectiveness of our actions in identifying and managing modern slavery risks by engaging and working with our suppliers, undertake internal governance and awareness training and generally tracking and rating our actions. Monitoring these actions requires a system of continuous improvement by which we seek to strengthen and improve our awareness & responsiveness to modern slavery.





#### COVID-19

Despite global economies showing signs of recovery following the Covid-19 outbreak, industry disruption as well as disruption to supply lines generally remains prevalent. The risk and presence of Modern Slavery remains and we all must be vigilant and do out part to continue to build and work with our internal and external relationships whilst maximising the use of modern technology to find enhanced ways of engaging with our customers and suppliers when traditional methods are not always available.

This enables us to build and maintain better relationships whilst at the same time increasing the visibility of our suppliers. Our on-line dedicated learning hub and our nternal training & awareness remains at the core of our implementation strategy.

# **ONGOING REVIEW**

Our response to Covid-19 is on-going and is subject to further review & monitoring. Our Modern Slavery Policy will continue to be reviewed and updated where necessary. Any complaints brought to our attention will be investigated and further action taken, where deemed necessary. Our complaints handling, reporting processes and procedures will be reviewed together with our remediation protocols and will be amended or updated. Our e-training education is available on line at any time and has been updated to allow access to our employees globally.

This statement is a joint statement and has been prepared in accordance with s14(2) of the Modern Slavery Act 2018 (Cth). Our reporting entities are Nepean Building & Infrastructure ACN 125 224 302 and Nepean No.1 Pty Limited ACN 606 791 931, to which the respective Boards as the principal governing body of those reporting entities, has approved of this statement. All references throughout this statement to NEPEAN are references to the NEPEAN portfolio of companies, its subsidiaries and related entities. This statement does not cover any non-controlled joint venture operations. During the reporting period that this statement covers, NEPEAN engaged and consulted with all companies owned or controlled by it in relation to the development and creation of this statement. Details and information of the requirements of the Modern Slavery Act 2018 were discussed together with the identification of relevant future actions.
