In FY 2025, we will continue to enhance and refine our actions to ensure that, in partnership with our suppliers and providers, we continue to support the principles of the Act.

### **Entity and Ownership**

Altora Ag Holdco Pty Ltd (ABN 29 630 396 619) is the parent entity that wholly owns the following entities:

- Altora Ag Services Pty Ltd (ABN 82 630 396 468)
- Altora Ag Pty Ltd (ABN 35 003 514 421)
- Altora Ag DB Pty Ltd (ABN 25 614 043 873)

Altora Ag has operated since 1st February 2023, following the merger of BFB Pty Ltd and Daybreak Cropping Pty Ltd.

Over the past 12 months, the business has acquired over 20,000 hectares of additional land and expanded our Altora Ag Services Pty Ltd business to a new location in Ballarat, Victoria.




# **Our Operations**

Altora Ag is Australia's largest broadacre cropping agribusiness – with ~178,000 hectares across 15 locations encompassing 68 properties.

The business enhances its farming assets with integrated post-farmgate logistics operations, including grain trading, grain storage and handling with a 450,000 MT capacity, and merchandise services for approximately 100 external clients.

# Our Supply chains

The Agriculture sector operates in a complex and rapidly changing environment. Supply chains refer to the products and services (including labour) that contribute to Altora Ag's products and services.

Altora Ag sources the following primary goods and services:

- Production inputs include fertilisers, chemicals, seeds, and fuel.
- Logistics, including third-party logistics services, encompass road, rail, and ocean freight.
- Farming services from local contracting farmers for harvest and sowing seasons.
- Grain handling, vehicle operation and farming equipment.
- Plant and equipment maintenance services include consumables, chemicals and processing aids.
- Bunker consumables (tarpaulins, fumigants).
- Safety and personal protective equipment including clothing, footwear, and other safety consumables.
- Office-based support and equipment, Legal, Accounting and Consulting Services, IT Hardware and Software support, stationery and other miscellaneous services.



## **People Risks**

As a medium-sized employer in the agricultural sector, Altora Ag acknowledges that the industry relies heavily on workers with a limited understanding of English and may be less aware of their human and labour rights.

We are committed to employing workers who have freely consented to employment and are of legal age and status to work and undertake business with suppliers and contractors who share these values. Altora Ag employs or engages these workers through an approved third-party labour hire organisation.

All workers receive at least the minimum remuneration in line with Modern Awards or Enterprise Agreements registered with the Fair Work Commission. The centralised payroll team pays employees, and contractors receive payments via invoice according to their agreement terms.

We provide all staff and contractors with our Code of Conduct and Key Policies and Procedures, which outline the expected standards of behaviour for our directors, employees, contractors, and thirdparty workers.

Our work, health and safety management system supports the safety and health of our employees, contractors, and third-party labour.

Our HR team manages recruitment internally, ensuring compliance with all Fair Work laws, wage regulations, entitlements, and payroll protocols.

All contractors undertaking seasonal on-farm work complete prequalification questionnaires to meet WHSE compliance and advise of any breaches of labour law compliance. In addition, the organisation regularly monitors Fair Work matters to see if there are any concerns or issues from our suppliers.



## Supply Chain Risks



We recognise that the level of modern slavery risk in our operations and supply chains is influenced by a range of factors, including geographic, sector, and product-specific factors, and we incorporate these considerations into our risk assessment processes.

Altora Ag's scale and geographic spread of operations require an extensive network of suppliers across areas such as seed supply, fertilisers, and fuel.

Altora Ag has identified the following risks across our supply chains most notably;

- Use of unskilled, temporary, or foreign labour in their workforce, including a heightened risk of child or forced labour from raw materials sourced from overseas.
- Supply from regions with inadequate protections for workers and practices that do not support workplace standards or comply with national standards.

Overall, we have assessed the residual risk of modern slavery in this category as low to medium.

To ensure controls are in place to address these risks, Altora Ag has implemented a supplier code of conduct and a process for reviewing suppliers. Many of our major suppliers are large-scale businesses bound by legislative requirements to issue annual modern slavery statements outlining the risks in each area of their business operations and supply chains.

In addition, our new procurement policy strives to source resources responsibly and sustainably.

## Our effectiveness

In 2024, Altora Ag finalised its Supplier Code of Conduct and Procurement policy. These additions to our supplier governance support our already-in-place pre-qualification process for our contractors.

During the reporting period, we conducted a detailed review of the actions taken by our suppliers to combat the risk of modern slavery within their supply chains by evaluating their issued modern slavery statement.
