

MODERN SLAVERY STATEMENT 2020

This statement is made pursuant to the *Modern Slavery Act 2018 Australia* and sets out the steps we have taken to identify and mitigate risks to our business and supply chains from slavery and human trafficking during the 1 July 2019 – 30 June 2020 Financial Year.

1. Introduction

Midway is committed to preventing slavery and human trafficking in all its corporate activities and to ensuring that our supply chains are also free from such practices.

2. Midway structure, operations and supply chains

Midway is an Australian forestry company based in Geelong, Victoria, with majority shareholdings in South West Fibre Pty Ltd (SWF) based in the Green Triangle (South West Victoria), Queensland Commodity Exports Pty Ltd (QCE) based in Brisbane, Plantation Management Partners (PMP) based in the Tiwi Islands, Midway Tasmania based in Tasmania, and Midway Logistics based in Western Australia.

2.1 Structure:

Midway is manager for all the subsidiary companies described in Table 1 below and is either a majority shareholder or sole shareholder of those companies. Midway and subsidiary companies (referred to as Midway hereafter) employ 150 staff across Australia.

2.2 Operations:

Midway's core business is the production and marketing of woodfibre for supply to producers of pulp, paper and associated products in the Asian region. Woodfibre is primarily produced from plantation hardwood, which represents the majority of the Company's export sales, with the balance comprising woodfibre produced from plantation softwood logs and hardwood timber residues generated from the harvest of sawlogs from native hardwood forests. The Company has interests in three processing and export facilities in mainland Australia. Other segments include:

Plantation and land management

Midway currently manages plantations on freehold and leased land held predominantly in the Otway's, Upper Goulburn and Ballarat regions of Victoria. Through its subsidiary PMP, Midway currently manages plantations in northern Australia. Combined the group manages over 48,000 ha of plantation estate. The company owns significant areas of freehold land and manages plantation projects under a range of ownership arrangements. During the 1 July 2019 – 30 June 2020 Financial Year, PMP managed over 34,000 ha in Cambodia and the Laos PDR in South East Asia. We bring over 20 years' experience in softwood and hardwood plantation management and environmental management systems covering all stages from land selection, establishment, maintenance through to harvesting.

Logistics, harvest and haul

The procurement, processing, handling, marketing and export of woodfibre is a core component of Midway's business. Midway engages contractors to harvest and haul timber to processing sites, including the company-owned mills and to third party facilities. We operate in compliance with timber harvesting codes of practice in the states we operate in – Vic, SA, Qld, NT, NSW and Tasmania. Midway manages all aspects of harvesting for landowners' plantations, including permits and approvals, roading, harvesting and haulage.

We bring over 20 years' experience in softwood and hardwood plantation management covering all stages from land selection, establishment, maintenance through to harvesting.

2.3 Supply chains:

The majority of Midway's supply chain is woodfibre. All woodfibre is sourced from within Australia through one of the following supply arrangements:

- Harvest and haulage operations that Midway owns and operates. Labour is engaged directly by Midway.
- Harvest and haulage operations where Midway engages contractors and supervises the work. Contractors engage labour.
- Third party supply of wood delivered 'Mill Door' under contract from either state-owned or private entities. Suppliers or their contractors engage labour.
- Most of the woodfibre supply is certified under either or both the Forest Stewardship Council (FSC) or Responsible Wood (AS4708) standards.

The supply chain includes processed woodchips and may extend to either the departure port, or to the destination port for woodchip vessels. With Free-on-Board (FOB) woodchip shipments, Midway loads the vessel at the departure port, and the buyer arranges freight to the destination port. For Cost Insurance and Freight (CIF) shipments, Midway charters the vessel to the destination port. Other products and services provided to Midway include port services, fixed plant and equipment, mobile plant, consumables, seedlings, fertilisers, agricultural chemicals, office supplies, consulting services, fuels, electricity, and protective clothing. Risks of modern slavery practices

Table 3 below describes the risks of modern slavery practices in the operations and supply chains for Midway. Risks are assessed as low within operations conducted by Midway. These are conducted within Australia and South East Asia, subject to controls including external auditing and contractual requirements.

Certain areas of our supply chain may pose a higher labour rights risk due to their location and the nature of the goods and services procured. Our risk assessment is a combination of sector and industry risks, product and services risks, geographic risks, and entity risks.

4. Effectiveness of our controls

Midway has implemented a number of initiatives to track our progress against detecting and preventing modern slavery practices, including:

- Appointing the Midway sustainability committee to develop and review modern slavery policy, reporting protocols and controls.
- 2. Reporting breaches via the Midway Group incident reporting system.
- 3. Whistle-blower hotline.
- 4. Employee assistance program provides an anonymous counselling service available to all Midway employees.
- **5.** Quarterly review of strategic risk register includes review of risk ratings, controls and effectiveness of controls in reducing risk.
- **6.** Annual external forest certification audits include assessment of compliance with ILO conventions.

5. Consultation

Reporting entities within the Midway Group were consulted in relation to this statement and procedures to be adopted, which included discussions with business unit managers regarding risk assessment, and implementation of the framework.

6. Ongoing actions

- We will update contractual documentation to require counterparties comply with all such laws and policies in relation to the Australian Modern Slavery act 2018 (Cth).
- We will implement supplier self-declaration regarding modern slavery.
- We will introduce internal training on implementation of Midway's anti-slavery policy and processes for incident reporting.
