





## **MODERN SLAVERY RISK ASSESSMENT**

The consequences of the COVID-19 pandemic and corresponding 'two-speed' roll out of inoculations for developing nations and their vulnerable populations is profound.

According to the latest global estimates, 160m children are engaged in child labour, with a further 25m adults and children subjected to forced labour.

New analysis from International Labour Organization and UNICEF indicates that an additional 8.9m children will be in child labour by the end of 2022 as a result of rising poverty caused by the Coronavirus pandemic.

Key to our Modern Slavery Risk Assessment is a literature review that was undertaken to better understand supply chain risks for Delta Group, at home and abroad. The more we know of current (and changing) Modern Slavery risks the better we can communicate with and manage our predominantly domestic supply chains. ## **MODERN SLAVERY RISK ASSESSMENT**

Analysis of the 2020 List of Goods Produced by Child Labour or Forced Labour by the US Department of Labor indicates no material change has occurred to the global supply chain risks reported in our 2020 Modern Slavery Statement. Nonetheless, ongoing review of the (annual) publication focuses attention on the nature and scope of global Modern Slavery risks relevant to Delta Group operations.







#### CONSULTATION WITH CONTROLLED ENTITIES

In accordance with the Act, Executive and Senior Management from Delta Group and all related and controlled entities have been consulted in the preparation of our Joint Modern Slavery Statement 2021.

As previously, consultation took place by way of online (Microsoft Teams) meetings, email and telephone calls as a result of ongoing COVID-19 Public Health Orders and Border Restrictions.

A working group comprising key Executive Management over saw the production of this Joint Modern Slavery Statement prior to its approval by our Managing Director; in their capacity as Principal Governing Body under the Act.

#### TYPES OF MODERN SLAVERY

The most 'at risk' types of Modern Slavery that Delta Group may contribute to or could be directly linked with involve Forced Labour, (the worst forms of) Child Labour, Servitude and Trafficking In Persons.

We will continue to review and monitor the various types of Modern Slavery, particularly Debt Bondage and risks that may emerge as those most vulnerable to human rights violations, persecution, war or violence are exploited by sophisticated offshore criminal syndicates in conjunction with unscrupulous labour hire operators.

#### **FORCED LABOUR**

Situations where the victim is either not free to stop working or not free to leave their place of work.

#### **CHILD LABOUR**

Situations where children are exploited through slavery or similar practices, including for sexual exploitation; or engaged in hazardous work which may harm their health, safety or morals.

#### SERVITUDE

Situations where the victim's personal freedom is significantly restricted and they are not free to stop working or leave their place of work.

#### **TRAFFICKING IN PERSONS**

The recruitment, harbouring and movement of a person for exploitation through modern slavery.

#### **DEBT BONDAGE**

Situations where the victim's services are pledged as security for a debt and the debt is manifestly excessive or the victim's services are not applied to liquidate the debt, or the length and nature of the services are not limited and defined.

#### **SLAVERY**

Situations where the offender exercises powers of ownership over the victim, including the power to make a person an object of purchase and use their labour in an unrestricted way.

Situations where coercion, threats or deception are used to make a victim marry or where the victim does not understand or is incapable of understanding the nature and effect of the marriage ceremony. **MOST RISK**

With a national workforce in excess of 1,000 qualified, trained and experienced personnel spanning all States and Territories across mainland Australia, Delta Group remains fully compliant with Fair Work Australia's National Employment Standards or the Modern Award equivalent in each State or Territory where our salaried staff are located.

Where applicable, staff may be employed under registered Enterprise Bargaining Agreements that have been recognised by the Australian Building & Construction Commission and Fair Work Commission as compliant with the Building Code 2016.

In accordance with our statutory obligations, we maintain rigorous payroll and administrative processes to ensure all employee entitlements are current and up-to-date, including (but not limited to):

- Superannuation
- Long Service Leave
- Annual Leave
- Sick Leave
- Family & Domestic Violence Leave
- Personal & Carer's Leave

Similarly, Delta Group maintains strict Security of Payment policies and procedures in compliance with the Building Code 2016.

The risk that Delta Group, including all related entities, directly causes any type of Modern Slavery remains negligible.

#### DOMESTIC SUPPLY CHAIN RISK

Delta Group shares the same services and supply chains across all related entities and each reporting entity. We have developed and maintain robust prequalification processes and operating (project and/or site specific) policies to ensure complete regulatory and statutory compliance. All trade and non-trade suppliers, consultants and/or subcontractors must adhere to best practice governance and risk management protocols to achieve prequalified status, including (but not limited to):

As previously stated, the risk that Delta Group, including all related or controlled entities, directly causes any type of Modern Slavery as a result of our operations is negligible. Analysis of survey and audit findings also indicates strong awareness and understanding of the Modern Slavery Act 2018 and the statutory obligations that apply to upstream and downstream entities across the Australian building and construction sector. Given the nature and scope of our supply chains and client base, together with our past, current and future actions, the risk that Delta Group is directly linked to Modern Slavery has been rated as medium. However, risks that we contribute to Modern Slavery remain as Medium-High. Further interrogation of our domestic retail or wholesale supply chains and their potential links to high risk products manufactured in high risk countries is required to identify specific entity risks. At which point Delta Group - in collaboration with our domestic suppliers - can apply leverage to eliminate Modern Slavery risks in our business.

## **KEY ACTIONS**

Australia, by nature of its geographical location and diminished domestic manufacturing sector, is particularly exposed to Modern Slavery risks throughout global supply chains, particularly those of our major trading partners in China as well as South and South East Asia that have been associated with Forced and/or Child Labour practices.

As identified in our 2020 Joint Modern Slavery Statement, Delta Group has initiated a range of key actions designed to address Modern Slavery risks in our operations, including all related/controlled entities.

These actions will be complemented by those identified in this, our 2021 Joint Modern Slavery Statement. Namely:

- Understanding the level of exposure to Forced Labour risks in the manufacture of garments and electronics in China that may involve (documented) exploitation of Uyghur Muslims and other ethnic minorities.
- Investigating the likelihood that Delta Group contributes to or is directly linked with Child Labour risks in the mining of raw materials (cobalt) used in the manufacture of lithium ion batteries.
- Establishing relationships with qualified, trained and experienced third parties to develop an Ethical & Social Procurement Framework, including verified risk assessment and auditing protocols.

Audits identified in our 2020 Joint Modern Slavery Statement involved targeted self assessment questionnaires to determine if our initial (and inherent) risk assessment warrants further investigation and action. Where relevant, these additional actions are identified for attention in FY22. ## **KEY ACTIONS**

Combined, our literature review and self assessment questionnaires have helped determine the highest risk products or services from the highest risk sectors and industries in the highest risk countries. As a result, we are now better positioned to collaborate with our supply chain partners and to investigate if high risk entities exist in our respective operations.

#### **ETHICAL & SOCIAL PROCUREMENT FRAMEWORK:**

The development of a stronger, transparent and more effective Ethical & Social Procurement Framework is closely linked to our stated Governance & Policy commitments from 2020 and will enable Delta Group and all related or controlled entities to better manage Modern Slavery risks. Key actions for 2022 include (but are not limited to):

- Responsible Business Alliance Membership
- ISO 37301 Compliance Management System Development
- Prequalification Process Mapping (Ongoing)
- Contracts Review (Ongoing)
- Management Training & Staff Induction Program (Ongoing)

#### **HIGH RISK PRODUCT ASSESSMENTS**

Following our initial (inherent) 2020 risk assessment we have identified specific suppliers and manufacturers of Diamond Tipped Saw Cutters, Nails and Delta Group Uniforms & PPE. We will collaborate with our domestic retail and/or wholesale suppliers to understand what, if any, entity risk assessments need to be made. New products have been identified as a result of our literature review as well as COVID-19. We will explore if the supply of our Power Tools & Batteries and Face Masks involve Modern Slavery risks.

#### HIGH RISK GEOGRAPHIC ASSESSMENTS

Delta Group invests heavily in the procurement of IT&T Hardware such as servers, mobile phones, laptops, personal computers (desktop PCs) and monitors. Similarly, the application of LCD Technology is extensive and includes a wide variety of products across Delta Group operations. We will undertake due diligence of our existing (domestic) supply chains to understand what they and the manufacturers of key electronic components are doing to mitigate Modern Slavery risks attributed to the (mis) treatment and alleged exploitation of Uyghur Muslims and other ethnic minorities in China.

Our Staff Induction program was developed and is ongoing at the time of publication. All new staff are inducted to all Delta Group policies and, in particular, our obligations under the Modern Slavery Act 2018.

Our Management Training and Contracts Review are ongoing at the time of publication and we have engaged a qualified third party consultant to support the development of our proposed Ethical & Social Procurement Framework.

## TRACKING & MEASUREMENT

#### **SUPPLY CHAINS**

Mapping of our Prequalification Processes began and is ongoing at the time of publication, with further actions to be completed in 2022. 50% of our proposed supplier self assessment questionnaires were completed, including:

- Our domestic Labour Hire suppliers for the provision of Plant Operator, Site Labour, Traffic Management, Security and Cleaning services were assessed and found to comply with all statutory obligations under the Fair Work Act 2009, Building Code 2016 and/or the relevant State or Territory Modern Award.
- Our domestic partners for the sale and recycling of scrap steel were assessed, with all partners confirming their compliance with the Modern Slavery Act 2018 as reporting entities (under the Act).
- Our domestic supply chains for rubber products also involved enterprises that were reporting entities under (and compliant with) the Act.
- Final assessment of our supply chains for the procurement of Uniforms & PPE, Nails and Diamond Tipped Saw Cutters were ongoing at the time of publication.



#### MONITORING

The engagement of a qualified third party consultant will support ongoing work to develop internal audit protocols, as well as support our assessment of qualified external auditing systems and controls such as those provided by the Responsible Business Alliance and/or ISO 37301 Compliance Management System certification, as identified previously.

Internal policies were also developed to ensure we maintain preferred supplier relationships for high risk products such as bricks, timber, tea and coffee. Wherever possible we will preference 'Australian Made' products or ensure that (offshore) products are recognised by third party accreditation schemes such as the Rainforest Alliance and UTZ Certification.
