#### ABOUT THIS STATEMENT

The Modern Slavery Act 2018 (Cth) (the Act) requires entities with an annual consolidated revenue of over a \$100 million that are either classed as an Australian entity or a foreign entity carrying out business in Australia during the reporting period, to prepare and publish an annual Modern Slavery Statement (Statement).

This Statement has been prepared pursuant to Section 14 of the Act, by Tetra Tech Coffey Holding Pty Limited (Tetra Tech Coffey, we, us) on behalf of the reporting the following reporting entities:

This Statement covers the financial year ending September 2021 and sets out the process taken by Tetra Tech Coffey to identify, assess and address the risks of modern slavery in our operations and supply chains.

#### STATEMENT APPROVAL

This Statement for financial year 2021 is made pursuant to section 14 of the Modern Slavery Act 2018 (Cth) and constitutes Tetra Tech Coffey Holdings' Modern Slavery Statement.

The Statement was approved by the board of Tetra Tech Coffey Holding Pty Ltd, on behalf of the listed reporting entities on 7 April 2022. This statement be reviewed and updated it as necessary, annually.

#### INTRODUCTION

Tetra Tech Coffey Holding Pty Limited (Tetra Tech Coffey Holding) is a wholly owned subsidiary of Tetra Tech, Inc., a NASDAQ-listed company with a global workforce of 21,000 staff working across 120 countries.

Tetra Tech Coffey Holding provides consulting services in the areas of geotechnics, environment, engineering, project management, and international development.

Tetra Tech Coffey Holding's international development business (Tetra Tech International Development Pty Ltd (Tetra Tech International Development)) provides substantially different services to the rest of the businesses of Tetra Tech Coffey Holding and it has a separate management team and structure which reports directly to Tetra Tech, Inc.

Accordingly, Tetra Tech International Development Pty Ltd is submitting its own Modern Slavery Statement. This Modern Slavery Statement does not address Tetra Tech International Development's business unless expressly stated.

The statement has been provided on behalf of Tetra Tech Coffey Holding Pty Limited. Where reference is made to Tetra Tech Coffey Holding, this reference includes all of the listed Tetra Tech entities including Tetra Tech International Development. Where reference is made to Tetra Tech Coffey, this reference excludes Tetra Tech International Development.

It is the policy of Tetra Tech Coffey to proactively identify and manage the environmental, social and economic impacts within our supply chain, and as identified by our key stakeholders and our business.

Tetra Tech Coffey is committed to:

- Setting objectives and action plans in support of this statement and pursuing improvement of our practices.
- Prioritising business with suppliers who have embedded sustainable and ethical practices within their organisation and who drive such practices within their own supply chain.
- Complying with applicable legislation.

This statement will be circulated throughout Tetra Tech Coffey and is available for public review. It will be reviewed on a regular basis to evaluate relevance, monitor compliance and drive improvement.

Established in Australia in 1959, Tetra Tech Coffey Holding is a trusted expert in the provision of geotechnical, environmental, engineering, project management, and international development services.

Tetra Tech Coffey has over 750 staff based across the abovementioned office locations.

#### **OUR WORKFORCE**

Tetra Tech Coffey's workforce comprises 95 casual, 110 part time and 580 permanent staff.

Most of our workers are qualified and/or experienced professionals in the fields in which we offer services. Our workforce also includes administrative and support staff who assist in the operation of our business.

#### **OUR SUPPLIERS**

Tetra Tech Coffey's owned or controlled entities have common suppliers.


Tetra Tech Coffey's top ten supplier categories account for over 81% of our spend for the reporting period.

The majority of our supply chain is also located within Australia and New Zealand with relatively few suppliers located in other countries. The locations of our supply chain are also shown graphically in Figure 1.




Figure 2: Top ten supplier types for Tetra Tech Coffey 2021 financial year spend.

Our top ten supplier types are represented in Figure 2 and include real estate, Tetra Tech sister companies, consulting services, drilling, laboratory services, combined field and laboratory testing services, recruitment, finance services including tax and auditing and telecommunications.

#### RISK ASSESSMENT

#### **OPERATIONS**

Tetra Tech Coffey employs over 750 staff across Australia, New Zealand and Papua New Guinea (PNG). Most of our employees are employed on a full-time basis, with proportionally fewer part time and casual employees.

Most of our staff are professionals with university qualifications and/or industry experience. We also employ administrative staff to support our operations.

Most of our employees are employed in Australia or New Zealand with a small team in PNG. Work completed outside Australia, New Zealand or PNG is undertaken by our employees who are mobilised to those sites.

Staff are screened prior to employment for their right to work and age to ensure their suitability for employment.

Staff remuneration is based on industry standards and acquired benchmarking data for similar industry groups.

For these reasons, we consider that the combined operational modern slavery risk for Tetra Tech Coffey is low.

COVID-19 impacted our operations due to wide spreads infections in some of the areas in which we operate, region or state-based lockdowns and restrictions of movement. We supported our staff through these periods by providing information regarding the COVID-19 controls to be implemented in line with our company developed COVID-safe plans. We encouraged our staff to be vaccinated. We allowed time for our staff to attend vaccination centres for this purpose. We allowed time for our staff to attend testing centres to confirm their COVID-19 status if identified as a close contact or exhibiting symptoms in line with local regulatory requirements. We allowed our staff time to recover from vaccination injections or from infection, as required. When workloads reduced, we implemented alternate working arrangements with the aim of retention of head count.

#### **SUPPLY CHAIN**

Our suppliers have supply chains that may have risks of modern slavery over which we have limited visibility. Our screening of our supply chain has identified that the highest potential for exposure to modern slavery exists in:

- The manufacture and supply of uniforms and personal protective equipment.
- Cleaning services.
- IT supply of hardware or software supply and support services.
- Traffic management.
- Labour hire providers, particularly in high risk jurisdictions;
- Hotels, restaurants and leisure.
- Road and rail transportation.
- Security.

Most of our suppliers are based in Australia and New Zealand, which are low risk jurisdictions for modern slavery. Where we conduct work outside those countries, we use the same controls for supplier prequalification.

We understand that our suppliers located in Australia and New Zealand may be supplying goods or services that originate from higher risk jurisdictions. To assist us to understand this, and other, less visible modern slavery risk factors in our supply chain, we issued modern slavery questionnaires (MSQ) via an on-line hosted survey platform. The survey was issued to our more significant suppliers that provided goods and/or services to us during the 2021 reporting year. This assisted us to understand the potential risk of modern slavery in our supply chain and we use this information to initiate discussions with higher risk suppliers.

MSQs were issued on behalf of Tetra Tech Coffey to a selection of our suppliers that provided service to our organisation during the 2020/21 financial year. This supplier list was selected with reference to:

- Major suppliers by total spend.
- Suppliers we interacted with on repeated occasions (frequently used suppliers) but where the total spend was relatively low.

 Suppliers who conduct activities that are considered to represent a higher risk for potential exposure to modern slavery.

In undertaking the MSQ process, we adopted a risk-based approach in line with the United Nations Guiding Principles on Business and Human Rights.

COVID-19 also caused disruption for suppliers to our business. We supported our suppliers by continuing, as far as possible, with contracted work and timely payment of invoices. We also requested that our suppliers include COVID-19 safe protocols in their project documentation to ensure, as far as reasonably practicable, the protection of their workers.

## SUMMARY OF SUPPLY CHAIN SCREENING RESULTS

The top five countries where our suppliers have business operations are:

- Australia.
- New Zealand.
- Papa New Guinea.
- The United States of America.
- Canada.




Figure 3: Average supplier risk score

Tetra Tech Coffey suppliers were sent a Modern Slavery Questionnaire. The average modern slavery risk rating based on the responses was 4 out of 10 (refer Figure 3), resulting in an overall low risk average.




Figure 4: Supplier human rights impact assessment completion

Compared to the 2019/2020 questionnaire responses a slightly higher proportion of suppliers have conducted a human rights impact assessment for their operations. The proportion of suppliers that have undertaken a human rights impact assessment is shown in Figure 4. Performance in the current reporting period has improved slightly.

Most of the suppliers who responded also confirmed that they have in place, and agree to maintain at all times, adequate policies, controls, procedures and training designed to: prevent, detect, assess, manage and remedy modern slavery in their operations and supply chains.




Figure 5: Supplier policy, control and procedure implementation




Figure 6: Supplier risk rating summary

A breakdown of the risk ratings of those who completed the MSQ presented in Figure 6.

The MSQ process has brought to our attention the suppliers with whom we need to engage for further due diligence in our second reporting period.

#### SUPPLIER ENGAGEMENT

We understand that each of our suppliers also have their own supply chains, which may expose us to modern slavery risk. Beyond the information collected as part of the MSQ, we currently have limited visibility of this risk. We will work with our suppliers to better understand the risk within their supply chain and their management controls, focusing on our highest risk suppliers.

Education of our staff, in field supervision and observation of our field-based suppliers, ongoing communication with our suppliers with more knowledge of the situation and our risks will assist us in the identification of possible modern slavery risks

# TETRA TECH INTERNATIONAL DEVELOPMENT OPERATIONS

Tetra Tech International Development has operations in countries that are considered to have a higher inherent risk of modern slavery, such as Fiji, Indonesia, PNG, Tonga, Cambodia, and the Philippines.

Tetra Tech International Development's exposure to modern slavery risk is largely indirect and predominantly associated with the level of expenditure into reported high-risk industries rather than evidenced on their direct interaction with modern slavery practices.

Further details regarding the risks in the operations of Tetra Tech International Development can be found in their modern slavery statement.

#### **OUR ACTIONS**

Tetra Tech Coffey will continue to use the results of our supply chain screening activities, in conjunction with supplier survey feedback received to date, to set out tangible actions for assessing, managing and reducing modern slavery risks in our supply chain.

#### **OUR OPERATIONS**

The risk of modern slavery within our workforce is considered low due to the candidate review methodologies we adopt, the employee contracts we execute, the remuneration processes and reviews we apply being based on benchmarked data from similar service industries and the modern slavery training we offer to our staff.

We have developed a modern slavery policy that informs our staff of our expectations in relation to the identification, reporting, management and control of modern slavery risks within our operations.

We maintain a whistle-blower policy that includes modern slavery concerns as listed areas of protected disclosure whereby our staff can report concerns without fear of reprisal.

We require our staff to complete modern slavery awareness training. This internally developed training program educates our staff about the presence and prevalence of modern slavery in the areas in which we operate and explains the process we adopt to minimise the risk of modern slavery in our operations and projects.

We have developed a diversity, equity and inclusion policy that sets our approach and commitment to a diverse, equitable and inclusive workplace for all employees and contractors. Our goal is to provide an inclusive and productive working environment in which our workers are treated fairly, with respect and dignity and that we seek to understand, embrace, and nurture our unique qualities and collective differences.

We will monitor the performance of our modern slavery screening processes and develop and implement improvements where warranted. We will continue to collaborate with other Tetra Tech businesses within our region to align our processes and allow the identification of improvement possibilities across businesses.

#### **OUR SUPPLY CHAIN**

As outlined above, our due diligence in preparation of this statement has included issuing questionnaires to a selected subset of our suppliers. Their answers enable us to better understand their approach to the identification and management of modern slavery risks within their operations and supply chain. In future years, suppliers will be screened at nominated intervals based on their risk profile.

We have developed a supplier code of conduct and will request that our suppliers acknowledge their acceptance of it and agree to abide by its requirements.

We will re-assess suppliers who pose a high risk or high potential exposure to modern slavery to:

- Determine if their service is critical to our business and whether an alternate and lower risk supplier may be engaged.
- Assist them in modifying their exposure and/or control measures to reduce their level of risk.
- Monitor their performance to ensure risks are appropriately controlled.

For critical suppliers identified as high risk, we will work with those suppliers to understand the origin of the risk of modern slavery in their work and offer support to educate their staff regarding modern slavery risk and to assist in the identification and implementation of suitable controls to reduce the exposure risk.

#### **PROCUREMENT**

Our procurement procedures include the following requirements, specifically in relation to assessment of risks related to modern slavery:

- Initial screening of suppliers based on the geographic location of their service offering and the type of service being offered to exclude those whose risk is likely to be low. This will allow effort to be focused effectively on those areas and supplier relationships that are posing the highest risk.
- Screening of selected existing and potential new suppliers for their compliance with the Act, via the online MSQ survey.
- Ongoing reassessment of suppliers to monitor for the effectiveness of our system and approach.
- A requirement for our suppliers to commit to abiding by our supplier code of conduct or have in place a suitable alternate.
- Commercial terms that include specific reference to obligations in respect to the Modern Slavery Act. Where these terms cannot be agreed, as a minimum, the supplier must be screened and commit to our supplier code of conduct.
- Providing support for critical, high risk suppliers, identified based on results of the supplier screening process to assist in the reduction of modern slavery risks.
- Ongoing internal audit of our operations to confirm adherence to the approved processes.

# ASSESSING EFFECTIVENESS

#### ONGOING PROCESS OF REVIEW

We will continue to work with and screen our suppliers for modern slavery risks. Our process will include the analysis of the MSQ results year-on-year to identify patterns, emergent risks and priorities for further due diligence.

We will evaluate the MSQ responses for high risk suppliers to determine root causes. Where their involvement on a project is necessary or critical, we will work with them to educate them and their staff about the risk of modern slavery and to help in the identification and implementation of suitable controls to minimise the exposure risk.

We will seek to assess the effectiveness of our actions by tracking:

- The number and percentage of our staff who have attended the required awareness and procedure based training.
- The number and percentage of suppliers who have been screened.
- The number and percentage of suppliers who have accepted our code of conduct or implemented their own similar terms.
- The outcomes of the screening process and the number and percentage of suppliers determined as being low, medium or high risk.
- The results of internal audits conducted to check for our own compliance with requirements.
- The changes in MSQ responses and summary data over time for suppliers or supplier types.
- Whistle-blower reports/complaints relating to modern slavery risks or potential breaches of our policy of supplier code of conduct.
- The investigations and outcomes of investigations of potential or reported breaches.

#### **CONSULTATION PROCESS**

Tetra Tech Coffey has worked with the Tetra Tech companies in our region to understand and learn from their approach to the identification and management of modern slavery risks and to provide consistency of approach within the companies over which we have control.

We also sought input from Tetra Tech International Development, which is a subsidiary of Tetra Tech Coffey Holding, and has developed its own modern slavery statement.

We consulted with Norman Disney Young, a Tetra Tech Company, that developed its own modern slavery statement.

We consulted with and received input and review from Eco Logical Australia, which is a subsidiary of Tetra Tech Coffey Holding, whose activities are included in this modern slavery statement.

Each of the Tetra Tech Coffey companies provided input to the development of this modern slavery statement prior to its approval and submission.
