#### 1 GROUP OVERVIEW

#### **Primary Function**

The Pharmacy Guild of Australia (PGOA) is registered under the *Fair Work Registered Organisations Act 2009* (RO Act) to provide industrial relations advice and support to pharmacy businesses in Australia. # 3 ASSESSMENT OF MODERN SLAVERY RISKS INCLUDING DUE DILIGENCE AND REMEDIATION

The Pharmacy Guild of Australia tracks the risk of Modern Slavery via its risk management frameworks. These frameworks are reviewed on an ongoing basis and are reported to National Council, the relevant Branch Committee or company board, as applicable.

Guild Group Holdings Limited tracks its Modern Slavery Risk via its established Risk Management framework, which is reported to the GGHL Board once each quarter.

Mechanisms to minimise the risk of Modern Slavery include:

- completion of a Modern Slavery questionnaire as part of the Key Supplier selection process,
- completion a Modern Slavery questionnaire on an annual basis to assess the ongoing risks of Modern Slavery, and
- for Key Suppliers who have been rated "likely" and above for Modern Slavery risk:
  - Vendor Managers work with key suppliers to check how they are progressing and any actions they have put in place to address Modern Slavery risks,
  - they are required to complete the Modern Slavery questionnaire on a half yearly basis and
  - half-yearly attestations are obtained from the relevant GM where that GM wishes to continue use of the supplier.

Guild Solutions Inc (GSI), a wholly owned subsidiary of Guild Group Holdings Ltd and incorporated in the Philippines, takes the following steps to lower the risk of modern slavery in its Philippines operations:

- GSI staff receive salary and benefits which exceed government mandated minimum standards
- GSI staff use a clock-in / clock-out system in line with local HR requirements to ensure worked hours can be monitored and overtime paid

#### 4 MODERN SLAVERY RISKS AND MITIGATIONS

For the year ending 30 June 2022, no 'likely' modern slavery risk was identified inside The Pharmacy Guild of Australia supply chain.

This statement was approved by the National Council of The Pharmacy Guild of Australia (principal governing body) on 1 December 2022.


