Summary

The Labelmakers Group companies have monitored our direct labour recruitment, deployment, utilization, and remuneration practices in Australia, including in New Zealand, and found to be in full compliance with local and international labour laws and prevention of modern slavery as per the Australia Modern Slavery Act 2018.

Labelmakers continued to source 85% of its cost of supplied materials and services from reputable international businesses with their own monitoring and compliance practices to international labour laws and audited 35 of its major suppliers to be complying with preventing modern slavery.

The company will be monitoring the effectiveness of its Anti-Slavery and Ethical Sourcing Policy as per section 6.0 in this report to achieve its stated KPIs.

The Company maintained its membership to Sedex (being the world's leading ethical trade membership organisation working with businesses to improve working conditions in global supply chains). During this reporting period the company's labour protection, OHS, environmental and ethical practices were audited as per, ETI (Ethical Trading Initiative Code - founded on the conventions of the International Labour Organisation (ILO) and being an internationally recognised code of labour practice), Social Accountability (SA8000), ISO14001 and industry specific codes of conduct and found to be complying in protecting its workers' rights and maintaining its ethical sourcing practices.

1.0 The Company

Labelmakers Group design, print and manufacture self-adhesive labels, shrink sleeves, other forms of labels and cartons for the major food, grocery, beverage and home care companies in Australia and New Zealand.

The Company believes that sustainability starts with our value system and a principles-based approach to doing business. By incorporating the Principles of the UN Global Compact and the Commonwealth of Australia Modern Slavery Act 2018 into our strategies, policies, and procedures, we are committed to ensure compliance with the labour rights standards, legislation and statutory requirements in our supply chain processes and to act ethically upholding our basic responsibilities to people and planet and setting the stage for long-term success.

Labelmakers support and respect the protection of internationally proclaimed human rights and prohibit all forms of forced child and compulsory labour.

We seek to engage with suppliers who are in accord and share our core values. Suppliers must agree to Labelmakers Group Ethical Standard of Business and Responsible Sourcing policy and be in compliant. We evaluate and monitor suppliers' operations over a number of areas and require of them to cooperate and provide records for compliance.

2.0 Labelmakers Companies Mandatory Reporting and Declaration

During the reporting period of this statement, we have actively engaged, consulted with, and monitored the entities we own or control in the development of this statement, including:

We have provided training and distributed our policy for ethical sourcing and prevention of Modern Slavery to all divisions and as per the Modern Slavery Act 2018 reporting requirements.

3.0 Suppliers Approval Process

We acknowledge that there are potential risks of modern slavery in our supply chain processes as the result of their geographical location and the source of materials used in our products. Labelmakers have a Supplier Approval Process and the Ethical Standard of Business and Responsible Sourcing policies that we execute at the initial approval phase of contracting a new supplier. We subsequently monitor Suppliers' performance through the risk assessment process to ensure their compliance to our Ethical Standard of Business and Responsible Sourcing policy. We also acknowledge that, we lack full visibility in certain overseas markets, and this may carry additional risks of modern slavery, especially in secondary levels of our chain of suppliers and materials sourced for the Group.

4.0 Labelmakers Group Companies Sourcing Structure

Labelmakers Procurement Management Team at its Head Office, purchase the major materials used in the manufacturing of its products, or its subsidiary companies will buy directly but through the suppliers approved by the Group. 85 percent of the total cost of direct materials for the Group are sourced through reputable suppliers including Paper, Ink, Film, Cardboard, Adhesive manufacturers, and also for its machinery parts and components.

The company also purchase its support services and utilities from local and reputable sources with very low risk of Modern Slavery implications.

5.0 Our Commitment to Anti Modern Slavery Practices

During the last number of years, the company has joined **Sedex**, world's leading ethical trade membership organisation, working with the members organisations, to improve working conditions in global supply chains and has participated in **Sedex Members Ethical Trade Independent Audits (SMETA)** to comply with:

- Standard Business Ethics
- Labour Standards
- Health and Safety Regulations
- Structured Management Systems, Responsibility and Accountability
- Environmental Control Measure

During this reporting period, we have implemented the Suppliers' Compliance and Risk Assessment and Rating procedure as part of our Group Anti Modern Slavery Policy and done the first-tier audit of about 35 suppliers.



6.0 Effectiveness of Labelmakers' Anti-Slavery and Ethical Sourcing Policy

The assessment of our actions to identify and address our modern slavery risks in our operations and across our supply chain is ongoing and evolving process that we are committed to continue and to build on. Whilst as indicated 85% of all our supplies are procured through known and reputable sources with their own policy for prevention of modern slavery, Labelmakers has set the following goals to achieve:

- A. Ensure Labelmakers Group Ethical Standard of Business and Responsible Sourcing policy is part of the supplier approval system and included in all contractual agreements.
- B. Formally assess up to 50% of our supplier for compliance in 2022 2023.
- C. Formally achieve another 25% supplier assessment in 2023 -2024.
- D. Achieve 100% supplier assessment by 2025.
- E. Continue Labelmakers' Group of companies' memberships with Sedex and participate in SMETA compliance audits as indicated in **5.0** above.

We will continue to measure and assess the effectiveness of our actions across key performance areas for our own and within our supply chain:

- Commitment and responsibility to prohibit Modern Slavery labour practices
- Level of commitment to monitor and assess outcomes against set targets for staff awareness and education
- Maintaining and meeting business responsibilities for safety, environment and reporting any noncompliance

7.0 Labelmakers Slavery Prevention Policy

Labelmakers Group acknowledges its responsibility within the Modern Slavery Act 2018 (Australia) to mitigate any form of Modern Slavery and to introduce a plan of action to:

- Educate staff on what modern slavery may encompass including; slavery, servitude, human trafficking, child and forced labour.
- Promote to staff the importance of raising any concerns they may have and protecting those who may raise issues found about modern slavery within our supply chain.
- Scope the risks, their classification by product or the origin of supply sources
 and prioritising action plans focused on preventive practices.
- Extend our understanding of modern slavery risks across our first-tier suppliers through supplier audits and risk assessments by the company or by a third-party certification body.
- Engage suppliers, recognising the required actions that must be implemented and carry out due diligence for identifying risks and remediation processes in collaboration with our supply chain partners.
- Regularly assess the effectiveness of our business strategy and actions towards this policy.
- Provide the annual statement and information considered relevant in compliance with the Act.

The above are implemented aligned with our Ethical Sourcing Policy, Code of Conduct, and the company's other policies related to the safety and wellbeing of our staff, contractors and suppliers of goods and services.

8.0 Suppliers' Compliance and Risk Assessment and Rating

Labelmakers has started and assessed in choosing its Suppliers with consideration to potential social and environmental risks. The first part is in consideration to variety of factors including Supplier country of supply, industry specific risks, Supplier history and the Supplier's compliance management systems. Based on the initial screening for Low, Medium, or High level of risk for compliance one of the following methods has been and continue to be utilised to assess Suppliers' commitment:

- Low Risk To sign a Supplier Declaration Statement (attachment 1)
- Medium Risk Suppliers with this designation may be required to either complete a desktop audit or a site-based audit based on the results of the Supplier Self-Assessment Questionnaire (attachment 2).
- High Risk: Suppliers who are designated as higher risk will be required to complete a 2nd or 3rd party Responsible Sourcing audit (i.e. join as a member to Sedex and complete 3rd party SMETA audits).
