1. About this Statement

Introduction

ForHealth is pleased to release its 2025 Modern Slavery Statement (**Statement**) for the period 1 July 2024 to 30 June 2025 (**Relevant Period** or **FY25**) in accordance with the *Modern Slavery Act (Cth) 2018* (the **Act**). It is our fifth Modern Slavery Statement.

As noted in the Global Slavery Index 2023, 'Modern Slavery is hidden in plain sight and is deeply intertwined with life in every corner of the world, with more than an estimated 50 million people around the world living in situations of Modern Slavery on any given day in 2021.¹

Our ongoing commitment to identify, assess, manage and mitigate our modern slavery risks has been overseen by the ForHealth Modern Slavery Committee, our Risk Committee and ultimately our Board.

We are committed to contibuting to the elimination of modern slavery.

4. Our business, structure, operations & supply chains





(a) Our business

In FY25, ForHealth has experienced growth via acquisitions and continued to expand its Urgent Care, Evoca, Logic Health, Health & Co, Equality and Skin2 businesses.

During FY25 ForHealth operated 35+ Federal and State Government funded urgent care clinics (**UCCs**) around Australia, with more to be planned by the end of FY26. Through these UCCs, we are partnering with relevant governments, Primary Health Networks, communities and public hospitals to help reduce pressure on Australia's public hospital system. UCCs play a vital role in caring for urgent care patients, which in turn, protects our hospital system from overcrowding. They provide the community with the treatment they need quickly for an illness or injury that is not deemed an 'emergency' but is 'urgent', without having to wait long periods in emergency departments and is bulk billed for anyone with a Medicare card.

At the end of FY25, ForHealth employs approximately 2,947 staff nationally (inclusive of full time, part-time and casual staff). We provide facilities and services to more than 1,090 independent General Practitioners (**GPs**), 201 independent dentists and 160 allied health practitioners who operate their own businesses from within our over 100 large multiservices medical centres and 61 dental centres and who provide health services of more than 6.4 million patient visits and to approximately 1.4 million individual patients each year. Our 161 large multi-service medical and dental centres include more than 50 outer metro / regional sites. ForHealth also supports more than 330 GPs across our 35+ UCCs nationally.

ForHealth sites operate as a single point of primary care for the community. This includes independent GPs, nursing treatment rooms, chronic disease facilities, pathology, extensive imaging capabilities, medical specialists, independent allied practitioners, dental services, pharmacies and where applicable UCCs. We also focus on sub-specialty care such as women's health, skin, occupational health, refugee support, Aboriginal and Torres Strait Islander support, LGBTQA+ health, immigration and mental health.

Our mission is **high quality, accessible healthcare for all Australians**. We believe that accessible healthcare is one of the best things about our country and we are proud to be a leader in this field.

(b) Our operations

Medical Centres

ForHealth provides facilities and services to independent healthcare professionals (including GPs) (HCPs) who operate their own businesses from within our various large multi-service medical and dental centres. The facilities and services we provide to independent HCPs include the provision of premises, facilities management, nurses, reception staff, practice managers, practice management software, administrative and financial services, IT support, cleaning, waste removal, maintenance and provision of medical consumables.


ForHealth also supports the operation of imaging, pathology collection, pharmacy and physiotherapy services within many medical centres by offering facilities via lease or licence agreements to these providers.

Urgent Care


As noted above, in FY25 ForHealth operated 35+ urgent care facilities around Australia, working with both Federal and State Governments to reduce pressure on emergency departments by allowing the redirection of category 4 and 5 injuries to our urgent care treatment rooms. ForHealth is the largest Urgent Care provider in Australia and in FY25 provided services to ~370,000 patient visits.

ForHealth leverages its large-scale medical centres, treatment rooms, reception areas and network of GPs to provide this new healthcare delivery model. Patients are able to access Urgent Care services via self-referral or walk-in, appointment or referrals via other health services (including emergency departments at nearby hospitals) and clinicians. Upon arrival, patients are triaged by nursing staff and assessed for eligibility of treatment by the Urgent Care service. Patients are then treated in order of assessed clinical urgency.




Our Queensland operations






Our NSW operations







Our Victorian operations





Our WA, SA and ACT operations










Primary Dental

ForHealth operates 61 dental facilities primarily co-located in its medical centres and provides facilities and services to over 201 independent dentists, who in turn service our communities and their patients.

Logic Health is committed to providing the very best occupational healthcare, delivered by highly trained, skilled and experienced practitioners, working under strong corporate and clinical governance providing for high quality and safe care.

Allied Health

ForHealth also provides facilities and services to more than 160 allied health professionals across 65 locations within Australia who provide their patients with allied health services. Such services include physiotherapy, podiatry, dietetics, diabetes management, counselling, chiropractic, osteopathy, optometry, psychology and more.

Immigration medicals

ForHealth also operates immigration medical service clinics for the Department of Immigration, as a subcontractor to BUPA. In areas where BUPA does not physically have BUPA, BUPA subcontracts to other primary health service providers, such as ForHealth.

Evoca

Evoca delivers accessible and holistic healthcare to women of all ages and stages of life. It comprises a group of independent GPs who specialise in, and are passionate about, women's healthcare. Its goal is to ensure women feel heard and their health symptoms are validated and addressed with compassion and understanding in a sympathetic setting.

Evoca launched its first site in Epping, Victoria in December 2022. Just 3 years later there are over 40 clinics and over 110 women's health GPs operating under the Evoca brand nationally. It is the first national network of women's health GPs. Evoca provides GPs with an opportunity to develop portfolio-type work and supports GPs and their patients with a multidisciplinary team of women's health professionals including physios, dieticians, nurses and specialists.



Skin2

Skin2 is a GP-led service dedicated to the diagnosis and treatment of skin cancer. Having completed extra training and accruing experience in this field, all of the GPs operating within the Skin2 brand are passionate about offering premium skin cancer care and treatment for their patients with a focus on early detection, treatment and prevention to deliver positive clinical outcomes. All Skin2 facilities are state-of-the-art, and patients benefit from the best possible service and outcomes. Skin2 launched its first site in Highett, Victoria in August 2018. Today there are ~49 clinics and 78 GPs operating under the Skin2 brand nationally.



Equality Health

Equality Health delivers inclusive, culturally sensitive care that celebrates the uniqueness of every individual. It is represented by a group of GPs who are passionate about addressing the disparities in healthcare within the LGBTIQA+ communities. It aims to close the gap and provide a single point of contact for all general medicine, sexual health and mental health needs for the LGBTIQA+ community.

Equality Health launched its first site in NSW in September 2024. There are 8 clinics nationally supported by 12 GPs. An additional 3 clinics are expected to be launched by the end of 2025.



(c) Our Supply Chain

ForHealth sources various healthcare-related products and services, as well as usual business-related products and services and draws from both domestic and international suppliers. Our supply chain is comprised of the following product / service categories and remains largely unchanged from what was reported in our FY24 Modern Slavery Statement.

Our supply chain continues to be comprised of the following groups of goods and services:

General Medical

 includes all medical consumables e.g. masks, gloves, needles, bandages etc

General Dental & Laboratory services

 includes all dental consumables and dental equipment, imaging, manufacturing of crowns and bridges

General Procurement

 includes cotton uniforms, coffee, travel management, printers, phones etc

Corporate Services

 includes stationary, training, accreditation services, marketing, desks

IT Products & Services

 includes all software and hardware components, equipment & services

Facilities Management

 includes cleaners, waste removal, HVACs, fridges, beds and general maintenance trades and associated products

Utilities

 includes gas, water, electricity and solar

Construction Services

 includes all construction, renovation and relevant trade services

Professional Services

 includes marketing, auditing and accounts payable services, legal, tax and other consulting services

5. Risks - FY25 Assessment of Modern Slavery risks

(a) Assessing & identifying key risks in our supply chain

When considering modern slavery risk in our supply chain, ForHealth takes a '<u>risk-based</u> <u>influence</u>' approach to ensure resources are directed to suppliers that have a higher modern slavery risk profile and who we also have most influence over. For example, we are unlikely to be able to influence where Apple or Microsoft procures its components from, but may have more influence over our medical consumables, dental consumables or local cleaning suppliers.

During FY25, our Modern Slavery Committee continued to map the Group's supply chain and identify potential risks of modern slavery by evaluating each first-tier supplier and class of product/service against a risk matrix. Our Modern Slavery Risk Matrix (see **Annexure A**) has been updated for the Relevant Period.

During FY25, the following products/services were identified by ForHealth as high-risk categories.

Areas of risk, ForHealth has some influence over

Procurement of Medical & Dental Consumables

including from China, Malaysia and Thailand Sourcing of Rubber Gloves

including from Malaysia Sourcing of Cotton uniforms

including cotton from China, India and Bangladesh Cleaners of Centres

from Australia

Areas of risk, ForHealth has limited influence over

Procurement of Coffee

including from Brazil and Colombia Procurement of IT hardware and software

including from China, Indonesia, India

6. Actions - FY25 actions taken to mitigate Modern Slavery Risks

During FY25, we conducted the following actions to address the risks identified as part of our risk assessment.

(a) Commenced review of 2nd tier suppliers of Medical Consumables

During FY25, ForHealth worked closely with Team Medical who supplies most of our medical & dental consumables to conduct a deep dive into our 2nd tier supply chains of these products.

Team Medical have implemented Ethixbase 360 platform, which has enabled a detailed modern slavery risk analysis of its suppliers. Ethixbase 360 is a software tool designed to assess risk, demonstrate compliance and allows an assessment of modern slavery risks and risk monitoring across a large supplier base.

Through Ethixbase 360, in FY25 Team Medical issued modern slavery questionnaires to all of its top suppliers (our 2nd tier suppliers) to assess the modern slavery risk.


In FY25

- 155 Team Medical suppliers received a Modern Slavery questionnaire via Ethixbase 360;
- 69% of those suppliers completed the questionnaire;115 ForHealth 2nd tier suppliers either completed a Modern Slavery questionnaire or are in the process of doing so.

Once questionnaires are complete, Ethixbase 360 provides a risk assessment taking into account the following risk items with the following weightings:

- Activity 30% weighting
- Human rights 15% weighting
- Workforce –15% weighting
- Jurisdiction 30% weighting
- Policies and systems risk 10% weighting.

<u>Team Medical's suppliers (ForHealth's 2nd tier suppliers) of medical consumables</u> are spread across the world



Through our workings with Team Medical:

- we did not identify that any of ForHealth's 2nd tier suppliers (through Team Medical) obtained goods or services from the Xinjiang Uyghur Autonomous Region;
- fourteen (14) of our 2nd tier suppliers were identified with a high-risk rating of (8+); and
- three (3) of our 2nd tier suppliers received a risk alert.

In FY26, ForHealth will continue to engage with Team Medical to identify, manage and where possible mitigate ForHealth's modern slavery risks associated with our 2nd tier suppliers of medical consumables.





(b) Supporting our cleaning providers

As noted in our FY24 Modern Slavery Statement, in FY24 we conducted a deep dive into our suppliers of cleaning services by sending modern slavery questionnaires designed to assist us in identifying modern slavery risks.

In FY25, we engaged each of these suppliers to determine how ForHealth could support them in managing their modern slavery risks and reduce any gaps they have.

Through this engagement, we supported these suppliers with their governance and processes. From this, we can confirm that each of these suppliers:

- now has a modern slavery policy in place dealing with modern slavery risks;
- now has either automated time and attendance systems or other robust procedures (e.g. audit procedures or thorough pre-employment checks) to ensure that salary payments are award compliant; and
- is open to issuing supplier questionnaires modelled on ForHealth's own supplier questionnaires to all their own suppliers to map out our 2nd tier suppliers.

To assist these suppliers further, we issued to each supplier a copy of ForHealth's:

- supplier questionnaire issued to all suppliers generally designed to identify and assess general modern slavery other risks of a supplier from any industry.
- deep dive questionnaire for cleaning suppliers designed to understand modern slavery risks of cleaning suppliers specifically with queries geared towards identifying the types of modern slavery that occur in the cleaning industry e.g. underpayment of wages, child labour, lack of grievance procedures etc; and
- modern slavery risk matrix included in Annexure A of this document.

We will continue to assist our cleaning providers to further develop questionnaires, processes or strategies to support them manage their own modern slavery risks and map out their supplier chains.

(c) <u>Updated training from FY24 survey learnings & Remediation Plan</u>

As was noted in our FY24 Modern Slavery Statement, in FY24 ForHealth conducted internal surveys to better understand the effectiveness of its modern slavery training (**Effectiveness Survey**) and also developed its Modern Slavery Remediation Plan to deal with incidents of modern slavery when identified.

In FY25, ForHealth redesigned and relaunched its modern slavery training to take into account feedback from the Effectiveness Survey and incorporated training on our Modern Slavery Remediation Plan.

Specifically, the training was transformed from an informative tool to a framework that allows ForHealth's staff to identify, assess, mitigate and remediate modern slavery risks within ForHealth's own supply chain. The training includes interactive videos to allow understanding of its prevalence, the applicable legislation that governs it and ForHealth's own approach to mitigating modern slavery.

The Effectiveness Survey indicated staff required more practical guidance on ways to identify modern slavery. Based on this, new sections were added that specifically detailed staff's role in identifying modern slavery at each level of the organisation, for example by receptionists, practice managers, the procurement team, department managers and leaders.

7. Effectiveness – Assessment of effectiveness of FY25 actions

ForHealth is committed to continuing to evolve and strengthen its response and strategies toward mitigating and, where possible, eliminating modern slavery risks in its supply chain. We assess our effectiveness of our risk reduction actions in FY25 as follows:

- **Modern Slavery training effectiveness:** see section 6(c) for details of our updated training. All staff are requested to complete the updated training as part of induction and then annually.
- **Procurement process compliance**: In FY25, our Modern Slavery Committee continued to ensure compliance with our procurement and onboarding processes including reviewing and assessing high-risk suppliers.
- Modern Slavery Hotline: The Committee continues to consider whistleblower and/or modern slavery instances. No reports were received during FY25 through the external / third party managed whistle-blower or our Modern Slavery hotline.
- FY25 Actions: We can confirm that in FY25:
 - we commenced analysing our 2nd tier supply chain of medical consumables;
 - we supported our cleaner suppliers to mitigate gaps in their modern slavery governance and process;
 - we redesigned our modern slavery training with learnings from our Effectiveness Survey conducted in FY24, including adding training on our Remediation Plan and providing a framework to allow ForHealth's staff to identify, assess, mitigate and remediate modern slavery risks.

8. Next Steps and forward commitments

9. Consultation between Owned & Joint Reporting Entities

All ForHealth Group entities are wholly owned subsidiaries of Limestone Holdco Pty Ltd ACN 639 416 667. Further, all ForHealth entities have largely common directors and company secretaries and from a supply chain perspective they operate as one common entity.

The Modern Slavery Committee is responsible for consulting with all ForHealth Group entities. For the Relevant Period, the membership of the Modern Slavery Committee was Melinda Harrison, General Counsel, Saheba Kaur, Senior Legal Counsel and Tamim Rahman, Senior Legal Counsel. The Modern Slavery Committee consulted with all entities within the Group.

When determining high risk suppliers, the Modern Slavery Committee considered suppliers of each Group entity and ranked them according to the Modern Slavery Matrix set out in **Annexure A**. Accordingly, modern slavery risks have been appropriately identified, assessed and addressed and each entity has been consulted and is aware of their required actions.

10. Board Approval

This Statement has been prepared by the Modern Slavery Committee in accordance with section 14 of the Modern Slavery Act 2018 (Cth) in consultation with each of the ForHealth Group subsidiaries and has been reviewed and approved by Board of Directors of Limestone Holdco Pty Ltd on 6 November 2025.
