

MODERN SLAVERY STATEMENT

For the reporting period 1 July 2023 to 30 June 2024



Introduction

The Tesseract Group considers ethical labour practices and human rights to be a top priority and we are committed to treating everyone who works at or with Tesseract with dignity and respect.

As an organisation, we strive to improve the ethical standards both within our business and in our supply chain by working in partnership with our suppliers to minimise the risk of modern slavery.



The Group's Organisational Structure

This Statement is made on behalf of Thales CPS Australia Pty Ltd (formerly Tesseract Limited) (ABN 13 605 672 928) (referred to as 'Tesseract', 'the Company', 'we', 'us' or 'our') which is a reporting entity under the Modern Slavery Act 2018 (Cth) ('the Act'). This Statement was prepared in accordance with the Act and describes the steps that Tesseract has taken during the financial year 2024 (FY24) to identify, assess and address the risks of modern slavery in our business and supply chains and our assessment of the effectiveness of these steps.

From 5 October 2023, Tesseract is a subsidiary of Thales Australia Holdings Pty Limited (ACN 058 583 841) ('Parent Company'). The Parent Company is ultimately owned by Thales SA, which is a French société anonyme (joint-stock company), identified with number 552 059 024. Tesseract is the only entity of the Parent Company covered by this Statement. Other entities of the Parent Company either do not meet the reporting criteria under the Act, or will produce their own statement.

Whilst not covered by this statement as they do not meet the reporting requirements, the actions taken to mitigate the risk of modern slavery detailed in this Statement were applicable to the following Tesseract subsidiaries in FY24 as a result of common internal rules, processes and procedures:

During the reporting period 1 July 2022 to 30 June 2023, Tesseract was an Australian domiciled entity which was listed on the Australian Stock Exchange (ASX: TNT). On 13 June 2023, Tesseract announced that it had entered into a Scheme Implementation Deed (SID) with Thales Australia Holdings Pty Ltd (Thales Australia), a wholly owned subsidiary of Thales under which it was proposed that Thales Australia will acquire 100% of the share capital in Tesseract. On 22 September 2023, the Federal Court of Australia approved the SID and on 4 October 2023, Tesseract Limited was acquired by Thales Australia.



KEY SUPPLY CHAINS

Tesseract's supply chain consists of goods and services that support our cyber security and cloud services. As a professional services focused organisation our primary expenditure within the reporting period was in the remuneration for our Australian and New Zealand based team members. Secondary expenditure that provides the infrastructure, facilities and other support required to enable the delivery of our services exist in the following key categories:

- IT technology (Software and Hardware);
- Telecommunications (Carriage Services and Facilities);
- Business Premises and Facilities;
- External Professional Services; and
- Travel and Administration.

The goods and services that Tesseract procure are predominantly sourced from suppliers based in Australia.

Risk Assessment and Management

GOVERNANCE AND POLICY

Tesseract is committed to operating in an ethical and legally compliant manner and has in place a robust governance framework to support this commitment. Tesseract has developed and issued policies and procedures that support and promote this approach including:

- Modern Slavery Policy,
- Privacy Policy,
- Equity & Diversity Policy,
- Environment Best Practice Policy, and
- Corporate Social Responsibility Policy.

In the first reporting period (1 July 2021 to 30 June 2022), the Company established an internal Modern Slavery Working Group to identify and assess modern slavery risks in the supply chain, develop policies to better manage modern slavery risks within the supply chain, and promote awareness of modern slavery to the broader business and staff. The internal Modern Slavery Working Group undertook a mapping exercise of its suppliers to identify its supply chain categories and made an initial assessment of potential exposure to modern slavery risks.

As a result of the work undertaken in the first reporting period, during the FY23 reporting period the following actions were taken by the Company to assist it to identify and manage modern slavery risks in the supply chain:

- the Company implemented a change to its Master Service Agreement to include contractual obligations aimed at modern slavery identification and prevention, on both the supplier and on Tesseract;
- the Company made available its Modern Slavery Statement on the Company's website; and
- the Company continued to identify and assess modern slavery risks in Tesseract's supply chain through researching third party contractors to provide services to its clients.


During this reporting period, Tesseract:

- implemented a Modern Slavery Policy;
- 67% of employees and contractors completed training to educate the workforce on identifying and eliminating any risks of occurrence of modern slavery;
- conducted training of employees and contractors to assist in identifying and eliminating any risks of occurrence of modern slavery;
- made available its Modern Slavery Statement on the Company's website;
- continued to utilise the revised Master Service Agreement which includes contractual obligations aimed at modern slavery identification and prevention on both the supplier and on Tesseract; and
- continued to identify and assess modern slavery risks in Tesseract's supply chain through researching third party contractors to provide services to its clients.

All contractors to, and employees of, the Company are expected to comply with the Company's Modern Slavery Policy, which:

- describes the many forms that modern slavery can take, and the indicators of modern slavery;
- sets out the responsibilities of the employee / contractor to identify and eliminate risks of occurrence of modern slavery; and
- explains to the employee / contractor what steps they should take if they suspect that modern slavery may be occurring.

DUE DILIGENCE, SUPPLIER ASSESSMENTS AND SUPPLIER MANAGEMENT




As a primarily professional services focused organisation with 98% of our workers employed or contracted in either Australia or New Zealand, Tesseract's operations are generally considered to be low risk of slavery or human trafficking practices.



Our employees are subject to the relevant Australian or New Zealand labour laws including the *Australian Fair Work Act 2009 (Cth)* or the New Zealand Employment Relations Act 2000.



Tesseract has small operations outside of the Australia and New Zealand region primarily limited to professional consulting services. These are considered low risk of modern slavery practices due to the high-skill, highly educated level of our employees.



Accordingly, as the major operational expenses involve the employment or engagement of staff in our offices in Australia or New Zealand to deliver high-skilled professional services, Tesseract has assessed the risk of modern slavery in its main operations as low.



SUPPLIER PROFILES

Tesseract recognises that some of its expenditure is directed towards suppliers that source goods and services from outside Australia, including some geographies that have a higher modern slavery risk profile. In accordance with the mapping exercise undertaken in relation to our tier 1 supply chain in the first reporting period, the following supply chain categories were identified along with an initial assessment of their relative exposure to modern slavery risks:

Supply Chain Category	Modern Slavery Risk Exposure
IT Technology <i>(Software and Hardware)</i>	Electrical goods and software development are recognised as high-risk industries globally. We procure from leading, globally recognised suppliers through their operations in Australia who have mature measures to reduce modern slavery risks in their supply chains, including independent auditing and public reporting of key measures and KPIs. Our assessment of these providers indicates they are taking adequate steps to identify and manage modern slavery risks.
Telecommunications <i>(Carriage Services and Facilities)</i>	These services and facilities are sourced from Tier-1 licenced telecommunications providers based in Australia or New Zealand that have their own modern slavery policies and procedures in place. Considered low risk.
Business Premises and Facilities <i>(Rental, cleaning, and environmental management)</i>	Cleaning and maintenance services are recognised as high-risk services globally. Tesseract typically uses the cleaning services provided by the building management at each of our Australian and New Zealand offices. Tesseract continues to monitor this part of its supply chain to identify and manage any modern slavery risks.
External Professional Services <i>(Legal, Accounting, Taxation, Insurance and Marketing)</i>	Considered low risk. Sourced from Australian and New Zealand based high-skilled professionals.
Travel and Administration <i>(Staff Travel and Staff Amenities)</i>	Considered low risk. Nearly all travel occurs either domestically within Australia or New Zealand on recognised major carriers.


The initial assessment of Tesseract’s supply chain and its potential exposure to modern slavery risks has not changed since the first reporting period.

The acquisition of Tesseract’s shares by Thales Australia has not lead to material changes in Tesseract’s supply chains and operations, and has not altered the initial assessment.

SUPPLIER ASSESSMENTS

During this reporting period (and previous reporting periods), Tesseract conducted research on its suppliers to identify and assess modern slavery risks which may be specific to individual suppliers.

As a result of the supplier mapping process that was undertaken in the first reporting period, Tesseract commenced planning for the implementation of a supplier assessment and modern slavery risk screening process for all new and existing suppliers. The purpose of this supplier assessment process will prioritise screening of suppliers with relatively high exposure to modern slavery risks based on the categories identified through the high-level mapping exercise. Further work is continuing to be done to finalise these processes.



During the FY23 reporting period, it also introduced new contractual obligations in its Master Service Agreement aimed at assisting it to identify modern slavery offences and encourage compliance with modern slavery laws, which has been maintained during this reporting period.

Tesserent is also planning to improve upon its existing systems and procedures by implementing a supplier code of conduct to describe the minimum expectations of Tesserent's suppliers in the areas of integrity, ethics and conduct, conflict of interest, health and safety, and labour and human rights – which will include the elimination of any modern slavery practices.

As outlined above, Tesserent implemented a Modern Slavery Policy in this reporting period, and contractors and employees are expected to comply with that policy.

OUR PEOPLE

Tesserent is an equal opportunity employer and recognises that people are our greatest investment and asset. We are committed to providing a working environment across all levels of our business that fosters fairness, respect, and equal access to opportunities regardless of individual differences.

Therefore, Tesserent is committed to diversity that incorporates all characteristics that make individuals unique from each other, these include (without limitation) factors such as race, religion, age, family status, ethnicity, gender, and disability. We recognise the benefits of diversity in the workplace and that it is essential in supporting our strong corporate performance.

Tesserent people and culture team works with the leadership team and everyone within the organisation to form a complete picture of their current capabilities and ambitions, map out their development opportunities and provide them with personalised training and development pathways.

Tesserent considers the continued skill development and therefore empowerment of the industry workforce as a significant contributing factor towards minimising the risk of modern slavery and human trafficking.

During this reporting period, Tesserent has implemented enhanced training packages for its staff which include further awareness and education about modern slavery practices.

Assessing the Effectiveness of Our Controls

Tesserent published its first Modern Slavery Statement for the period 1 July 2021 to 30 June 2022. Several of the actions set out in that statement were newly introduced during that first reporting period and our aim was to monitor and improve upon our processes and actions during subsequent reporting periods. The initial risk assessment and high-level supplier mapping we undertook in the FY22 reporting period provided a baseline to enable us to assess the effectiveness of our actions in future periods as we continue to improve and mature our processes.

Whilst Tesserent has assessed its potential exposure to modern slavery risks as low, it acknowledges that it is not immune and it is committed to implementing and improving upon its processes to identify and eliminate modern slavery practices within its business and supply chain. Integrating contractual terms about modern slavery into our agreements with suppliers is one of the actions that was taken by Tesserent during the FY23 reporting period and maintained during this reporting period. Enhanced training packages for our staff which incorporate modern slavery awareness and education were developed during the FY23 reporting period and commenced in this reporting period, in addition to the implementation of the Modern Slavery Policy.

The overall percentage of contractors and employees undertaking the training package was 67% and we look to improve on this percentage to 100% as we assess the effectiveness of our actions.

These actions were newly introduced, we will be building indicators in future years, as part of the assessment of effectiveness.

Next Steps

Tesserent is committed to continuously improving the ethical standards within its business and in its supply chain. In FY25, we plan to:

- maintain and continue to implement a Modern Slavery Policy within our business;
- further educate our staff on modern slavery and train staff to screen for modern slavery risks by maintaining modern slavery training in our broader employee training program, to ensure that any risks or issues can be eliminated and/or remediated; and,
- promote continuous dialogue and information sharing between Tesserent and our suppliers by reviewing and improving the contractual provisions in our supplier agreements relating to modern slavery risks to encourage compliance with modern slavery laws.

Consultation and Approval

The Statement was developed with contributions from a working group made up of representatives from the human resources, legal, risk and compliance team, which met regularly during the statement preparation process to discuss the requirements of the Modern Slavery Act 2018.


