1. Entity Structure & Operations

Bestbar Pty Ltd is a private company that is 100% owned by Rokeby Nominees Pty Ltd.

Bestbar sources locally manufactured and imported reinforcement steel as a raw material that it then converts into finished goods that are sold by to end-users in the building and construction industries.

Bestbar also sources locally manufactured and imported sundry components to support the primary product range.

Bestbar has operations in Western Australia, Northern Territory, South Australia, Victoria and New South Wales.

Bestbar employs approximately 485 people across 9 factories all located in Australia. Bestbar has no operations or associated entities offshore.

Bestbar (Vic) Pty Ltd and Bestbar (NSW) Pty Ltd are wholly owned by Bestbar Pty Ltd and come under the group procurement controls of the primary company so are subject to the controls below.



1.3 Distribution & Factories

Bestbar Factories and distribution sites are located within 5 different states and territory:

Western Australia, South Australia, Victoria, New South Wales & Northern Territory.





Bestbar's sourcing of raw material is primarily direct from manufacturers but can also be through the manufacturer's representatives and distributors.

Imported products are typically delivered on a CIF basis utilising the shipping services contracted with our suppliers and / or the agents.

All procurement is centralised to ensure adherence to company policy and corporate governance requirements.

Purchases are only allowed from previously approved and accredited suppliers. This also includes suppliers of services and consumables for the day-to-day operational requirements.

Finished goods are delivered using locally owned and operated transport providers.

2.1 Good and Services Origin

Bestbar purchases various goods and services from local, domestic, and international suppliers. The table below defines Bestbar main expense categories.

3. Risk Analysis

Bestbar acknowledges present risks of modern slavery in some of their supply chains and operations. The factors discovered are both the geographical location of some suppliers, and the source of materials used in products supplied to Bestbar.

Labors risk in some geographic location like Turkey where some of our steel (Raw Material) come from can be at risks of modern slavery.

Bestbar also acknowledges the possible lack of visibility in certain overseas suppliers to carries additional risks of modern slavery especially Toer 2 and 3 of the supply chain.

3.1 Countries of Origin's Risk

Bestbar identified the different risks relying on the country of origin of our Tier 1 suppliers, as well as Tier 2 and 3 when known. Bestbar understands the different characteristics that form the Modern Slavery risks and applied this knowledge to the below assessment.

Bestbar identified the risks of each country considering key information such as: poor governance, inequality, lack of basic needs and disenfranchised groups.

The table below defines Bestbar's countries of purchase.

4. Supply Chain Risk Management

At Bestbar Pty Ltd prior to entering into any supply arrangements with our partners we conduct a detailed review of their capabilities and business status.

Potential suppliers are required to provide us with details of their compliance in the following areas:

- Business insurance coverage
- Environmental
- Health and Safety
- Quality Accreditation

Potential suppliers are also required to agree to our supplier code of conduct which covers the following critical items:

- Supplier Expectations
- Integrity ethics and conduct
- Conflict of interest; gifts, benefits, and hospitality
- Audits and assessments
- Labor and Human Rights
- Health and Safety

An agreement to the supplier code of conduct is also a condition on every purchase order made by Bestbar Pty Ltd which is accepted by suppliers.

A specific questionnaire covering Modern Slavery requirements as covered by the act is also required to be completed and kept on file.

4.1 Supplier's modern slavery statements and open book policy.

Additionally to the automatic screening of the prospectives suppliers from Bestbar supply chain team, there is a research and review of the suppliers' Modern slavery statement if they submitted one.

This steps helps Bestbar to confidently understand the entities deeper impact on the supply chain by going into more details into the Tier 2 and Tier 3 suppliers.

Furthermore, Bestbar requests its Offshore resources suppliers to apply an open book policy. This initiative assure that Bestbar, by contracting this suppliers, is positively impacting the supplier's workers and providing them with a safe and fair work environment with an above pay rate, to afford them a comfortable and opportunistic life.

4.2 Policies & Employees training

Bestbar endeavors to communicate and demonstrate its values through policies and codes of conduct.

These documents are aimed at our suppliers and easily accessible to all the employees.

To raise awareness and educate the employees the company created mandatory training in line with the below policies. These training courses are renewable on a yearly to 2 yearly basis and are periodically reviewed by our National Training team.

Additionally, the modern slavery module provides information about modern slavery act requirements, awareness on what modern slavery is and what needs to be done to preventive effects of modern slavery infiltrating the organizations operation.

5. Effectiveness of the actions & Future steps

Bestbar can measure then compare from year to year the effectiveness of this actions and how with the suppliers it can contribute to abolish potential modern slavery in the supply chain.

Bestbar also created, reviewed and/or updated the following documents :

- Offshore Recruitment Policy

- Modern slavery induction now required to be done by all employees

Bestbar will continue to take actions and tracking its outcomes by undertaking regular internal report and striving to improve the following point by the end of our FY 2025 :

- Open Book Policy extended to our long-term supplier in the Offshore resource services
- Creation of a remediation process
- Finalisation of Bestbar the Sustainability statement
- Conduct of a modern slavery remediation gap analysis
- Review of our Suppliers accreditation form by an external auditor
- Improvement of our supplier accreditation form and requirements and Process
