Modern Slavery Statement Primaplas Pty Ltd Financial year 2023-2024

Introductory Statement

Modern slavery is the severe exploitation of persons denying them of their liberty and dignity. It is a serious problem for millions of people around the world, including many in developed countries, who are being kept and exploited in various forms of slavery.

Primaplas Pty Ltd rejects any form of modern slavery and is committed to preventing slavery and human trafficking in our operations and supply chain. This statement sets out the actions that Primaplas Pty Ltd has taken to understand all potential modern slavery risks related to our business, and to implement steps to prevent slavery and human trafficking.

Structure, Operations, and Supply Chain

Primaplas Pty Ltd is a leading distributor of polymer resins and films. Primaplas' head office is in Sydney, with an office in Melbourne.

Primaplas connects polymer resin and film manufacturers with converters, and provides complete logistics services. Primaplas distributes a wide range of polymer resin and film manufactured all over the world, from regions including Southeast Asia, Northeast Asia, the United States, and Europe. Primaplas engages third parties for warehousing and transport.

At Primaplas, we take great pride in our operations and fair treatment of not only our staff but also other stakeholders. We establish a relationship of trust and integrity with all our suppliers. Our supplier selection and on-boarding procedure includes due diligence of the supplier's reputation, jurisdiction, compliance with health, safety and environmental standards, and references. Our due diligence process also includes regular visits to the suppliers and other stakeholders.

Risks of modern slavery

Primaplas uses several factors to assess the potential risk of modern slavery in our supply chain:

- geographic location
- types of operations, goods and/or services that they provide
- sector
- associated supply chain involved

The risk of modern slavery within Primaplas' own operations is considered low. Primaplas' areas of higher risk are base skilled labour in secondary levels of our supply chain in higher risk geographies as ranked by the 2018 Global Slavery Index. Primaplas' risk assessment did not highlight any areas of significant concern of modern slavery in our supply chain. We acknowledge that the limited visibility in secondary supply chains in overseas geographies, such as the providers of cleaning, transport, and manual labour services to our direct supply chain present higher potential risks of modern slavery.

Assessing and addressing modern slavery risks

Human rights policy

Primaplas has implemented a Human Rights policy which rejects any form of slavery in our supply chain, including but not limited to forced, bonded, or child labour. Primaplas will engage with our suppliers to ensure that they operate in a manner consistent with our human rights values and standards.

Supply chain and supplier engagement

Primaplas acknowledges that our supply chain is complex and that to eradicate any risk of modern slavery in our supply chain, Primaplas must work with our suppliers and partners. Primaplas has ongoing discussions with business partners and suppliers on their operations and procedures.

Supplier Code of Conduct

Primaplas has a Supplier Code of Conduct which sets out our expectations relating to human rights and labour, business ethics, environment, and workplace health and safety.

Awareness and training

Primaplas provides awareness training to our staff on the risks of modern slavery. Education and awareness of potential risks of modern slavery will enable our staff to raise any concerns of the existence of modern slavery in our supply chain.

Due diligence

Primaplas conducts evaluations of all new suppliers before they become business partners, and reviews existing suppliers regularly. Activities to evaluate suppliers include:

- Assessing risks in the provision of goods and/or services
- Assessing the supplier's risk based on country's rank on 2018 Global Slavery index
- Performing in-person visits of suppliers to review working conditions of employees
- Regularly checking references from various sources about the supplier
- Engaging with the supplier on their supply chain
- Requiring suppliers to complete a modern slavery questionnaire for those considered of concern or higher risk

Assessing the effectiveness of our actions

Primaplas recognises that the review and assessment of the potential risk of modern slavery in our supply chain is an ongoing process. As we improve our understanding of the risks in our supply chain, we will improve our processes, policies, and procedures. Primaplas will continue to monitor and assess the effectiveness of our actions:

- Engaging and working with our suppliers to evaluate their supply chains and risks of modern slavery
- Reviewing our policies and procedures, such as our Supplier Code of Conduct to ensure they remain relevant
- Monitoring reports of concerns of the existence of modern slavery
- Reviewing our training and awareness to ensure that it is up to date

This Modern Slavery Statement was prepared in consultation with the relevant companies owned or controlled by Primaplas Pty Ltd.
