#### Introduction

RIMEX Supply, a Canadian-owned company specializing in the design, manufacturing, repair, and retail of wheels and rims, operates globally through a number of subsidiary companies including RIMEX Wheel in Australia. This report is prepared to meet compliance requirements of the Australian Modern Slavery Act 2018 and provides transparency regarding RIMEX's structure, operations, and supply chains.

## Entity Structure, Operations, and Supply Chains

### Organizational Structure

RIMEX Supply owns and operates four manufacturing plants in Canada and China where most of our products are manufactured which are then sent onto our distribution networks which are primarily based in countries associated with the mining industry such as Canada, USA and Australia.

### Operations

RIMEX focuses on producing high-quality wheels and rims for industries such as mining, construction, and transportation. The company leverages advanced manufacturing techniques and strict quality control measures across all operations which plays a key role in manufacturing and distribution within the Asia-Pacific region.

### Supply Chains

RIMEX's supply chains encompass raw material sourcing, manufacturing processes, and finished goods distribution. Key suppliers are concentrated in regions such as North America, Asia, Australia, and China, each selected based on ethical standards and compliance to modern slavery legislation.

#### Supplier Engagement and Due Diligence

RIMEX has and will continue to engage suppliers through comprehensive questionnaires covering labor practices, risk mitigation strategies, and adherence to ethical standards.

#### Internal Consultation

Internal reviews were conducted, gathering data from departments such as procurement and human resources to identify and address risks.

### Policy Implementation

RIMEX implemented a robust anti-modern slavery policy across its operations, ensuring compliance with Commonwealth of Australia legislative requirements.

#### Effectiveness of Actions

The company uses the following metrics to assess the effectiveness of its actions:

- · Supplier compliance rates based on questionnaire results.
- Feedback mechanisms between subsidiaries and suppliers.
- Reduction in identified risks over time.
