- Monthly truck maintenance

Potential modern slavery risks within operations and supply chains

Risk that Hong Australia Corporation Pty Ltd May Cause:

We also work to increase employee awareness by providing regular updates and safety training. All employees are recruited through a fair and transparent process, which includes verifying working hours, ensuring legal rights to work in Australia, and aligning with current regulations. Feedback from all employees is encouraged and welcomed.

Risk that Hong Australia Corporation Pty Ltd May Contribute To:

There is always the possibility that we may unintentionally contribute to risks due to a lack of awareness or knowledge about certain situations or conditions. Hong Australia Corporation Pty Ltd maintains direct communication with the majority of our customers, suppliers, and manufacturers to mitigate this risk.

Risk that Hong Australia Corporation Pty Ltd May Be Directly Linked To:

There is a risk that our operations and products may be connected to modern slavery through our business relationships, particularly with our suppliers. Through our due diligence processes, we have identified key risk areas, including:

- **Industry and Sector Risks:** Activities related to the harvesting of raw materials.
- **Geographic Risks:** Working with suppliers or manufacturers from low- and middle-income countries where modern slavery risks may be higher.

By addressing these risks and maintaining vigilance in our operations, we strive to uphold ethical standards throughout our supply chain.

Action taken to assess and address potential modern slavery risks

Assessing Risk:

1. Review Existing Information:

Continuously examine current data, reports, and relevant documents to identify and understand modern slavery risks within the organisation and supply chain.

Hong Australia Corporation also consulted with a cross-functional working group comprising employees responsible for the oversight of procurement, legal, and risk processes across the business. 1. Reviewing and Developing the Content of Questionnaires:

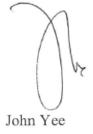
- Purpose: To ensure that the questionnaires used to assess suppliers and partners are relevant and aligned with current food safety industry standards.
