

MODERN SLAVERY STATEMENT 2021

Introduction

This statement covers all activities of the Victoria Amateur Turf Club (incorporating the Melbourne Racing Club), and its related entities (in this statement, defined together as the "Melbourne Racing Club"), to understand and implement actions to minimise the risk of modern slavery in its operations and supply chain.

This is the second modern slavery statement prepared by the Melbourne Racing Club in accordance with the *Modern Slavery Act 2018* (Cth) (the "Act"), and applies to its financial year ending 30 June 2021.

The Melbourne Racing Club understands that modern slavery can occur in many forms, as defined by the Act. This can include slavery, human trafficking, forced marriage, forced labor, debt bondage, child labor and deceptive recruiting for labour or services.

The Melbourne Racing Club does not tolerate modern slavery in any form in its operations and supply chains, and is responsible for being alert to such risks.

Our Business

The Melbourne Racing Club, with its beginnings dating back to 1875, is a not-for-profit members' club with in excess of 15,000 racing members. The Melbourne Racing Club conducts over 70 thoroughbred race meetings annually across three racetracks in greater Melbourne - Caulfield, Mornington, and Ladbrokes Park (Sandown).

In addition to horse racing, the Melbourne Racing Club also holds functions and events of all sizes across its venues that include lifestyle and leisure shows, music and food festivals, trade shows and motorsport racing.

The Melbourne Racing Club also has interests in property development, through the Caulfield Village development and planned masterplan projects at Caulfield.

The Melbourne Racing Club controls the Pegasus Leisure Group, which operates a portfolio of hotel and club venues located across greater Melbourne.

Lastly, the MRC Foundation, established in 2014, is the Melbourne Racing Club's philanthropic arm. The MRC Foundation assists a diverse range of groups and organisations, particularly those within the local areas of the Melbourne Racing Club's racecourses, Pegasus Leisure Venues and participants within the racing industry. The MRC Foundation engages the Melbourne Racing Club's customers and the wider Victorian community in generating charitable funds and other in-kind support in order to support people and causes in need.

About 2,000 staff, including 300 permanent staff, are employed by the Melbourne Racing Club, peaking at approximately 2,500 during spring carnival.

All operations of the Melbourne Racing Club take place in Victoria. Australia.

Our Structure, Operations & Supply Chains

Throughout the reporting period, the reporting entity, Victoria Amateur Turf Club (incorporating the Melbourne Racing Club) ("the VATC") operated its various business arms as set out below pursuant to a group organisational structure including its key subsidiaries, being Melbourne Racing Club F&B Limited, MRC Investments Pty Ltd, Yadnum Pty Ltd, MRC Foundation Limited and via a joint venture with Country Racing Victoria Limited, Thoroughbred Gaming Group Pty Ltd.

The table on the next page sets out the key operations of the Melbourne Racing Club's businesses and its associated major supply chains.

- Supply of merchandise approx. 10 suppliers
- Horticultural suppliers for the maintaining of racetracks, including labour- approx. 15 suppliers
- IT services and office consumables approx. 35 suppliers



- Management of 13 hotel and club venues (as of 30 June 2021)
- Providing gaming services as well as food and beverage offering at each venue
- Food and beverage suppliers (which operate in industries including agriculture, meat processing, viticulture) approx. 50 suppliers.
- Operational requirements including regular servicing of equipment as well as repairs and maintenance requirements – over 30 suppliers.
- Supply of general operational goods over 40 suppliers.
- Services provided by external companies including gaming, security, waste removal, cleaning and external advisors approx. 20 suppliers.



Collaborative Approach

As referred to previously, VATC is the only entity within the Melbourne Racing Club group required to produce a modern slavery statement pursuant to the Act.

However, the VATC and its subsidiaries share common committee members, boards and executives across the Melbourne Racing Club. In addition, there are several shared services departments across the Melbourne Racing Club that work between all entities, including but not limited to procurement, legal, risk and finance.

Therefore, while VATC is the reporting entity under this statement, all companies the VATC owns or controls were consulted during the assessment undertaken and preparation of this statement, and this statement applies to modern slavery risks in respect of the entire supply chain and operations of the Melbourne Racing Club as a whole.

Potential Risks of Modern Slavery

Melbourne Racing Club has assessed and understood its key areas of expenditure within its supply chain across all areas of its business to identify any areas that may be considered as an area of risk in relation to modern slavery.

Melbourne Racing Club has a predominantly Australianbased supply chain made up of approximately 1200 direct suppliers, with payments being made by Melbourne Racing Club to 967 suppliers in FY21. Over 98% of these suppliers are concentrated in Australia.

Melbourne Racing Club has identified that some areas of its supply chain, that are direct contracted suppliers to Melbourne Racing Club, may be at risk of modern slavery practices due to the nature of the goods and services to be purchased. These include security services, cleaning services, purchase of electrical and technology (hardware, software and cloud services), and merchandise and clothing. We have identified 50 suppliers within these sectors in FY21.

The effects of Covid-19 during the reporting period substantially impacted the Melbourne Racing Club's ability to assess the full nature, context and extent of these risk areas. The Melbourne Racing Club aims to improve our processes and systems to identify and respond to modern slavery risks each year.

Our Actions, Addressing the Risk

Our approach to Modern Slavery is guided by the following:

- Governance: which includes internal policies, standards, contract terms and the Modern Slavery Working Group
- Empowerment: which includes staff training and raising awareness
- Collaboration and remediation: which includes our suppliers
- Due diligence planning: plans to conduct detailed due diligence on major suppliers, including supplier scorecards and audits

Actions Taken in 2021

The following paragraphs set out the actions that the Melbourne Racing Club has taken in 2021 to assess the risk of modern slavery practices in its supply chain. The key focus for the year has been on increasing awareness across our business.

Understanding the Risk

A bespoke interactive training programme on the risks of modern slavery was commissioned and rolled out to staff with over 80% of all permanent head office and senior staff completing the training.

This training module has been added to the onboarding process of all new permanent staff.

A paper was presented to the Committee and Executive of the Melbourne Racing Club explaining the requirements of the Act and setting out the MRC's internal requirements in regard to the risks present and actions to be taken on modern slavery moving forward.

Continued attendance at key training and seminars by the procurement department to understand requirements of the Act.

A modern slavery working group was established in 2020 to ensure obligations are met and to discuss addressing modern slavery risks generally.

Process and Policies

Maintenance and review of processes put in place prior to the reporting year, including updating the Melbourne Racing Club's internal Purchasing Policy to:

- Ensure procurement has oversight of key suppliers; and
- Include reference to the Act and modern slavery risks generally, directing staff to consider the issue and engage with procurement to discuss any potential modern slavery risk with a selected supplier.
- Monitoring the supplier request process where questions must be answered about the potential risk of modern slavery with that proposed supplier prior to engagement. for review by procurement.

Contracts

Continuing to ensure all new formal contracts entered into between the Melbourne Racing Club and suppliers with a risk of modern slavery within its supply chain includes obligations in relation to reducing modern slavery in its supply chain and compliance with the Act (where applicable).

Labour

Compliance with the requirements of the Labour Hire Licensing Act 2018 (Vic), by putting processes in place to ensure all current and new suppliers of the Melbourne Racing Club's labour hire providers are adequately licensed.

Future Actions

Planning for post-2021 actions to ensure continued identification and management of risks of modern slavery within its supply chain and operations. Plans include:

- Enhancing specific and structured supplier due diligence
- Enhancing engagement with suppliers on modern slavery risks
- Engaging within our industry for best practice

Assessing the Effectiveness of Our Actions

To ensure the Melbourne Racing Club is both complying with the Act and addressing potential modern slavery issues within its supply chain, an internal working group, which includes senior executives, was established in 2020.

This group also ensures that progress on addressing modern slavery is continually evolving and does not stagnate.

The working group considers that the awareness of modern slavery issues across the Melbourne Racing Club staff has greatly improved in the first two reporting periods under the Act. The internal and external training of staff, and development of internal processes have allowed Melbourne Racing Club to identify and understand potential risks of modern slavery across its key supply chains.

The Melbourne Racing Club's progress in both assessing the full nature, context or extent of modern slavery risks in its supply chains, and implementing actual changes in respect of those risks continue to be significantly interrupted by Covid-19, delaying a number of intended measures and actions.

However, the Melbourne Racing Club considers it has made good progress, but there is always more work to do. Moving forward, it intends to establish in a more measurable sense how we will assess effectiveness of our action to date.

Ultimately, the Melbourne Racing Club recognises that modern slavery risks and practices are not static, and it is committed to continuing to manage and assess its effectiveness on an ongoing basis.

This statement was approved by the Committee, being the principal governing body of the Victoria Amateur Turf Club (incorporating the Melbourne Racing Club), being the reporting entity, on 25 November 2021.
