



## Modern Slavery and Human Trafficking Statement for Financial Year Ending 31 December 2024

This Statement is given pursuant to the Modern Slavery Act 2018 (Cth) by Sealed Air Australia Holdings Pty Ltd (ACN 102 261 307) with its registered office at 1126 Sydney Road, Fawkner, Victoria.

### 1. Identify the reporting entity

Sealed Air Australia Holdings Pty Ltd (ACN 102 261 307) is an Australian company with the following controlled entities (together referred to below as “**Sealed Air Australia**”):

- (1) Sealed Air Holdings (New Zealand) Pty Ltd (ACN 602 021 036), which in turn controls the following entity:
  - a. Sealed Air (New Zealand) (11133), a New Zealand entity; and
- (2) Sealed Air Australia Pty Ltd (ACN 004 207 532), which in turn controls the following entities:
  - b. Sealed Air Pty Ltd (ACN 162 250 740); and
  - c. Entapack Pty Ltd (ACN 006 471 209).

Sealed Air Australia is 100% owned by the ultimate shareholder Sealed Air Corporation.

### 2. Describe the structure, operations and supply chains of the reporting entity

Sealed Air Corporation (NYSE: SEE), is a leading global provider of packaging solutions that integrate sustainable, high-performance materials, automation, equipment and services. Sealed Air designs, manufactures and delivers packaging solutions that preserve food, protect goods and automate packaging processes. We deliver our packaging solutions to an array of end markets including fresh proteins, foods, fluids and liquids, medical and life science, e-commerce retail, logistics and omnichannel fulfillment operations, and industrials.

Our globally recognized solution brands include CRYOVAC® brand food packaging, LIQUIBOX® brand liquids systems, SEALED AIR® brand protective packaging, AUTOBAG® brand automated packaging systems, and BUBBLE WRAP® brand packaging. In 2024, Sealed Air generated \$5.4 billion in sales and has approximately 16,400 employees who serve customers in 117 countries/territories.

Sealed Air serves a range of markets with packaging systems and solutions that protect goods, extend shelf life, reduce waste, and improve efficiency. Its key focus areas include food packaging for fresh proteins, dairy, and ready meals; protective packaging for e-commerce, electronics, industrial, and consumer goods; and healthcare packaging for medical and pharmaceutical products. Our supply chain includes the sourcing of raw materials, packaging components, contract manufactured goods, equipment, and other direct materials, such as inks, films and paper principally related to the provision and manufacturing of goods. Our principal raw materials are polyolefin and other petrochemical-based resins, as well as chemicals such as caustic soda, solvents, waxes, phosphates, surfactants, chelates, paper and wood pulp products.

Sealed Air Australia’s supply chain consists of over 1,600 suppliers, which include suppliers from Australia, New Zealand, Asia, North America, the Middle East and Europe/UK. For indirect purchases the main spend categories are freight, energy, real estate leases, insurances, Governmental bodies and MRO for operational sites. Direct purchases comprise of polymers and paper used in production of finished goods, as well as various sub-categories of materials converted in our manufacturing process or used to package the finished goods. Examples of these materials are films, adhesives, inks, various paper products, tapes, starch, foils, cartons and pellets.

### 3. Describe the risks of modern slavery practices in the operations and supply chains of the reporting entity and any entities it owns or controls

During the reporting period we continued to assess our suppliers for the risks of modern slavery in our operations and the supply chain to consider the risk that we are causing, contributing, or directly linked to modern slavery practices. We acknowledge that the risks of modern slavery may be heightened in some of our supplier groups or supply chains and use a number of factors to assess the potential risk including geographical location of some suppliers, our areas of operation, and the source of materials used in products supplied to us. Following this assessment, areas of vulnerability in our operations were found to include outsourced services such as cleaning, security, outsourced manufacturing and the use of labour hire contractors. Sealed Air Australia is continuing to use the Ethixbase third party software as part of its risk assessment methodology to assess third party suppliers. We also perform vendor screening via a global ethics and compliance platform Navex which includes screening for adverse media that has been published about the supplier related to modern slavery. Sealed Air Australia is also a member of Sedex, one of the world’s leading online platforms for companies to manage and improve working conditions in global supply chains.



Sealed Air Australia's modern slavery risk assessment criteria of supplier responses include the following elements:

1. Nature of the supply relationship;
2. Respect of labour and human rights;
3. Social accountability; and
4. Business integrity (bribery, conflicts of interest, gifts and entertainment, codes of conduct, freedom of association, training and policies and procedures).

Each Sealed Air Australia supplier risk is/will be assessed based on their responses, geographical location and the type of industry. Suppliers were categorised as:

- Low Risk – Little or no risk of breaches of modern slavery legislation or the Sealed Air Australia Supplier Code of Conduct. No immediate action required.
- Medium Risk – Responses require further investigation and a potential SMETA audit.
- High Risk – Risk is deemed unacceptable and the supplier should be suspended until investigations completed and results are considered satisfactory.

**4. Describe the actions taken by the reporting entity and any entities it owns or controls to assess and address these risks, including due diligence and remediation processes**

We have in place a number of internal policies to ensure that we are conducting business in an ethical and transparent manner. These include:

- *Global Anti-Slavery and Human Trafficking Policy*. This policy sets forth our stance on modern slavery and how employees can identify any instances of these practices and where they can report potential non-compliance.
- *Sealed Air global Code of Conduct*. This provides the foundational standards of conduct for all aspects of our business and is applicable to all our employees and operations globally. It includes provisions related to, among other things, ethical standards, compliance with laws, safe working conditions, and whistleblowing which encourages employees to raise concerns about issues they are observing or experiencing in the workplace or within our business functions without fear of reprisal. Our Code of Conduct applies to not only employees, but any entity that does business with or on Sealed Air's behalf.
- *Sealed Air Australia Supplier Code of Conduct*. This code explains our commitment to ethical workplace practices and sets forth the ethical and legal standards we expect suppliers will adhere to. Suppliers are required to demonstrate that they provide safe working conditions, treat workers with dignity and respect, and act in accordance with all laws and international and organizational standards governing slavery or forced labour (e.g. International Labour Organization). Additionally, supplier violations of this code may lead to the termination of the business relationship.

We are not aware of any modern slavery-related breaches of the above policy/codes during the reporting period. Sealed Air Australia has so far requested above 85 percent of its tier 1 suppliers with annual spend with Sealed Air Australia of USD100,000 or more to comply with the following requirements ("**Sealed Air Australia Modern Slavery Requirements**"):

- complete Sealed Air Australia's modern slavery risk questionnaire; and
- agree to Sealed Air's Global Anti-Slavery and Human Trafficking Policy, the Sealed Air Australia Supplier Code of Conduct and other Sealed Air Australia requirements to mitigate modern slavery risks in its (and the supplier's sub-contractor's) supply chain.

We may also conduct a search of our suppliers using the NAVEX software tool as an additional screening step. We are also utilising Ethixbase's other verification tools to further analyze supplier risk.

All new suppliers (excluding a small number of sole traders and any government entities) in the reporting period have been sent the Sealed Air Australia Modern Slavery Requirements to complete.

In 2024, our supplier risk assessments (and follow up queries with suppliers) resulted in all suppliers that we assessed having been confirmed to be a "Low Risk". Given the outcomes of our risk assessment during the reporting period, no further investigations were required to address the risks of modern slavery in our operations and supply chain. We continue to follow up on and assess the questionnaire responses being received from our suppliers.

Our company has a robust global compliance training program in place comprised of mandatory training for employees related to code of conduct and ethical business practices using our E-Learning tool. Further, we have rolled out training for relevant Sealed Air employees to help them identify and report (potential) modern slavery or human trafficking risks and provided staff with a list of actions to be taken if a (potential) case of modern slavery is identified. We have an Integrity Committee that communicates regularly with our global employees to provide guidance and updates on key related topics, serving to remind employees to uphold our Code of Conduct and making compliance and acting with integrity a priority.



## 5. Describe how the reporting entity assesses the effectiveness of these actions

Sealed Air Australia has put in place an assessment methodology to measure the effectiveness of our actions to mitigate modern slavery risks. These include the following:

- SMETA 4 pillars audits of some key suppliers by an independent third party.
- Providing the suppliers referred to in paragraph 4 above with our codes of conduct and Global Anti-Slavery and Human Trafficking Policy and requiring the supplier to accept these.
- Use of a standardised questionnaire across a large majority of our major suppliers which is used to assess the risk in the supply chain including but not limited to:
  - Country of origin,
  - Industry sector e.g. clothing, electronics, security and transport are all considered elevated risk factors,
  - Use of migrant labour,
  - Use of under age employees e.g. apprentices,
  - Where our suppliers source their materials from, and
  - Embedded procedures and systems.
- Track supplier compliance with the Sealed Air Australia Modern Slavery Requirements, including:
  - Assessing supplier responses. Responses are then reviewed on a risk basis and high and moderate risks are investigated with the supplier to:
    - Understand the causes of the elevated risk, and
    - Take steps to reduce this risk.

Significant suppliers and those assessed as high risk are required to undertake a SMETA 4 pillars audit which is undertaken by an independent auditor. Failure to undertake this requirement will result in Sealed Air reviewing the supplier's ability to supply Sealed Air.

## 6. Describe the process of consultation with any entities the reporting entity owns or controls

We consulted the relevant companies we own or control in the development of this statement.

## 7. Provide any other relevant information.


Sealed Air Australia's Terms and Conditions of Purchase expressly oblige its suppliers to comply with all applicable laws including laws aimed at combatting modern slavery practices.

Sealed Air's ethics hotline (known as the Integrity Line) is operated by an independent, third-party reporting service. The Integrity Line is available anytime, via phone or web, for anyone (including non-employees) to seek guidance or report allegations of violations of our Code, our policies, or the law. For employees, the Integrity Line is designed to supplement existing reporting channels—not replace them. In addition, Sealed Air Australia has a Whistleblower Policy. This mechanism gives victims of modern slavery the ability to contact Sealed Air about any concerns.

We are also requiring all new suppliers (excluding Government entities and sole traders) to comply with the Sealed Air Australia Modern Slavery Requirements to mitigate modern slavery risks. Further, our suppliers are required to acknowledge our Code of Conduct as they get onboarded into our ERP system.
