Modern slavery takes many forms. The Modern Slavery Act 2018 (Cth) defines eight serious forms of exploitation: trafficking in persons, slavery, servitude, forced marriage, forced labour, debt bondage, the worst forms of child labour, and deceptive recruiting for labour or services.

We acknowledge that modern slavery can occur in every industry and sector and strive to improve the ethical standards both within our business and in our supply chains by working in partnership with our suppliers to minimise the risk of modern slavery.

Our commitment to identifying and addressing the risks of modern slavery in our operations and supply chains is ongoing, and in the future, we will continue to strengthen our approach to assessing and addressing the risk of modern slavery.

About us

Reporting entity

This Modern Slavery Statement ("**Statement**"), covers the activities of CRRC Changchun Australia Rail Pty Limited ACN 615 414 072 ("we", "our" and "CRRC Australia") in accordance with the Modern Slavery Act 2018 (Cth) (the "**Act**") during the reporting period of 1 January 2022 to 31 December 2022 ("**Reporting Period**").

Our structure

CRRC Australia is a company incorporated in Australia and headquartered in Melbourne.

CRRC Australia is a wholly owned subsidiary of CRRC Changchun Railway Vehicles Co., Ltd ("**CRRC Changchun**"), headquartered in Changchun, Jilin Province, China. CRRC Changchun is one of the biggest subsidiaries of CRRC Corporation Limited, and its activities extend to the entire life-cycle services of rail transit passenger transport equipment, including R&D and testing, new construction, operation, overhaul and maintenance.

CRRC Australia does not have any owned or controlled entities.

About us

Our operations

CRRC Australia is committed to supporting the design, manufacturing and maintenance of rolling stock in Australia. Our core operations include the involvement in Victoria's High Capacity Metro Train ("**HCMT**") project to build bigger and better trains to support the needs of Melbourne's rapidly growing population.

We are proud to be part of the HCMT project which aims to design, build and maintain 70 new high capacity trains for the metropolitan network over the next 35 years.

We are involved in the HCMT project as a subcontractor to the joint venture between Downer EDI Rail Pty Ltd and CRRC Changchun Railway Vehicles Co. Ltd (together "the HCMT Supplier"), who are contracted to Evolution Rail and the Victoria State Government

CRRC Australia is responsible for the core part of the HCMT project, including:

- the design, manufacture, testing & commissioning and delivery of the 70 HCMTs; and
- the design and manufacture of two simulators for drivers' training.

We have approximately 100 employees based in Melbourne.

About us

Our supply chains

We are committed to supporting local jobs and industry growth. CRRC Australia works closely with local suppliers and partners to build local capability.

During the current reporting period, CRRC Australia has engaged a number of directly-contracted suppliers, who manufacture and supply the parts and materials for the HCMT project. Among those suppliers, approximately 80% of them are based in Australia and the rest of the suppliers are either based in China or the European Union. We are committed to sourcing components of the HCMTs to the extent possible from within Australia and Victoria.

The HCMTs are assembled locally at the Newport manufacturing facility through a subcontractor arrangement with Downer EDI Rail Pty Ltd, employing and providing training to local labours.

CRRC Australia also engaged the services of professional consultants locally, including auditors and technical advisors.

Risk of modern slavery practices in our operations and supply chains

Risk assessment

Following our first Modern Slavery Statement and throughout the current reporting period, we have introduced processes to help identify and assess the risks of modern slavery in our operations and supply chains. We have considered a number of risks, including those risks that may:

- see our operations directly cause modern slavery practices;
- contribute to modern slavery practices from our operations and/or actions in
- supply chains; and
- may be directly linked to modern slavery practices in that our operations, products or services may be connected to modern slavery through the activities of another entity with whom we have a business relationship.

Through our processes, we considered indicators of modern slavery risks including but not limited to sector and industry, the type of products and services and geographical location.

Our risk assessment has indicated that our operations and supply chains have a low potential for modern slavery risks. However, we acknowledge that there remain potential risk factors that may expose operations and supply chains to modern slavery, which we identified below:

Risk of modern slavery practices in our operations and supply chains

Risk of modern slavery practices in our operations and supply chains

Risk profile

Risk	Description of risk
Sector / Industry	The manufacturing sector may present elevated risks of modern slavery as a result of factors such as potentially unsafe conditions, use of low-skilled labour, etc.
Product / Service	There might be potential risks or instances of modern slavery practices in supply chains, such as those associated with manufacturing components necessary to construct the HCMTs.
Geographic	Our supply chain is predominantly located in Australia which has a lower level of modern slavery risk. As noted above, approximately 20% of direct suppliers are outside of Australia, which we acknowledge may have an elevated potential risk of modern slavery. However, our overseas suppliers are regularly monitored and it is indicated that they comply with the equivalent Australian legislative requirements.
Specific Entity	We have not identified any modern slavery practices within our operations or supply chains.

Operations

In 2022, CRRC Australia is mainly engaged in the delivery of the HCMT Project. A large part of the HCMT assembly work was subcontracted to Downer EDI Rail Pty Ltd, which is an organisation based in Australia and has comprehensive ethical policies in place. All our employees are engaged through formal employment contracts in compliance with applicable employment laws and legislation. In addition, CRRC Australia has put in place codes and policies (see Policies and procedures below) to provide guidance to our employees and subcontractors about the expected appropriate business conduct and how to manage risks in relation to the occurrence of modern slavery. We consider modern slavery risks to be low within our operations.

Supply chains

CRRC Australia only engages suppliers with a good reputation, strong ethics and reliable business practices, we have implemented robust supplier selection processes. Through this year's desktop assessment and modern slavery questionnaires processes with our suppliers, we have not identified any involvement of our suppliers in modern slavery or human rights issues. Nevertheless, we are conscious that there could still be risks of modern slavery practices further down in our supply chains, particularly for materials and components that are procured from overseas countries that may not have a comparable modern slavery legislative regime as in Australia.

Actions

During the current reporting period, CRRC Australia has taken the following actions to strengthen our current processes to identify and deal with the possibility of modern slavery practices within our operations and supply chains.

Due diligence

Our teams undertook regular risk assessments to identify key modern slavery risks that may exist within our operations and supply chains, which include desktop assessments and visits to our suppliers' manufacturing facilities on a regular basis.

Governance and accountability

Modern slavery compliance is embedded into the responsibilities of each manager who is required to report on modern slavery compliance to the CRRC Australia general manager and the legal department.

Actions

Policies and procedures

CRRC Australia has a number of policies and procedures which are designed to ensure we have strong frameworks to enable us to assess and address modern slavery risks, including:

- **CRRC Code of Business Conduct:** applies to all business activities of CRRC Australia and seeks to ensure legal compliance and protect human rights, religion and race, as well as providing an avenue for internal complaints and suggestions, and which forbids Modern Slavery.
- **Employee handbook:** all employees of CRRC Australia have signed a confirmation letter of the employee handbook, confirming their understanding of their rights and responsibilities as employees including relevant laws, regulations and the code of business conduct. This handbook includes strong protections for equal employment, discrimination, workplace health and safety and harassment. The policy also reinforces our commitment to an ethical workplace and provides employees with an avenue to make complaints.
- **Workplace safety code in employee manual:** defines how we make our work environment both a physically and mentally safe place.
- **Code of ethics:** defines how CRRC Australia deals with all forms of discrimination and harassment. It also defines the reporting system and investigation procedure when discrimination or harassment is identified.

These policies operate alongside other procedures which seek to address modern slavery including:

Actions

- **Supplier questionnaire:** supplier questionnaire was issued to our key direct suppliers in 2022. The supplier questionnaire seeks to survey the specific modern slavery questions to identify the information including self-assessment of supplier's modern slavery obligation, how the supplier conducts due diligence for modern slavery risk and how this is reported internally, whether there have been any reports or concerns in relation to modern slavery in their business or supply chains, whether the organisation or its agents/subcontractors have been investigated or charged with breaches of legislation relating to modern slavery and other key questions related to modern slavery risks and management.

The responses to this questionnaire assisted us to ensure compliance and identify any potential issues and escalate them to senior management. CRRC Australia is continuing the process of reviewing and improving our supplier questionnaire with the aim to identify any modern slavery practices within our supply chains.

Actions

We also review and check the compliance of suppliers. This includes requiring suppliers to self-assess and confirm their compliance with applicable laws, no violation of workplace ethics and human rights such as no use of child labour, forced or involuntary labour in their operations and supply chains.

CRRC Australia is aware of the previous allegation against one of our suppliers, KTK Group, who was named in a report to have allegedly engaged Uyghur workers. In response to that allegation, CRRC Australia had carried out extensive inquiries of KTK Group. We have not found any evidence that supports the allegations in the report. In addition, we have received written assurances and evidence from KTK Group that it has not and will not engage Uyghur workers or other forced labour practices in its operations and supply chains.

Training

Awareness of the Act and potential risks are communicated to employees of CRRC Australia. Targeted training is also provided to staff who interface with the supply chains, especially the commercial, procurement, and human resources staff etc.

Remediation processes

CRRC Australia is committed to investigating any notification or reports that come to our attention regarding potential incidences of modern slavery occurring in our operations or supply chains. Further, we confirm that we would take all appropriate and necessary steps to rectify any confirmed modern slavery cases should they occur in our operations or supply chains.

Effectiveness of our actions

CRRC Australia is committed to reviewing its internal policy and improving our existing actions within our next reporting period to ensure the effective mitigation of modern slavery risks.

Specific measures that we have in place to measure the effectiveness of our actions include:

- senior management meeting annually to consider whether we are appropriately identifying and evaluating our modern slavery risks; and
- undertaking a robust review and assessment of our existing processes, particularly when there are material changes to existing supplier arrangements, or during the introduction of new operations or a new supplier.

We will also pay close attention to indicators including:

- supplier questionnaire and their responses; and
- any suspected or identified modern slavery incidents.


Consultation
