Structure, Operations and Supply Chain.

Business Overview

Columbit is a knowledgeable and trustworthy supplier of quality food ingredients and packaging as well as an authorised agent for premium international food and packaging equipment suppliers.

Columbit in Australia has two main business divisions.

- Foods division: Supplies a broad range of quality food ingredients, packaging, and consumable items such including casings, tins and clips. All stock is sourced from long established reputable suppliers predominately from Europe, India, South Africa, China and Japan. Columbit's focus is to support its customers to produce consistent product by providing quality, reliable ingredients available with timely delivery.
- Food Equipment division: Supplies specialised premium food processing and packaging equipment, all manufactured overseas (predominately Europe and USA). Complete with a team of highly trained technicians available nationally to service this equipment. Columbit's focus is to support its customers to maximise their investment.

Columbit activities within Australia are achieved by Columbit employees or authorised incorporated companies in Australia.

Our overseas suppliers are restricted to a small number of well-established and reputable high-quality companies.



Risk Identification.

Analysis

Columbit's executives have reviewed the total supply chain from raw material to final delivery at our customers premises with the following conclusions:

- 1. There is virtually a zero risk of modern slavery for all Australian related activities as only reputable incorporated Australian companies are involved.
- 2. Ingredient and equipment overseas suppliers from Europe, Japan and USA are considered as extremely low risk due to their labour laws and companies' positive reputation.
- 3. Ingredients overseas suppliers from South Africa, China and India are considered low due to companies' positive reputation.

Action Plan.

Policies and Procedures

Policies and procedures are developed and implemented that support the zero tolerance to modern slavery:

- Develop a modern slavery audit for all existing or future overseas suppliers.
- Train senior managers alerting them to modern slavery traits.
- Review suppliers' communications to identify potential red flags to modern slavery.
