MODERN SLAVERY STATEMENT 2020

Introduction & Reporting Entity

- 1. E&A Limited (ACN 088 588 425) (EAL) is an Australian unlisted public company registered at 75 Verde Drive Jandakot WA 6164.
- This statement has been developed in accordance with the *Modern Slavery Act 2018* (Cth) (Modern Slavery Act), and sets out the actions taken by EAL and its wholly owned and controlled entities (referred to collectively in this statement as the EAL Group) to identify, assess and address modern slavery risks in its operations and relates to the financial year ending 30 June 2020.
- 3. The EAL Group is committed to managing the issue of modern slavery and working with its stakeholders to bring it to an end. In order to achieve that purpose, the key activities undertaken by the EAL Group in the financial year ending 30 June 2020 included a review of existing policies and procedures and development of a modern slavery framework. Ultimately the EAL Group adopted a uniform Modern Slavery Policy in July 2020 to ensure that it adequately assesses and addresses modern slavery risks in its business and its supply chains. To date, the EAL Group has not identified any instances of modern slavery in its operations or supply chains.
- 4. The corporate structure of the EAL Group is set out in **Schedule 1**. EAL is the reporting entity required to issue this statement under the Modern Slavery Act.

Structure, operations and supply chains of the EAL Group

- 5. EAL is a diversified investment company which owns and operates 12 operating entities. The EAL Group operating entities in the main provide services to essential industries and assets including, resource, energy, renewable energy, utility & infrastructure, water & wastewater and industrial maintenance sectors.
- 6. The structure, operations and supply chains of the EAL Group are more particularly described in **Schedule 2**.

Risks of modern slavery practices in the operations and supply chains of the EAL Group

- 7. In terms of operations, the EAL Group has a zero tolerance approach to any form of modern slavery within its own operations. The EAL Group considers that it is unlikely to have a risk of modern slavery in its operations as:
 - 7.1. The majority of the EAL Group's employees are employed directly under contract (permanent, fixed-term, part-time or casual) or under enterprise bargaining agreements.
 - 7.2. The EAL Group does not employ any person outside of Australia, save that one of its entities engages ad hoc services of three individuals based in the Philippines through a third party services provider located in Australia. The terms of the services agreement include an obligation that the third party must, inter alia, abide by Philippines labour laws and judgments handed down by the Philippines Department of Labour and Employment.

- 7.3. While the EAL Group utilises labour hire through third party providers and subcontractors, it has taken steps to identify and ensure that the entities with which it deals complies with relevant local labour hire licensing laws.
- 8. The greater risk of modern slavery is in the supply chains of the EAL Group, particularly in jurisdictions outside of Australia. To minimise that risk, the EAL Group is committed to working with subcontractors and suppliers to ensure their practices are aligned with the EAL Group's expectations concerning modern slavery. The EAL Group has a clear expectation that all of its subcontractors and suppliers operate in accordance with modern slavery laws and are socially responsible.

Mitigating risks of modern slavery

- 9. As part of the Modern Slavery Policy, each entity within the EAL Group is required to:
 - 9.1. adopt procedures to ensure that it is addressing modern slavery and ethical sourcing risks in its operations and supply chains in a way that is appropriate for its business;
 - 9.2. make enquiries with its subcontractors and suppliers to identify any modern slavery risks;
 - 9.3. insofar as far as practicable, include in its operational and supplier contract terms:
 - 9.3.1. a requirement that suppliers comply with all local, national and other applicable laws and regulations in the areas in which they operate;
 - 9.3.2. a requirement that the supplier comply with certain minimum standards; and
 - 9.3.3. a right of termination if the supplier is unable or unwilling to work towards full compliance with certain minimum standards.

Measuring effectiveness of mitigation steps

- 10. The focus of the EAL Group has been to put in place an appropriate modern slavery framework and adopt associated processes and procedures that help achieve its objectives. For that reason, the EAL Group has not yet implemented a uniform approach for measuring the effectiveness of its actions to mitigate risks of modern slavery.
- 11. However, it intends to develop an appropriate reporting and review process over the next 12 months to better measure the steps that it has taken to address modern slavery risks, as well as identify other steps that might be taken.

Consultation

- 12. The aims of the Modern Slavery Policy include providing clear guidance for the reporting and investigation of any suspected modern slavery within the EAL Group's business, and developing procedures to address modern slavery.
- 13. The Modern Slavery Policy applies to all entities, employees and representatives of, and within, the EAL Group. It is also expected that any supplier or subcontractor to the EAL Group apply similar standards when working with us.
- 14. As the reporting entity, EAL (parent company) consulted with each of its operating subsidiaries.


